COMPLAINT

AND NOW, comes the Plaintiff, Robert W. Powell and says as follows:

1. Plaintiff is Robert W. Powell who resides at 424 South Church Street, DuBois, Pennsylvania 15801.

2. The Defendant is Thomas Darby Thompson who resides at 993 Worth Street, Reynoldsville, Pennsylvania 15851.

3. In or about August, 1999, Plaintiff and Defendant entered into a contract in which Defendant agreed to build a computer system for Plaintiff for the sum of \$1,779.00.

4. Plaintiff has tendered to the Defendant \$1,779.00 pursuant to the terms of the contract.

5. The computer system which Defendant supplied to Plaintiff is defective for one or more of the following reasons:

a. Defendant did not provide Plaintiff with software to DVD player;

b. Defendant was to speed Plaintiff's processor to 550 megahertz which Defendant failed to do;

c. Defendant failed to install a second fan on Plaintiff's computer system;

d. Defendant supplied casing which was defective;

e. Defendant was to supply original copyrighted Microsoft Corporation software which he failed to do;

f. Defendant failed to supply cable from the computer's DVD player to Plaintiff's television; and

g. Such other items as may be set forth at trial.


6. The actions of the Defendant constitute breach of contract. As a result of the Defendant's breach of contract.

7. As a result of Defendant's breach, Plaintiff has suffered damages.

8. Plaintiff filed a Complaint before the District Magistrate (46-3-01) and received a verdict in Plaintiff's favor in which he incurred court costs in the amount of \$56.00.

WHEREFORE, Plaintiff demands judgment against Defendant, Thomas Darby Thompson in an amount less than \$20,000.00 together with cost of suit and such other and further relief as the Court deems fair, just and equitable.
