When the defendant is placed under arrest for violation of this order, the defendant shall be taken to the appropriate authority or authorities before whom defendant is to be arraigned. A "Complaint for Indirect Criminal Contempt" shall then be completed and signed by the police officer OR the plaintiff. Plaintiff's presence and signature are not required to file the complaint.

If sufficient grounds for violation of this order are alleged, the defendant

Except as provided in Paragraph 5 of this Order, Defendant is prohibited from having **ANY CONTACT** with the Plaintiff, or any other person protected under this Order, at any location, including but not limited to any contact at Plaintiff's school, business, or place of employment. Defendant is specifically ordered to stay away from the following locations for the duration of this order.

4. Except as provided in Paragraph 5 of this Order, Defendant shall not contact the Plaintiff, or any other person protected under this Order, by telephone or by any other means, including through third persons.

5. Custody of the following minor children:

1. **Cierra Marie Teats**

shall be as follows:

- **Primary physical custody of the minor child/ren is awarded to the Plaintiff.**
- **Defendant shall have the following partial physical custody/visitation rights: A minimum of two times per week for a minimum period of two hours as arranged by Centre County Children and Youth Services and/or FICS workers.**

6. The following additional relief is granted as authorized by §6108 of the Act:

- **The parents shall not have contact other than for emergency purposes regarding the health, education and welfare of the child.**
- **Father shall have such other periods of partial physical custody with the child as is mutually agreeable between the parties and/or as arranged by Centre County Children and Youth Services and/or FICS.**

7. The costs of this action are waived as to the Plaintiff and imposed on Defendant, as follows:

For the past 5 years, this child has lived with:

Since September 7, 1999 minor child lived with both biological parents at 214 Tenth ST., Apt. 1 Philipsburg PA until December 3, 1999. From December 3, 1999 until approximately December 18, 1999 minor child was in the care of Centre County Children and Youth Services. From December 18, 1999 until January 18, 2000 minor child lived with both biological parents at 214 Tenth St., Apt. 1, Philipsburg PA. From January 18, 2000 until the present minor child has lived with the Plaintiff, biological mother, at 214 Tenth Street, Apt. 1 Philipsburg PA.

17. The facts of the most recent incident of abuse are as follows:

On about **Tuesday, April 25, 2000** at approximately **5:00AM**

location: **Plaintiff's residence**

Mike started calling me at about 5 AM and kept calling until around 8:30 AM. When he calls I tell him to stop calling me, and he says he'll call me as much as he wants. If I hang up on him he calls back and tells me not to hang up on him or he'll "slap you in the mouth". He called me around 10 to 20 times today alone. He once called me 55 times in one day.

Each time he called me today he called me names, and when I tell him to stop calling he says he'll call me as often as he wants.

I'm worried about my daughter's safety because of Mike's behavior. He was always mean to my son, and has hit him in the past, and CYS and the FICS program have said that Mike can't be in the house if my son is there. When I pack bottles and diapers for Cierra to visit Mike, when I get her back none of the bottles have been used, and her diaper has not been changed. She is always in a big daze when she comes back.

18. Prior incidents of abuse that the Defendant has committed against Plaintiff or the minor child/ren, (including any threats, injuries, or incidents of stalking) are as follows:

On January 18, 2000 I asked someone from FICS to come get me, and Mike started throwing me around. He ripped Cierra off of her apnea monitor, and he ripped the phone right out of the wall. He broke the answering machine and tore the bulletin board off the wall. The police came and told him he had to leave.

Both FICS and CYS have advised me to file a PFA.

He has said he will make sure my car doesn't run, (either he'll do it or he'll have someone else sabotage it) and has other people follow me around.

19. The police department(s) or law enforcement agencies that should be provided with a copy of the protection order are:

PSP Philipsburg and Milesburg

20. There is an immediate and present danger of further abuse from the Defendant.

23. **FOR THE REASONS SET FORTH ABOVE, I REQUEST THAT THE COURT ENTER A TEMPORARY ORDER, and AFTER HEARING, A FINAL ORDER THAT WOULD DO THE FOLLOWING:**

- a. Restrain Defendant from abusing, threatening, harassing, or stalking Plaintiff and/or minor child/ren in any place where Plaintiff may be found.
- b. Evict/exclude Defendant from Plaintiff's residence and prohibit Defendant from attempting to enter any temporary or permanent residence of the Plaintiff.
- c. Award Plaintiff temporary custody of the minor child/ren and place the following restrictions on contact between Defendant and child/ren:
no contact pending final hearing.
- d. Prohibit Defendant from having any contact with Plaintiff and/or minor child/ren, either in person, by telephone, or in writing, personally or through third persons, including but not limited to any contact at Plaintiff's school, business, or place of employment, except as the court may find necessary with respect to partial custody and/or visitation with the minor child/ren.
- e. Prohibit Defendant from having any contact with Plaintiff's relatives and Plaintiff's children listed in this petition, except as the court may find necessary with respect to partial custody and/or visitation with the minor child/ren.
- f. Order Defendant to pay temporary support to Plaintiff and/or the minor child/ren, including medical support .
- g. Order Defendant to pay the costs of this action, including filing and service fees.

- h. Grant such other relief as the court deems appropriate.
- i. Order the police or other law enforcement agency to serve the Defendant with a copy of this Petition, any Order issued, and the Order for Hearing. The petitioner will inform the designated authority of any addresses, other than the Defendant's residence, where Defendant can be served.


