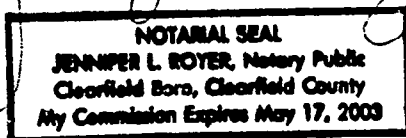



11. That the natural father has failed to show any interest in the children and has caused the children to be without essential parental care, contact or subsistence for 16 years.


12. That the Petitioner, Donald L. Boal (step-father) and the children have resided in Curwensville, Clearfield County, since July 1996.
