

NOW COMES, Petitioners, ROBERT B. HORTON and EMILY ADDLEMAN  
HORTON, his wife, who are the mother and step-father and sole

respectfully represent as follows:

1. That your Petitioners presently reside at 58 Clark  
Street, Clearfield, Pennsylvania 16830.

2. That the minor child, whose name your Petitioners are  
requesting be changed, is Tyler Scott Addleman, age 7 (D.O.B.  
8/11/92).

3. The aforementioned minor was born out of wedlock,  
being the natural child of Emily J. Addleman, now known as Emily  
Addleman Horton and Denver D. Howe.

4. Since birth, Tyler Scott Addleman has been in the sole  
physical custody of Petitioner, Emily Addleman Horton, formerly  
known as Emily J. Addleman, and for the last five years said  
minor has resided at the following locations with the following  
named people:

- (a) From on or about October 1, 1994 to on or about  
October, 1995 at 312 Moose Street, Clearfield,  
Pennsylvania 16830 solely with Co-Petitioner Emily

- (c) From on or about 10/1/98 to present with Emily J. Addleman, now known as Emily Addleman Horton and Robert B. Horton, husband and wife, at 58 Clark Street, Clearfield, Pennsylvania 16830.

5. By virtue of a Custody Stipulation agreed to by Emily Addleman Horton, then known as Emily J. Addleman, and Denver D. Howe in the custody action filed in the Court of Common Pleas of Clearfield County, Pennsylvania to No. 95-609-CD, Co-Petitioner, Emily J. Addleman, now known as Emily Addleman Horton, was to have sole legal and primary physical custody of said minor, while Denver D. Howe was to have such periods of visitation with said minor as could be mutually agreed upon with the mother. A copy of said Stipulation and this Court's Order of May 5, 1995 approving the Stipulation is attached hereto and made a part hereof as Exhibit "A".

6. Over the past four years, Denver D. Howe has not exercised any of his visitation rights with the aforementioned minor child.

7. Your Petitioners, Emily Addleman Horton and Robert B. Horton, were married on May 6, 2000 and have since that date resided in the marital home, the address of which was previously herein identified, with their son/stepson.

8. The minor child's biological father, Denver D. Howe, joins in this Petition to change said minor's last name from

"Addleman" to "Horton". An original Joinder executed by the biological father is attached hereto and made a part hereof as Exhibit "B".

9. That your Petitioners and said minor child desire that said minor child's last name be judicially changed from "Addleman" to his stepfather's last name of "Horton".

10. Changing said minor's last name as aforesaid is in the minor's best interest since it will remove any stigma or awkwardness of him having a different surname than that of his mother, stepfather and brother.

11. That there are no judgments or decrees of like character of record against minor, Tyler Scott Addleman.

12. The minor, Tyler Scott Addleman, has never been convicted of a felony or any comparable juvenile offense in the Commonwealth of Pennsylvania or in any other jurisdiction.

WHEREFORE, your Petitioners request that this Honorable Court enter a decree changing the minor's name from Tyler Scott Addleman to Tyler Scott Horton.

STIPULATION

EMILY J. ADDLEMAN, Plaintiff above named, having filed a Complaint for Temporary and Primary Custody to the above term and number, and

DENVER D. HOWE, Defendant above named, having reached an agreement with Plaintiff as to the custody of the parties' minor child, namely: TYLER SCOTT ADDLEMAN (d.o.b. 8/11/92) the parties hereby stipulate and agree as follows:

1. Plaintiff, EMILY J. ADDLEMAN, shall have primary physical custody of TYLER SCOTT ADDLEMAN, (d.o.b. 8-11-92)
2. Plaintiff, EMILY J. ADDLEMAN, shall have sole legal custody of TYLER SCOTT ADDLEMAN (d.o.b. 8-11-92).
3. Defendant, DENVER D. HOWE, shall have such periods of visitation of TYLER SCOTT ADDLEMAN as can be mutually agreed upon with Plaintiff. Said visitation shall be under the supervision of Plaintiff. Said periods of visitation shall be limited to daytime visits (before 7:00 p.m.) only until the child reaches six (6) years of age and shall take place at either: (i) the

present residence of Plaintiff; or (ii) at such other locations as first approved by Plaintiff, but under no circumstances shall Defendant remove the minor child from Clearfield County, Pennsylvania.

4. Whenever Defendant wishes to exercise his visitation rights with his son, he will give Plaintiff at least twenty-four (24) hours' notice either in writing or by telephone. So long as said notice provisions are followed, the permission of the Plaintiff is not to be unreasonably withheld.

5. In addition to the visitation rights herein set forth, Defendant shall be entitled to have reasonable telephone contact with the minor child while in the Plaintiff's custody, with said telephone contact to be at reasonable hours, to be agreed upon by the parties.

6. Plaintiff and Defendant also agreed that should Plaintiff, Emily J. Addleman, be unable to exercise primary physical custody of minor child, Tyler Scott Addleman, by reason of illness, accident, travel or any other legitimate reason, temporary physical and legal custody of said minor shall vest in the child's maternal grandparents, Charles R. Addleman and/or Phyllis R. Addleman, until the impediment preventing Plaintiff from exercising custody is removed or upon further order of a Court of competent jurisdiction.



7. The parties further agree that this Stipulation shall be presented to the Court to be incorporated into an Order of Court and evidence that intent by signing herein below.
