



6. The charges for Plaintiff's professional services were a fair, reasonable, and proper charge for all services at the time(s) they were provided.


7. The amount due and owing Plaintiff for dental services provided to Defendant **GARY BRUNO**, for which Defendant has not paid, is \$1,976.21
