



6. The charges for Plaintiff's professional services were a fair, reasonable, and proper charge for all services at the time(s) they were provided.


7. The amount due and owing Plaintiff for dental services provided to Defendant **GARY BRUNO**, for which Defendant has not paid, is \$1,976.21






ANSWER

5. Admitted in part and denied in part. It is admitted that Plaintiff has performed tasks required by Defendant. However, it is denied that Plaintiff has performed the requests made by Defendant in a manner consistent with the local practices in this area.

6. Denied. It is denied that Plaintiff's professional services and charges thereon were reasonable and fair in light of the circumstances surrounding the relationship between the parties.
7. Denied. It is denied that Defendant owes the amount as listed to the Plaintiff. Strict proof of the same is hereby demanded at trial.
8. Admitted.




