## COMPLAINT

3. On or about August 2, 1997 and at various times thereafter, the Defendant made an application to the Plaintiff for certain insurance coverage.

4. At the specific request and instance of Defendant, Plaintiff issued certain policies numbered B1Z36161, CP236161, WC236161.

5. Defendant received and accepted the aforementioned coverages.

6. Plaintiff avers that said policies were canceled or otherwise terminated.

7. The agreement of open account between the parties arose from words, course of dealing, and the aforementioned document(s).


8. Plaintiff avers that the balance due for unpaid insurance premiums, as those premiums were calculated by an audit, amounts to \$8,656.50.

9. Plaintiff claims legal interest, as damages, on the liquidated debt from October 15, 1998.

10. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and refused to pay the amount due Plaintiff or any part thereof.

**WHEREFORE**, Plaintiff demands Judgment against Defendant in the amount of \$8,656.50, with appropriate additional interest and costs.
