
Regarding the Harold D. (Denny) Shaw farm in Curwensville, PA, please be advised that Mr. Shaw has certain loans with National City Bank of Pennsylvania and that National City, under its lending arrangements with this borrower, and by virtue of its security agreements and UCC financing statements, has a blanket lien on all assets of the Shaw farm, as well as mortgages on the real estate.

National City's lien would extend to all assets except for titleable vehicles on which titles National City's lien does not appear.

National City loans are through the Farm Service Agency of the United States Department of Agriculture and, as such, the FSA also has interests in these obligations.

Therefore, any attempts to levy or foreclose against assets of this debtor under an execution sale or Sheriff Sale would be subject to the liens and interests of National City and the FSA which, at the date of this letter, total more than \$200,000.
