

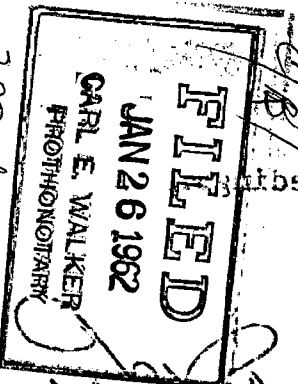

C O M P L A I N T

COMES NOW, the plaintiff, and by her attorney, Joseph J. Lee, brings this action in divorce against the above named defendant upon a cause whereof the following is a statement:

(1). The plaintiff, Mabel L. Rodkey, is sui juris and resides at Morann, Clearfield County, Pennsylvania, and has been a resident of Clearfield County all her life.

(2). The defendant, Robert E. Rodkey, is sui juris and resides at Morann, Clearfield County, Pennsylvania, and has been a resident of Clearfield County all his life.

(3). The plaintiff and defendant were married on October 27, 1934 in Cumberland, Maryland by a Justice of the Peace.

(4). At the time of their marriage both parties were citizens of the United States of America.

(5). There have been three children born of this marriage, to wit: - Walter L. Rodkey, aged 24 years, and living in Linden, N.J.; Bernadine M. Keith, married and living in Plainfield, N.J., 21 years of age, and Nancy C. Rodkey, born March 6, 1957, and living with the plaintiff in Morann.

(6). The defendant has offered such indignities to the person of the plaintiff as to render her condition intolerable and life burdensome.


(7). There has been no collusion between the parties hereto for the purpose of obtaining a divorce.

(8). The plaintiff herein avers that she is entitled to custody of the said Nancy C. Rodkey, being a child of tender years, and the plaintiff being the person who has reared and cared for the child and supplied the majority of the necessities of life for said child since birth.

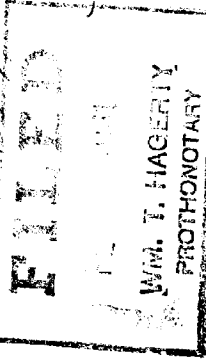
