2. That on May 22, 1957, Emory Gormont dedicated a certain sub-
division in the Township of Covington, Clearfield County, Pennsylvania as
recorded in the Office of the Recorder of Deeds in Miscellaneous Book No. 106
at page 112. Therein he dedicated as a public street:

Gormont Drive, being forty (40) feet in width, from Pennsylvania State
Highway Route # 17052 in a Southerly direction approximately 1052.6
feet.

3. The acceptance of the said street would be a benefit to the public
and to Covington Township.

4. Attached hereto and made a part hereof is a certified copy of a
Resolution duly passed by the Board of Supervisors of Covington Township,
accepting said street and also a plan of the street.

consent to the acceptance of Gormont Drive, as a part of the public road system
of Covington Township, by endorsing your consent hereon.

R E S O L U T I O N

ADOPTING AND ACCEPTING A STREET SITUATED IN THE EMORY GORMONT SUB-DIVISION TO BE KNOWN AS GORMONT DRIVE.

WHEREAS, Emory Gormont had dedicated a certain plot of ground in Covington Township, known as the Emory Gormont Sub-division. Said plot being recorded in Clearfield County in the Office of the Recorder of Deeds in Miscellaneous Book 106 at page 112, and

WHEREAS, said street forty (40) feet in width was dedicated as a public street in said plot, and

WHEREAS, it would be to the advantage of the property owners and the public in general, to have said street forty (40) feet in width as part of the road system in Covington Township.

BE IT RESOLVED THEREFORE THAT the street hereinafter designated, being forty (40) feet in width, be and are hereby accepted as a township street, subject to the consent of the Court of Quarter Sessions of Clearfield County, Pennsylvania,

Gormont Drive, being forty (40) feet in width, from Pennsylvania State Highway Route #17052 in a Southerly direction approximately 1052.6 feet.


ORDER OF COURT
