**COMPLAINT IN A CIVIL ACTION**

AND NOW, comes the Plaintiff, MURRAYS FREIGHTLINER, by and through its attorneys, HANAK, GUIDO AND TALADAY, who files this Complaint and in support thereof avers the following:

1. Plaintiff, MURRAYS FREIGHTLINER, is a Pennsylvania corporation organized and existing under the laws of the Commonwealth of Pennsylvania, with a business address of Route 219 and I-80, Exit 16, DuBois, Clearfield County, Pennsylvania, 16830.
2. Defendant, S M A ENTERPRISES, is a business located at 5740 W. San Miguel, Glendale, Arizona, 85301.
3. The Plaintiff, MURRAYS FREIGHTLINER, is in the business of reselling and repairing of trucks and tractor trailers.
4. On or about February 19, 2000, Defendant brought a 1999 Freightliner tractor, VIN No. 1FUPCSZB8XPB89936 for repairs to the Plaintiff.
5. Plaintiff performed various work for Defendant to include replacing the hood, grill, and correcting the radiator, air charge

cooler and numerous other mechanical items. The work was completed by Plaintiff on or about April 28, 2000. An invoice for the aforesaid work is attached hereto and made a part hereof as Exhibit "A".

6. Since Plaintiff completed the aforementioned work, Plaintiff has repeatedly contacted the Defendant for payment of the said services.

7. Despite repeated requests for payment by Plaintiff, Defendant has refused to pay the same.

8. Defendant's refusal to pay Plaintiff for the services provided by Plaintiff to Defendant's truck is a breach of the agreement between Plaintiff and Defendant.

9. Because of the services provided by Plaintiff to Defendant's truck, Defendant would be unjustly enriched if not required to pay Plaintiff.

10. The cost of the services provided by Plaintiff to Defendant were in the amount of Eighteen Thousand Three Hundred Thirty-two and 82/100 (\$18,332.82) Dollars.


11. In addition, Plaintiff has been forced to store the aforementioned vehicle for Defendant since April, 2000, to the present date at a cost of Five Thousand Four Hundred Twenty-five (\$5,425.00) Dollars.

12. Consequently, as a result of the work performed by Plaintiff for Defendant in the storing of the vehicle, Plaintiff has incurred damages as a result of Defendant's failure to pay in the amount of

(\$23,757.82) Dollars. The aforementioned expenses incurred by Plaintiff are continuing.

WHEREFORE, Plaintiff respectfully requests this Honorable Court to award judgment in favor of Plaintiff and against Defendant in an amount in excess of Twenty-five Thousand and 00/100 (\$25,000.00) Dollars, plus costs, interest and any other relief this Court deems just and equitable.
