PETITION IN EQUITY

NOW COMES, the Petitioner, John A. Gilday, Surviving Trustee of the Pleasant Hill Community Center, Decatur Township, Clearfield County, Pennsylvania, and sets forth his Petition as follows:

1. The Petitioner is John A. Gilday, an adult individual, of 1103 Alton Street, Philipsburg, Clearfield County, Pennsylvania 16866, who has served as a Trustee of the Pleasant Hill Community Center in Decatur Township, Clearfield County.
2. By Deed dated January 10, 1987, Yuccucio Casanova, by his Attorney-in-Fact, J.N. Casanova, conveyed certain property to The School District Of Decatur Township, Clearfield County, Pennsylvania, which Deed is recorded in Deed Book 43 at Page 381.
3. That by Deed dated November 6, 1956, the School District Of The Township Of Decatur, Clearfield County, Pennsylvania, granted and conveyed said property located in Decatur Township, Clearfield County, Pennsylvania to John Gilday, Clair

Steiner and Greyson Selby, Trustees of Pleasant Hill Community Center (Graham Precinct), an unincorporated association and recorded in Deed Book 455 at Page 63.

4. That the property described in said Deed was described as follows:

ALL that certain tenement and tract of land located and situated in Decatur Township, Clearfield County, Pennsylvania, bounded and described as follows, to wit:

BEGINNING at a stake corner, said corner being a distance of five hundred five and seventy-five hundredths (505.75) feet from the Northwestern right-of-way line of Route No.17022; thence by the Northern right-of-way of State Highway Route No.17057 leading from Philipsburg to Center South sixty-two degrees thirty minutes West ( $62^{\circ} 20' W$ ) a distance of one hundred ninety (190.0") feet to a stake corner; thence by line of D. Eshelman North twenty-six degrees fifty minutes West ( $26^{\circ} 50' W$ ) a distance of two hundred twenty-eight (228.0) feet to a stake corner; thence North sixty-five degrees thirty-five ( $65^{\circ} 35'E$ ) a distance of one hundred ninety and fifty hundredths (190.50') feet to a stake corner on line of George Smith; thence by line of George Smith South twenty-six degrees fifty minutes East ( $S 26^{\circ} 50' E$ ) a distance of two hundred eighteen (218.00') feet to a stake corner, the place of beginning.

5. That since the time of the conveyance to the Pleasant Hill Community Center, the building was used as a community center for the residents of Decatur Township, Clearfield County, Pennsylvania.

6. That subsequently, a non-profit corporation known as Pleasant Hill Community Center, Inc., was incorporated for purposes of administering the Center; however, the property was never conveyed to the Corporation.

7. That John A. Gilday is the sole surviving Trustee, as the other named Trustees are now deceased.

8. That the Pleasant Hill Community Center, Inc. is no longer a functioning non-profit corporation, as those people active in said Corporation are no longer active and/or have relocated outside of the Decatur Township area.

9. That the Township of Decatur, by its Board of Supervisors, has approved, pursuant to the Second Class Township Code, Section 2201, (53 P.S. Section 67201) the accepting of said building and property to be dedicated as a community center for the benefit of residents of Decatur Township.

10. That as a Fiduciary, Petitioner herein desires to make a Deed conveying the property to the Township, but with the unincorporated association no longer functioning, has no one from whom to secure approval nor to whom to make an accounting pursuant to such action. A copy of the proposed Deed is attached hereto and made a part hereof as Exhibit "A".

WHEREFORE, Petitioner would respectfully request the Honorable Court to hold a hearing and direct notice be given to the community at large and to any remaining individuals specifically who may be known to the Trustee as having expressed an interest historically in said property, for purposes of approving the Trustee conveyance of the property to Decatur Township in accordance with the PA R.C.P. Rule 1534(c).
