





COMPLAINT

AND NOW, comes the Plaintiffs, **BRYAN and LORI SROCK**, by their attorneys, **BLAKLEY, JONES & MOHNEY**, who files the within Complaint against the above-captioned Defendant and in support thereof avers the following:

1. Plaintiffs **BRYAN and LORI SROCK** are adult individuals residing at 398 Treasure Lake, Du Bois, Clearfield County, Pennsylvania 15801.
2. Defendant **WILLIAM MOORE** is an adult individual engaged in business as a contractor with a last known address at 229 Maple Avenue, Du Bois, Clearfield County, Pennsylvania 15801.
3. Defendant does not operate under any known trade name, nor is Defendant otherwise incorporated in his business as a general contractor.
4. On or about January 8, 1999, Plaintiffs and Defendant entered into a valid and enforceable oral agreement whereby Defendant was contracted to install tile flooring in Plaintiff's residence at 398 Treasure Lake, Du Bois, Clearfield County, Pennsylvania.

5. The Plaintiffs have fulfilled all provisions of the oral agreement on their part to be performed, namely payment to Defendant for services performed.

6. The Defendant has not fulfilled the provisions of the valid and enforceable oral agreement on his part to be performed.

7. Defendant has performed in a poor, improper, and workmanlike manner certain things which were expressly or by necessary implication required by the valid and enforceable oral agreement to be done and performed in a proper and workmanlike manner, namely as follows:

- (a) Portions of the ceramic tile floor installed by Defendant are buckling;
- (b) The ceramic tiles installed by Defendant are cracked in many places; and
- (c) The grouting installed by Defendant on the ceramic tile floors is deteriorating.

8. Defendant has failed and refused, and still refuses, to cure the aforementioned breaches, despite Plaintiff's repeated demands.


9. The reasonable costs of remedying the aforementioned breaches is in excess of \$10,000.00.

WHEREFORE, Plaintiffs demand judgment against Defendant in an amount not in excess of \$20,000.00 with costs and interest.
