ANSWER TO PLAINTIFF'S COMPLAINT

NOW comes the Defendant, Richard D. Heberling, doing business as Bigler Boyz, by and through his attorney, F. Cortez Bell, III, Esquire, who respectfully sets forth the Defendant's Answer to the Plaintiff's Complaint and avers as follows:

1. Paragraph 1 of the Complaint is admitted.
2. Paragraph 2 of the Complaint is admitted to the extent stated. It would be further averred that the true and correct name of the Defendant is Richard D. Heberling.
3. Paragraph 3 of the Complaint is admitted in part and denied in part. It would be admitted that the Plaintiff and the Defendant established accounts with each other for the purchase or supplying of various parts. It would be denied that those accounts would be what is referred to in Plaintiff's Complaint as an open account and strict proof thereof would be demanded at time of trial or hearing in this matter.
4. Paragraph 4 of the Complaint would be admitted in part and denied in part. It would be admitted that the Defendant on various occasions purchased parts from the Plaintiff and that the Defendant was to be billed on a monthly basis upon which certain payments would be made. It

would be specifically denied that said billings were specifically required on a monthly basis and that the Defendant made monthly payments. Strict proof of the denied averments of Paragraph 4 of the Plaintiff's Complaint would be demanded at time of trial or hearing in this matter.

5. Paragraph 5 of the Plaintiff's Complaint would be specifically denied. It would be specifically denied that that item or statement attached to the Plaintiff's Complaint as Exhibit A represents the monthly statement for October 27, 2000 indicating a balance due in the amount of \$685.90. To the contrary it would be averred that Exhibit A to the Plaintiff's Complaint bears the date of January 11, 2001 and as such does not represent the monthly statement allegedly provided to the Defendant for the month of October 27, 2000. Strict proof of the denied averment of Paragraph 5 of the Plaintiff's Complaint would be demanded at time of trial or hearing in this matter.

6. Paragraph 6 of the Plaintiff's Complaint would be denied. It would be specifically denied that to the date of the statement attached as Exhibit A, that being January 11, 2001, that the parties established a course of conduct whereby monthly service charges would accrue to the balance allegedly due the Plaintiff by the Defendant. Strict proof of the denied averment of Paragraph 6 of the Plaintiff's Complaint would be demanded at time of trial or hearing in this matter.

7. Paragraph 7 of the Plaintiff's Complaint would be admitted in part and denied in part. It would be admitted that for some period of time there was no payment on the Defendant's account with the Plaintiff. The item attached as Exhibit A to the Plaintiff's Complaint does not provide a basis for a more specific admission as there is no indication thereon as to when the last payment by the Defendant was credited to the Defendant's account. It would be specifically denied that the Defendant on or about September 22, 2000 made a payment on the Defendant's account with the Plaintiff as said entry represents a past due amount which the Plaintiff owed the Defendant which



DEFENDANT'S PRE-TRIAL STATEMENT

NOW comes the Defendant, Richard D. Heberling, doing business as Bigler Boyz, by and through his attorney, F. Cortez Bell, III, Esquire, who respectfully sets forth the Defendant's Pre-Trial Statement as follows:

STATEMENT OF THE CASE

The instant matter is before the Court as a result of a dispute concerning a billing that the Defendant received from the Plaintiff. It is not denied that an account was established by the Defendant with the Plaintiff. In addition, the Plaintiff had an account established with the Defendant. At one point in time the Plaintiff in order to result in a reduction on the Defendant's account credited an amount that the Plaintiff owed the Defendant thereby reducing the amount alleged to be owed by the Defendant. The dispute with regard to this matter is simply as to the amount, if any, which is owed the Plaintiff at this point in time.

CASE LAW

There are no specific case or statute references as this matter does not draw into

question any unusual circumstances to which reliance upon the same would be required. This matter is simply a suit based upon an account stated.


