COMPLAINT

NOW COMES the Plaintiff, Lezzer Cash & Carry of Curwensville, Inc., and by its attorney, James A. Naddeo, Esquire, sets forth the following:

1. That the Plaintiff is Lezzer Cash & Carry of Curwensville, Inc., a Pennsylvania corporation, whose principal place of business is Schofield Street, Curwensville, Pennsylvania 16833.

2. That the Defendant is Monroe Heights Development Corporation, a Pennsylvania corporation, trading and doing business as Microtel Inn & Suites, of 129 Dolby Street, Clarion, Pennsylvania 16214.

3. That beginning on August 29, 2000 and continuing on a regular basis until January 31, 2001, Defendant purchased goods and merchandise from Plaintiff.


4. During the time of Defendant's purchases, Plaintiff maintained books of account, keeping an accurate and running account of all debts and credits for the sale of goods and merchandise to Defendant.

5. That on or about February 1, 2001, Plaintiff submitted to Defendant a written account accurately showing all debits and credits for its transactions with defendant. A copy of the written account is attached hereto as Exhibit "A"
