COMPLAINT

AND NOW, comes the plaintiff, Jennie Kloss, who by and through her attorney, John R. Carfley, Esquire, files a claim against defendants herein, the following of which is a statement:

1. The Plaintiff is Jennie Kloss, an adult individual, presenting residing at Winburne, Clearfield County, Pennsylvania.

2. The Defendant is Jennifer Rogers, an adult individual, whose last known address was 3406 South 7850 West, Magna, Utah, 84044.

3. The Defendant is Robert F. Stemcovski, deceased, late of Winburne, Clearfield County, Pennsylvania. Stemcovski was related to the plaintiff which relationship accounted in large measure for the hereinafter referenced acts of generosity extended to the defendants by the plaintiff.

4. Plaintiff, at various times and places loaned money to Defendants to purchase property situate in the Township of Cooper, Clearfield County, Pennsylvania, bounded and described as follows:

BEGINNING at a post on Church Street; thence along Methodist Church lot South eighty-two (82) degrees thirty (30) minutes east one hundred fifty (150) feet; thence south six (6) degrees west one

hundred (100) feet to post; thence north eighty-two (82) degrees thirty (30) minutes west one hundred fifty (150) feet to post on Church Street and thence along Church Street north six (6) degrees east one hundred (100) feet to the place of beginning and being known as lots numbered twelve and fourteen, in the plot of Winburne Improvement Company's addition to the Village of Winburne.

This instrument of conveyance was dated February 5, 1992, and recorded in the office of the Recorder of Deeds of Clearfield County, Pennsylvania, in Deed Book Volume 1468, Page 422.

A true and correct copy of said deed of conveyance is attached hereto as Exhibit A.

5. It is believed and therefore averred that Robert Stemcovski passed away on or about May 29, 2000. No estate has been opened to date.

6. Upon the death of Robert Stemcovski, a one half interest in the said property vested in the defendant, Jennifer Rogers pursuant to the provisions of the deed which provided for a tenancy in common as between these two individuals.

7. Upon the death of Robert Stemcovski a one half interest in the said premises vested in the estate of the defendant, Robert Stemcovski by virtue of the deed which created a tenancy in common as between the joint owners.

8. To the best of Plaintiff's knowledge, information and belief no action has been taken by the defendant or any other individual to open an estate for the defendant Stemcovski or to pay any inheritance tax that may become due or be assessed on the said property by the Commonwealth of Pennsylvania, Department of Revenue.

9. Since the death of Stemcovski, Jennifer Rogers has listed the property for sale with Heritage Realty of State College, Pennsylvania.

10. Plaintiff, as aforesaid, at various times and places coincident to the purchase of the said property hereinabove described advanced money to the said defendants consisting of loans in the amount of \$13,393.00, with the express promise and assurances of the defendants that the defendants would reimburse the plaintiff for these advances.

11. Plaintiff, commencing on May 14, 1994 and continuing through the present time, loaned defendants sums of money totalling \$1,809.53 to buy materials to improve and renovate the home with the express promise and assurances of the defendants that the defendants would reimburse the plaintiff for these advances.

12. No written evidence of these loans was ever exchanged between plaintiff and defendants nor was any form of security provided plaintiff for these advances due largely to the familial relationship which existed between the plaintiff and decedent, Stemcovski.

13. At or about these times and places the defendants, individually and jointly, acknowledged receipt of the sums of money utilized to purchase the real estate and the sums of money loaned to the defendants to renovate and improve the home.

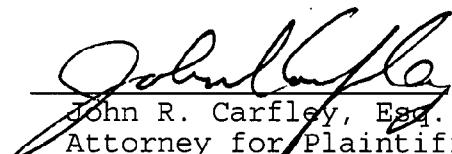
14. At various times and places defendants individually and jointly made promises to the plaintiff that the sums of money so advanced would be repaid thus lulling the plaintiff into a false sense of security with the intent of defrauding her of those sums rightfully advanced.

15. Although demand has been made for payment of the above enumerated loans, defendants have failed and continue to fail to

make any attempt at repayment of the same.

16. As a result of the actions of the Plaintiff in extending credit to the defendants defendants are indebted to the plaintiff in the amount of \$14,809.53, for which demand is now made.

WHEREFORE, Plaintiff prays your Honorable Court to enter judgment in favor of the Plaintiff and against the Defendants in the amount of \$14,809.53, together with prejudgment interest thereon from June 13, 1992, and costs of this proceeding.
