COMPLAINT

NOW, comes the Plaintiff, Backus USA, Inc., by and through its attorneys, The Hopkins Law Firm, and says as follows:

COUNT I

1. Plaintiff, Backus USA, Inc. is a Delaware corporation who maintains a principal business address along Route 219 North, DuBois, Pennsylvania 15801.
2. Defendant, NYK Line (North America, Inc.) is a corporation maintaining a principal business address at 300 Lighting Way, Secaucus, New Jersey 07094.
3. In or about the fall of 1999, Plaintiff contracted with Defendant to transport a USM-2 machine from the Netherlands to the convention center in Portland, Oregon, USA.
4. The equipment at issue arrived in Toronto, Canada from the Netherlands on December 27, 1999.
5. On December 30, 1999, the shipment departed Toronto and arrived in Detroit on December 31, 1999.

6. From Detroit Defendant sent the equipment via railcar to its final destination of Portland, Oregon where it arrived on January 10, 2000.

7. Defendant was obligated to transport the equipment to the NWFPA trade show which was held at the Oregon Convention Center in Portland, Oregon. The NWFPA show ran from January 24, 2000 through January 26, 2000. Consequently, Defendant had fourteen (14) days to move the equipment from the rail yard in Portland, Oregon to the Convention Center in Portland Oregon.

8. Defendant did not take the machine to the NWFPA trade show until Plaintiff called the Defendant complaining that the machine had not yet arrived at the Convention Center.

9. Plaintiff's agent advised Plaintiff that the Chicago office did not inform the agent that a shipment was coming to Portland and that is why the equipment was not transported to the Convention Center.

10. Defendant then arranged for the transfer of the machine from the rail yard to the Convention Center.

11. As a result of the delay in transporting the equipment to the Convention Center, Plaintiff was without the machine for the first day of a two and one half (2 1/2) day show.

12. Defendant breached its contract with Plaintiff by failing to alert its agents that a shipment was traveling from Detroit to Portland, Oregon, or otherwise transporting Plaintiff's equipment with diligent speed to the Oregon Convention Center.

13. As a result of Defendant's breach of its contract, Plaintiff has suffered damages in an amount in excess of \$20,000.00.

WHEREFORE, Plaintiff demands judgment against the Defendant for the following:

- a. Compensatory damages;
- b. Pre and post judgment interest;
- c. Cost of suit; and
- d. Such other and further relief as the Court deems fair, just and equitable.

COUNT II

14. Plaintiff repeats the allegations set forth in Count I as if set forth at length herein.

15. Defendant acted in a careless, reckless and negligent fashion in allowing Plaintiff's equipment to sit at a railroad yard in Portland, Oregon for fourteen (14) days without moving it to the NWFPA trade show.

16. Said negligence consists of:

- a. Failing to advise its agent that the shipment was headed to Portland, Oregon;
- b. Failing to notify Plaintiff when the shipment arrived in Portland, Oregon.
- c. Failing to advise Plaintiff that the equipment had not yet been moved to the NWFPA trade show.
- d. Failing to transport Plaintiff's equipment to the Oregon Convention Center with deliberate speed.

17. As a direct and proximate result of the careless, reckless and negligent conduct of Defendant, Plaintiff has suffered damages in an amount in excess of \$20,000.00.


WHEREFORE, Plaintiff demands judgment against the Defendant for the following:





PETITION FOR NOTICE OF REMOVAL

Defendant, NYK Line (North America), Inc., hereinafter ("NYK"), by and through its attorneys Rawle & Henderson LLP, hereby removes this action to the United States District Court for the Western District of Pennsylvania pursuant to 28 U.S.C. § 1331 and § 1441.

1. This action was commenced by way of a Complaint - Civil Action filed in the Court of Common Pleas of Clearfield County on March 7, 2001, and is docketed at No. 01-316-00, and is attached as Exhibit "A". The Complaint-Civil Action was mailed to petitioner no earlier than March 10, 2001.

2. The Complaint-Civil Action avers that there was a delay claim pursuant to cargo under a bill of lading or other marine contract shipped from the Netherlands to the United States.

3. The claim out of which the subject matter of this action arose was a maritime contract within the meaning of the Carriage of Goods by Sea Act (COGSA), and the rights of the parties herein are governed by the provisions of the Carriage of Goods by Sea Act. 46 U.S.C. §§ 1300 *et seq.*

4. This action is one over which this Court has original jurisdiction under the provisions of 28 U.S.C. § 1331, and is one which may be removed to this Court by defendant NYK pursuant to the provisions of 28 U.S.C. § 1441, as it is a civil action arising under a treaty of the United States. Wright, Miller & Cooper, *Federal Practice and Procedure: Jurisdiction* 3d § 3675 n.13 citing *Logistics Management, Inc. v. One Pyramid Tent Arena*, 86 F.3d 908 (9th Cir. 1996); *Thyssen Steel Co. v. M/V KAVO YERAKAS*, 50 F.3d 1349 (5th Cir. 1995); *Genetics Int'l v. Coremorant Bulk Carriers, Inc.*, 877 F.2d 806 (9th Cir. 1989); *Allied Chem. Int'l. Corp. v. Companhia de Navegacao Lloyd Brasileiro*, 775 F.2d 476 (2d Cir. 1985), *cert denied* 106 S. Ct. 1502 (1985).

5. This notice is timely, it being filed within 30 days of the receipt by petitioner of a copy of the Complaint-Civil Action setting forth the claims for relief upon which the action is based.


6. No other party has been named.




