ANSWER AND NEW MATTER TO PLAINTIFF'S COMPLAINT

1. Paragraph 1 of Lezzer's Complaint is admitted.
2. Paragraph 2 of Lezzer's Complaint is admitted.

DiRienzo admits that it has from time to time purchased goods and merchandise from Lezzer, but, pending complete investigation, is without knowledge or information regarding the timeframe during which it has purchased such goods and merchandise from Lezzer, for which reason the time period referenced in Lezzer's Complaint is denied and proof thereof is demanded.

4. DiRienzo is without knowledge or information sufficient to form a belief as to the truth or accuracy of the averments set forth in Paragraph 4 of Lezzer's Complaint, since they are

within the sole possession, custody and control of Lezzer, for which reason such averments are denied and proof thereof is demanded.

12. Lezzer has failed to adequately and accurately account for monies for which it seeks payment, for which reason Lezzer's claims are barred by waiver.


13. Lezzer has failed to adequately and accurately account for monies for which it seeks payment, for which reason Lezzer's claims are barred by payment.


