Hanak, Guido and Taladay, avers a cause of action against the  
Defendant as follows:


1. Plaintiff is the Jobbers Buying Group, Inc., a  
Pennsylvania business corporation, whose principal office and place of  
business is on McCracken Run Road, P. O. Box 604, DuBois, Clearfield  
County, Pennsylvania.
2. Defendant is Penn-Grampian Coal Company, a  
Pennsylvania business corporation, whose principal office and place of  
business is P. O. Box 249, Clearfield, Clearfield County, Pennsylvania.
3. Plaintiff is in the business of distributing and selling  
diesel fuel, gasoline and hydrocarbon products.
4. Defendant is in the business of mining and sales of  
bituminous coal, clay and stone.
5. At the instance and request of the Defendant, Plaintiff  
commenced selling to Defendant diesel fuel, gasoline and other  
hydrocarbon products for use in Defendant's business. Over the course

of years commencing on May 15, 1995, Plaintiff supplied to the Defendant \$15,145.03 of fuel and oil products for use by Defendant in its business.

6. Defendant has made payments on a consistent basis to the Plaintiff through September 13, 2000. After the last credit application, there is remaining a balance of \$6,000.00 owed by Defendant to Plaintiff before application of interest. A copy of the summary bills of account and purchase invoices are attached hereto as Exhibit "A".

7. Defendant refuses and continues to refuse to pay the unpaid balance of \$6,000.00, together with interest thereon.

WHEREFORE, Plaintiff demands judgment against the named Defendant in the amount of \$6,000.00 worth of principal, together with interest at the legal rate as the court may determine.






PRAECIPE FOR JUDGMENT BY DEFAULT






