Whereas, FIRST AMERICUS ENTERPRISES, INC. is about to execute contemporaneously herewith, a contract with MORTON BUILDINGS, INC. for the construction of a one-story, 48' x 100' building upon a lot of land described as:

ALL that certain piece, parcel or tract of land situate in the Township of Brady, Clearfield County, Pennsylvania, being bounded and described as follows:

BEGINNING at a four-inch iron pipe found, said pipe being the northeast corner of the tract herein described; thence South 00° 58' East, 1699.2 feet to a 3/4" rebar set; thence by lands now or formerly of Evelyn E. Sisco and Randy Bergh, South 87° 54' West, 323.8 feet to a 3/4" rebar set; thence South 32° 29' West, 30.1 feet to the centerline of S. R. 0219; thence by the centerline of S. R. 0219, North 57° 31' West, 148.1 feet to a point; thence by the same by a curve to the right, having a radius of 2286.42 feet, arc length of 198.78 feet, chord bearing North 55° 01' 44" West, 198.72 feet to a point; thence by the same North 52° 32' West, 144.1 feet to a point at the intersection of S.R. 4010; thence by the same North 52° 32' West, 109.4 feet to a point; thence by the same by a curve to the left, having a radius of 534.19 feet, arc length of 219.36 feet, chord bearing North 64° 18' 08" West, 217.82 feet to a point; thence by the same North 76° 04' West, 195.9 feet to a point; thence by the same by a curve to the left, having a radius of 764.95 feet, arc length of 449.54 feet, chord bearing of South 87° 05' 54" West, 443.10 feet to a point; thence leaving said road, North 00° 58' West, 1271.9 feet to a 3/4" rebar set; thence South 89° 55' East, 1650.6 feet to the place of beginning. Containing 2,388,749 square feet or 54.84 acres.


BEING the same premises which vested in First Americus Enterprises, Inc. by deed from P. Joseph Valigorsky, II, and Mark A. Piasio intended to be recorded in the Clearfield County Recorder's Office.


