AND NOW, comes the Plaintiff, and by its Attorney,  
Robert M. Hanak, avers a cause of action against the Defendant as  
follows:

1. Plaintiff is DuPenn, Inc., a Pennsylvania business corporation, who operates under the registered name of IGM Carbon, and whose address is R. R. 1, Box 100, DuBois, Clearfield County, Pennsylvania.

2. Defendant is PATCO Services, a business entity believed to be a corporation or partnership or proprietorship, whose principal place of business is at 1 Clark Road, Duryea, Pennsylvania.

3. Plaintiff is in the business of the machining, fabricating and sales of graphite and carbon products.

4. Pursuant to purchase orders of the Defendant, Plaintiff manufactured, machined, sold and delivered to Defendant machined carbon parts per shipments as follows:

(a) Shipment of March 23, 2000, in the amount  
of \$4,162.50;

(b) Shipment of March 27, 2000, in the amount of \$8,257.00; and

(c) Shipment of March 31, 2000, in the amount of \$16,545.75.

These shipments total \$28,965.25. Attached hereto are Plaintiff's invoices for the respective shipments as Exhibits A, B and C.

5. All shipments were made pursuant to a purchase order by Defendant to Plaintiff of March 9, 2000, which is attached hereto as Exhibit D.


