TOGETHER WITH, ALL AND SINGULAR, UNTO GRANTEES, THEIR HEIRS, SUCCESSORS AND ASSIGNS FOREVER, a perpetual right of way and easement to be used in common with grantors their heirs, successors and assigns, forever, in, upon, across, through and over a certain twenty-five (25) foot wide access road 1144.29 feet long which commences on the Southern boundary line of the hereinabove described premises and runs in an approximately Southerly direction across said lands now or formerly of Ernest J. and Althea A. Rohrbacker, to the Northern right of way of T-978 a/k/a Keller Road near the corner of said lands now or formerly of Ernest J. and Althea A. Rohrbacker and lands now or formerly of Chester A. Ogden.
