6. The averments of paragraphs 1 - 5 above are incorpo-  
rated with this new matter as though fully set forth herein.

7. I contacted Rep. Camille George due to my ill treatment  
by Clearfield Domestic Relations Office concerning 20 yr. old  
arrearages in the amount of \$5113 which I did not owe. I told  
Rep. George, due to a recent operation, I couldn't afford a law-  
yer. He advised me to contact his friend, Mr. Colavecchi, poss-  
ibly giving him a percentage of the \$5113 if he was able to obtain  
this money back. So on April 4, 2000, I called Mr. Colavecchi  
and told him about my conversation with Rep. George and that  
I would be willing to give up half of the \$5113 if he got it  
back. He said, "Let me look into it and I'll get back to you."

NEW MATTER (cont.)

8. In a letter dated April 7, 2000, Mr. Colavecchi requested I come to his office. Due to my operation, I had to have a friend drive me to Mr. Colavecchi's office on April 13, 2000. I was at his office approximately 45 min. At that time, he advised me I would need a \$1200 retainer and that he charges \$140 per hour for his services. I told him there was no way I could afford to pay that kind of money. I never signed a fee agreement or the petition he prepared. I assumed I did not hire him. Once again, I told Mr. Colavecchi I was willing to give up half of the \$5113 to pursue it. He refused and we never talked again.

9. On April 19, 2000, I received documents from Mr. Colavecchi that indicated he was still working on the matter, also demanding the \$1200 retainer to go forth. Again, I did not sign the petition he prepared nor did he and I appear in court. I have not gotten my money from DRO.

10. Mr. Colavecchi sued me in District Justice Court for services he claims to have provided. However, he did not appear for the hearing on April 2, 2001 and District Justice Ireland ruled in my favor. Now, Mr. Colavecchi appealed and the matter is in Common Pleas Court.

WHEREFORE, the Defendant respectfully requests that the Plaintiff's Complaint be dismissed and the Court rule in favor of the Defendant.
