WHEREAS, **DANIEL J. SMITCHKO** and **KIMBERLY A. SMITCHKO**, his wife, currently of RR 1 Box 215A, Morrisdale, Clearfield County, Pennsylvania, 16858, about to execute contemporaneously herewith, a contract, with **MORTON BUILDINGS INC.** of Route 45, Centre Hall, Pennsylvania, 16828 for the construction of home improvements to a residential building upon premises situate in Cooper Township, Clearfield County, Pennsylvania, bounded and described as follows:

**ALL** that certain tract, piece or parcel of land situate in Cooper Township, Clearfield County, Pennsylvania, bounded and described as follows to wit:

**BEGINNING** at a post on public road at the corner of land now or formerly of Leader Brothers; thence by line of said road the following courses and distances, South 66° 15' East, six hundred and eight (680) feet to a post; thence South 73° 15' East five hundred fifteen (515) feet to a post; thence South 77° East two hundred and twenty nine (229) feet to a post; thence South 78° 20' East eight hundred and thirty three (833) feet to post; thence South 79° East, eleven (11) feet to post and corner of land conveyed by Martha Raymond and August Raymond, her husband, to George Veihdeffer by deed dated the 16<sup>th</sup> day of May, 1922, and recorded in Clearfield County in Deed Book Volume 264, Page 267; thence along said Veihdeffer line South 6° 24' West, seven hundred and eighty three (783) feet to land formerly of Fred Berg Estate; thence along said land formerly of Fred Berg Estate North 83° 30' West, two thousand two hundred fifteen and five tenths (2215.5) feet to a post; thence by land now or formerly of Leader Brothers, North 6° 5' East, one thousand one hundred and ninety eight and six tenths (1198.6) feet to a post on public road and place of beginning.

**CONTAINING** forty seven (47) acres and thirty nine (39) perches, and being a part of the same premises which the heirs of John Veihdeffer conveyed to Martha Raymond by deed dated the 26<sup>th</sup> day of April, 1922, and recorded in Clearfield County in Deed Book 257 at Page 99.

**BEING** the same premises as vested in Daniel J. Smitchko and Kimberly A. Smitchko, his wife by deed of John B. Graffius and Isabelle Graffius, his wife and Florence Rothrock, a widow, dated the 8<sup>th</sup> day of July, 1994, and recorded in the Office of the Recorder of Deeds of Clearfield County to Deed Book 1618 at Page 14.

SMITCHKO**, his wife, it is agreed that no lien shall be filed against the building by the contractor, or any sub-contractor, nor by any of the material men or workmen or any other person for any labor, materials purchased for the erection of said building, the right to file such liens being expressly waived.
