COMPLAINT

NOW COMES the Plaintiff, Billy J. Lumadue, and by his attorney, James A. Naddeo, Esquire, sets forth the following:

1. That the Plaintiff is Billy J. Lumadue, an individual, who resides at R. D. 1, Box 214A, West Decatur, Pennsylvania 16878.

2. That the Defendant is William S. Albert, an individual, who resides at R. R. 1, Box 219CC, West Decatur, Pennsylvania 16878.

3. That the Plaintiff, Billy J. Lumadue, is the record owner of certain property located in Boggs Township, Clearfield County, Pennsylvania, by virtue of a deed from The Tax Claim Bureau of Clearfield County, Pennsylvania, dated December 10, 1993 and recorded in Clearfield County Deed and Record Book 1579, page 515. A copy of the deed is attached

hereto as Exhibit "A". The premises are more particularly bounded and described as follows:



4. That the Defendant, William S. Albert, challenges Plaintiff's possession of the parcel of land to the extent that Defendant has received a Deed from Daniel K. Stoltzfus, et al dated May 15, 1999 and recorded in the Office of the Register and Recorder for Clearfield County as Instrument No. 199907870 which purports to contain the property of the Plaintiff. A copy of said deed is attached hereto as Exhibit "B".

WHEREFORE, Plaintiff requests that this court order Defendant to bring an action in ejectment within thirty days

from entry of the order pursuant to Pa. R.C.P. No. 1066(b)(1),
or be forever barred from asserting a claim to said parcel.

DEFENDANT'S MOTION FOR RECONSIDERATION

AND NOW, comes the Defendant, WILLIAM S. ALBERT, by his attorneys, HANAK, GUIDO AND TALADAY, and hereby moves this Court to reconsider its decision as set forth in its Opinion and Order dated April 20, 2004, averring as follows:

1. On or about April 23, 2001, Plaintiff, BILLY J. LUMADUE, commenced this action to rule Defendant, WILLIAM S. ALBERT, to file an action in ejectment relative to a 14 acre tract of real property situated in Boggs Township, Clearfield County, that Plaintiff allegedly purchased at tax sale.
2. Defendant retained Attorney Barbara Hugney-Shope to represent him in the above matter.
3. Shortly after the pre-trial conference, Attorney Shope proposed a settlement in this case under the terms of which the parties would convey certain portions of the disputed property to each other and WILLIAM S. ALBERT would enjoy an easement over Plaintiff's portion of the disputed property.

4. On or about July 2, 2003, which was 5 days before this matter was scheduled for trial, Plaintiff submitted a counter-offer whereby the parties would exchange quit-claim deeds but Defendant would not enjoy an easement over Plaintiff's portion of the disputed property.

5. Attorney Shope agreed to such a settlement on July 2, 2003.

6. This Court found that Attorney Shope gave WILLIAM S. ALBERT instructions to contact her office by July 3, 2003, if he did not want to accept Plaintiff's counter-offer.

7. This Court further found that WILLIAM S. ALBERT did not object to such a settlement.

8. The Court made the above findings in spite of WILLIAM S. ALBERT'S testimony that he expressly objected to settlement on terms proposed by Plaintiff.

9. This Court went on to find that WILLIAM S. ALBERT'S alleged failure to object to the settlement retroactively gave Attorney Shope authority to settle this matter on terms proposed by Plaintiff.

10. WILLIAM S. ALBERT intends to appeal this Court's decision and has instructed your undersigned counsel to file timely notice of appeal.

WHEREFORE, Defendant, WILLIAM S. ALBERT, respectfully requests this Honorable Court to reconsider its decision that is set forth in its Opinion and Order dated April 20, 2004, and to issue an Order denying Plaintiff's Petition to Enforce Settlement.



Hearing thereon was held September 15, 2004, at which time Plaintiff presented one James Pahel, professional surveyor, who determined the boundaries of the premises in accordance with the map he prepared and which was admitted into evidence as Plaintiff's Exhibit No. 4. Mr. Pahel acknowledged that the survey does not follow exactly the courses and distances contained in the earlier deed in the chain of title dated September 1881 and, in fact, stated that the description contained in said deed does not properly close. He notes, however, in his testimony, that that deed was not prepared by a professional.

He further testified that he located a row of very

old blazed and marked trees on the eastern boundary, as well as the southern boundary, and located a stone wall on the western boundary and one-half of the northern boundary.


Defendant presented no expert testimony with regards to the description of the premises, although he did submit a map prepared by a surveyor who did not appear in person and was not subject to cross-examination.
