CIVIL COMPLAINT

The plaintiff, **ALTURNAMATS, INC.**, by and through its attorney, Richard W. Kooman, II, brings this civil complaint on a cause of action the following of which is a statement:

1. The plaintiff, Alturnamats, Inc., is a Pennsylvania corporation with a business address of P.O. Box 344, Titusville, Crawford County, Pennsylvania.

2. The defendant, Douglas Drill Services, Inc., is a Pennsylvania corporation with a registered address of TR 678 Graham Station, P.O. Box 77, Philipsburg, Clearfield County, Pennsylvania.

3. The plaintiff, upon oral request of the defendant, has sold and delivered various ground cover mats to the defendant on an open account. Since opening the account, any items returned for credit and any payments received without specific designation by the defendant as to the invoice to be credited, have been applied to the balance of the open account as provided by law.

4. The plaintiff, upon oral request of the defendant, sold and delivered to the defendant on said open account certain ground cover mats for which payment has not been made by the defendant. The date and the amount of each transaction is set forth on a photostatic copy of the account card maintained by the plaintiff

for the defendant marked Exhibit "A", attached hereto and made a part hereof. Copies of the invoices for materials and services listed on the account card are marked Exhibits "B-1" through "B-19" and are attached to and made a part of this complaint.


5. The prices charged the defendant are fair and equitable and are the prices specifically agreed upon by the plaintiff and defendant.

6. The balance owed the plaintiff since March 16, 2001 is \$50,264.09.

7. The plaintiff has requested the defendant to pay it the sum of \$50,264.09, but the defendant has refused and continues to refuse to pay the plaintiff.

WHEREFORE, the plaintiff, Alturnamats, Inc., demands judgment against the defendant, Douglas Drill Services, Inc., in the amount of \$50,264.09 together with interest at the legal rate of six (6%) percent per annum from March 16, 2001.
