All that certain lot, parcel or piece of ground situate in Beccaria Township, Clearfield County, Pennsylvania, bounded and described as follows:

Beginning at an iron pin along the Eastern side of State Route #1031, formerly Legislative Route 11064 and line of land now or formerly of GRC; then along the Eastern side of State Route #1031, formerly Legislative Route 11064 North 01 degree 12 minutes East for a distance of 637.85 feet to an iron pin; then along the line of Parcel 2 South 83 degrees 24 minutes East for a distance of 476.69 feet to an iron pin along the line of land now or formerly of Mark Kutruff; then along the line of land now or formerly of Mark Kutruff South 06 degrees 22 minutes West for a distance of 735 feet to an iron pin; then along the line of land now or formerly of GRC North 70 degrees West for a distance of 431.40 feet to an iron pin on the Eastern side of State Route #1031, formerly Legislative Route 11064, the place of beginning.
