WHEREAS, **RONALD L. GIBBONS** and **SHARON L. GIBBONS**, his wife, currently of RR 1 Box 189D, West Decatur, Clearfield County, Pennsylvania, 16878, about to execute contemporaneously herewith, a contract, with **QUENTIN McCLAREN** of RR 1 Box 382, West Decatur, Pennsylvania, 16878, for the construction of home improvements to a residential building upon premises situate in Boggs Township, Clearfield County, Pennsylvania, bounded and described as follows:

**ALL** that certain piece or parcel of land and situate in Boggs Township, Clearfield County, Pennsylvania, bounded and described as follows:

**BEGINNING** at an iron pin located on the Southern right of way line of T-670, said pin being the Northwest corner of Parcel 1, herein described; thence along T-670 South 83 degrees 26 minutes 01 seconds East a distance of 499.59 feet to an iron pin; thence along Parcel 2 South 13 degrees 38 minutes 56 seconds West a distance of 287.85 feet to an iron pin; thence along the line of land of Walter H. and Kathleen Fleck, grantors herein North 79 degrees 04 minutes 45 seconds West a distance of 516.46 feet to an iron pin; thence along same North 18 degrees 13 minutes 58 seconds East a distance of 251.64 feet to an iron pin and point of beginning.

**CONTAINING** 3.118 acres more or less and being Parcel 1 as shown on the Fleck Subdivision as prepared by George A. Cree, Registered Surveyor 2417 Skyline Drive, Fallentimber, PA 16639.

**BEING** the same premises as vested in Ronald L. Gibbons and Sharon L. Gibbons, his wife by deed of Walter H. Fleck and Kathleen Fleck, his wife dated the 3<sup>rd</sup> day of September, 1999, and recorded in the Office of the Recorder of Deeds of Clearfield County to Instrument Number 199914842.

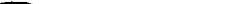
NOW, this 16<sup>th</sup> day of May, 2001, at the time of and immediately before the execution of the principal contract, and before any authority has been given by the said
