COMPLAINT

1. Plaintiffs are Burtis W. Dixon and Judy A. Dixon, parents and natural guardians of their minor daughter, Kristen H. Dixon, whose mailing address is P.O. Box 331, Bigler, Clearfield County, Pennsylvania 16825.

2. Defendant is Annisse J. Straw an individual residing at 409 Pine Top Road, P.O. Box 452, Bigler, Pennsylvania 16825.

3. On February 27, 2001, at approximately 7:30 a.m., Kristen H. Dixon was operating a 1994 Ford Probe traveling north on SR 970.

4. On that same time and date, Annisse J. Straw was operating a green Ford Explorer traveling south on SR 970.

5. Defendant crossed over the centerline and while going in a southerly direction, traveled into the northbound lane and into the path of the vehicle being operated by Plaintiff who then swerved to her right to avoid a collision.

6. As a result of having to swerve to avoid hitting Defendant's vehicle which had crossed over the centerline and came into Plaintiff's lane, Plaintiff lost control of her vehicle which caused it to cross over the southbound lane and into a ditch along the westside of SR 970 striking the opposite side of the ditch which was the initial impact point and final rest of the vehicle.

7. The injuries and damages hereinafter set forth were caused solely by and were the direct and proximate result of the negligence of the Defendant in any or all of the following respects:

- a. In operating the vehicle at a high, dangerous and reckless speed under the circumstances;
- b. In failing to have the vehicle under proper control;
- c. In continuing to operate the vehicle in a direction toward Plaintiff's vehicle when its operator saw or in the exercise of reasonable diligence should have seen that further operation in that direction would result in a collision;
- d. In that the driver was inattentive and failed to maintain a sharp lookout of the road and the surrounding traffic conditions;
- e. In violating the various statutes and municipal ordinances pertaining to the operation of motor vehicles on public

thoroughfares under the circumstances, including the violation of the statute on crossing over the centerline into the other lane of traffic;

f. In driving on the wrong side of the highway;

g. In crossing the divider line which marked the center of the road; and,

h. In failing to maintain a reasonable lookout for the presence of other motor vehicles on the road.

8. Solely as a result of the negligence of the Defendant as aforesaid, the said automobile of the Plaintiff owned by Burtis W. Dixon and Judy A. Dixon was damaged as set out in more detail on the estimate prepared by Bigler Boyz Collision Center showing a cost to repair the vehicle in the amount of Ten Thousand Nine Hundred Seventy-one Dollars and Eighty-four Cents (\$10,971.84), plus towing fees to remove the car from the ditch and to tow it to the residence in the amount of One Hundred Twenty Dollars (\$120.00) and storage fees at Ten Dollars (\$10.00) a day. A copy of said estimate is attached hereto marked Exhibit "A".

9. There is a current market value on the 1994 Ford Probe of Six Thousand Nine Hundred Ninety-five Dollars (\$6,995.00) as shown on Exhibit "B" to which would be added the inconvenience for loss of vehicle and interest and costs.
