COMPLAINT

1. Plaintiff William G. Satterlee & Sons, Inc. is a Pennsylvania corporation with an office and place of business at R.D. #1, Box 173, Rochester Mills, PA 15771 ("Satterlee").

2. Defendant Penn-Grampian Coal Company is Pennsylvania corporation with an office and place of business at Box 249, Grampian, Clearfield County, Pennsylvania 16838 ("Penn-Grampian").

3. That Penn-Grampian purchased from Satterlee diesel fuel and related products commencing on August 20, 1999 through April 30, 2000.

4. That Satterlee charged Penn-Grampian its usual and customary charges for said diesel fuel and related products.

5. That during the time of Penn-Grampian purchases, Satterlee maintained books of account, keeping an accurate and

running account of all debits and credits for the sale of diesel fuel and related products to Penn-Grampian.

6. That Satterlee submitted to Penn-Grampian a written account monthly requesting payment for the outstanding balance on the account. A copy of said accounting is attached hereto and marked Exhibit "A."

7. That Satterlee has made a demand for the payment of said outstanding balances due on said account which Penn-Grampian has failed and refused to pay.

WHEREFORE, Satterlee demands judgment against Penn-Grampian for \$20,037.97, together with interest at the rate of eighteen (18%) percent from May 31, 2000.



Upon demand, Customer shall return to Satterlee all cardlock cards. Customer shall promptly notify Satterlee at (412) 397-2400 or (800) 942-2214 if a cardlock card is lost or stolen.

2. Customer shall be responsible for and shall pay for all products withdrawn, discharged or released from the Stations using the Customer's cardlock cards, regardless of whether such use was authorized, unauthorized or fraudulent. 




