4. The within condemnation has been authorized by a plan signed by the Secretary of Transportation on May 1, 2001, entitled "Drawings and Authorizing Acquisition of Right-of-Way for State Route 0219, Section 228 R/W in Clearfield County, also State Route 0219 Section N06, also 0219 Section A03 R/W", a copy of which plan was filed in the County Recorder's Office in Instrument No. 200107339 at Map File No. 2309 on May 16, 2001.

5. The purpose of the within condemnation is to acquire property for transportation purposes.

6. A Schedule of Property Condemned identifying and specifying the location of the property hereby condemned is attached hereto and made a part hereof.

7. Plans showing the property hereby condemned may be inspected in the Recorder's Office of the aforesaid County at the places indicated on the attached Schedule of Property Condemned or, if not shown thereon, on the day of the filing of this document being lodged for record or filed in said Recorder's Offices, where they may be inspected.


8. The nature of the title hereby condemned is a channel easement.

9. In the event there are recoverable minerals (including gas and oil) within the areas, if any, hereby condemned in fee simple, the mineral rights (including rights to gas and oil) in those areas are hereby excepted and reserved from this condemnation, provided however, that the right of support of the areas condemned is included within the scope of this condemnation, and no access from the surface of such areas for removal purposes will be allowed without permission from the Commonwealth.

10. The payment of just compensation in this matter is secured by the Commonwealth's power of taxation.

11. I, Gary C. Fawver, P.E., Chief, Right of Way & Utilities Division, of the Department of Transportation, do hereby depose, swear and affirm that I am authorized by and do hereby execute this Declaration of Taking on behalf of the Commonwealth of Pennsylvania, Department of Transportation, and that the averments contained and set forth herein are true and correct to the best of my knowledge, information and belief, and are made subject to penalties provided in 18 Pa. C. S. §4904, relating to false swearing to authorities.

WHEREFORE, a channel easement is hereby condemned from the property identified on the attached Schedule of Property Condemned, as indicated on the plans referenced in paragraph 7 above.



TO THE HONORABLE JUDGE OF SAID COURT:

Petitioner, the Department of Transportation of the Commonwealth of Pennsylvania, respectfully represents that:

1. The Department of Transportation ("Commonwealth") is a Department of the Commonwealth of Pennsylvania with offices at P.O. Box 8212, Harrisburg, Pennsylvania 17105-8212.
2. On May 31, 2001, a Declaration of Taking was filed by the Commonwealth, condemning, *inter alia*, certain real property owned by James Panighetti and Corinda Kay Panighetti ("claimants").
3. On September 6, 2001, upon Petition of the Commonwealth, this Honorable Court ordered and directed that the sum of \$4,500.00, representing the amount of just compensation estimated by the Commonwealth due to claimants for damages sustained resulting from the condemnation of her property, be deposited into Court.
4. At the time of the filing of the Declaration of Taking, there were no liens or encumbrances still owing against the property of the claimants, as shown on the attached Proposed Schedule of Distribution.

5. The sum of \$4,500.00 that was deposited into Court in accordance with this Court's Order remains deposited, as no party in interest has filed a petition.

6. Subsequent to the estimated just compensation being deposited into Court, the claimants entered into a post-condemnation settlement with the Department and the Department agreed to present this Petition on their behalf.

8. I, Christopher J. Clements, Assistant Counsel in Charge, affirm that I am authorized to execute this Petition to Pay Claimants on behalf of the Department, that all statements are true and correct to the best of my knowledge, information and belief, and that all statements are made subject to the penalties provided in 18 Pa.C.S.A. §4904, relating to unsworn falsification to authorities.

**WHEREFORE**, Petitioner respectfully requests that this Honorable Court order and direct that the sum of \$4,500.00, representing the amount deposited into Court as just compensation due claimants, plus any accrued interest, be paid to the claimants in the following amounts, as provided in Section 522 of the Eminent Domain Code, 26 Pa.C.S. §522, as amended; \$2,250.00 plus 50 per cent accrued interest to James Panighetti and \$2,250.00 plus 50 per cent accrued interest to Corinda Kay Panighetti.
