
STIPULATION AGAINST LIENS

WHEREAS, DENNIS A. STEWART, (hereinafter "OWNER"), of R.R. 1, Box 2, Curwensville, Pennsylvania, is about to execute contemporaneously herewith, a contract with J. S. REMODELING (hereinafter "CONTRACTOR") of R.D. 1, Box 480, Curwensville, Pennsylvania, to perform the labor necessary for the construction of a 24' x 30', one story addition to the rear of his two (2) story residence at R.R. 1, Box 2, Curwensville, Clearfield County, Pennsylvania, and being more particularly described in the Deed of conveyance to the OWNER herein, recorded in Clearfield County Deed Book 1794, page 272.

NOW, THEREFORE, at the time of and immediately before the execution of the contract between OWNER and CONTRACTOR, and before any authority has been given by OWNER to the said CONTRACTOR to perform the labor necessary for the construction, or to purchase materials for said construction, in consideration of the making of the contract for the construction between the OWNER and CONTRACTOR, it is agreed that neither the undersigned CONTRACTOR, any subcontractor, or material man, or any workman, or any other person, for labor furnished or materials purchased, shall file a lien, commonly called a Mechanic's Lien, for work done or materials furnished to the said building under the contract between the OWNER and CONTRACTOR for construction of the commercial building, the right to file, maintain or have such liens being expressly waived.



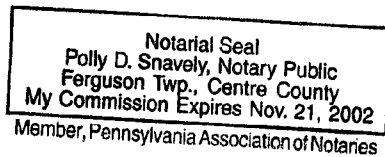

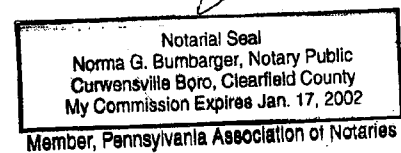
