STIPULATION AGAINST LIENS



This stipulation is made and intended to be filed with the County Prothonotary within ten (10) days after date, in accordance with the requirements of Act of Assembly of Pennsylvania, in such case provided.

BEGINNING at an iron pipe (found) on the easterly line of SR 4018, being the northwesterly corner of now or formerly (n/f) Dennis Pane;

THENCE by the Easterly line of SR 4018, North 0 degrees 12 minutes East, 69.77 feet to the Southwestern corner of Parcel #2;

THENCE by Parcel #2, North 87 degrees 45 minutes East, 100.00 feet to an iron pin set;

THENCE by the residual lot, South 0 degrees 12 minutes West, 69.77 feet to an iron pin set on line of n/f Dennis Pane;

THENCE by line of n/f Pane, South 87 degrees 45 minutes West, 100.00 feet to an iron pipe found and the place of beginning.
