**COMPLAINT**

NOW, COMES the Plaintiffs, William Scott DeLong and Christine DeLong, by and through their attorneys, Lea Ann Heltzel, Esquire and The Hopkins Law Firm, and says:

1. Plaintiffs, William Scott DeLong and Christine DeLong, are adult individuals residing at 626 South Brady Street, DuBois, Clearfield County, Pennsylvania.
2. Defendant, David F. Iorfida, is an adult individual residing at 110 Pinecrest Road, St. Marys, Elk County, Pennsylvania.
3. On April 30, 2000, at approximately 1:30 A.M., Plaintiffs were asleep in their bed in their home located at Dickinson Road, Sandy Township, DuBois, Clearfield County, Pennsylvania.
4. Defendant, David F. Iorfida, was traveling North on Route 255, Sandy Township, Clearfield County, when he failed to negotiate a turn and drove his vehicle directly into Plaintiffs' house.

5. At the time of the accident, Plaintiffs were asleep in their bed. Due to the forceful impact of Defendant's vehicle, Plaintiff William Scott DeLong was thrown out of his bed.

6. The accident was directly and proximately caused by the negligence and carelessness of Defendant which consisted, among other things, of the following:

- a) Operating his motor vehicle in a careless, reckless and negligent manner;
- b) Operating his motor vehicle at an excessive rate of speed under the circumstances;
- c) Operating his motor vehicle without due regard to the rights, safety and position of Plaintiffs;
- d) Failing to have his motor vehicle under the proper control so as to prevent his vehicle from striking Plaintiffs' house;
- e) Failing to keep a proper lookout;
- f) Failing to use due care under the circumstances;
- g) Failing to take evasive action in order to avoid impacting with Plaintiffs' house;
- h) Operating his motor vehicle and disregarding the rules of the road and laws of the Commonwealth of Pennsylvania including, but not limited to, accidents involving death or personal injury; accidents involving damage to attended vehicle or property damage and duty to give information and render aid; and immediate notice of accident to police department.
- i) Operating his motor vehicle while Defendant was under the influence of alcohol.

## COUNT I

### Plaintiff, William Scott DeLong, vs. Defendant

7. Plaintiff incorporates by reference all of the preceding paragraphs of this Complaint as if each and every one were individually set forth within this Count.

8. As a direct, proximate, natural, foreseeable and probable consequence of Defendant's negligence, carelessness and reckless conduct, Plaintiff was placed in immediate peril and sustained an AC joint separation, and other injuries which may yet develop.

9. As a direct result of Defendant's negligence, carelessness and reckless conduct, Plaintiff has suffered, and will suffer in the future, great pain, agony and inconvenience.

10. As a direct and proximate result of Defendant's negligence, carelessness and reckless conduct, Plaintiff has incurred, and will in the future incur, expenses for medical treatment in an amount not yet ascertained.

11. As a direct and proximate result of Defendant's negligence, carelessness and reckless conduct, Plaintiff was prevented from attending his usual duties of employment, causing loss of income and in the future incurred earning losses, by not being able to achieve his full employment potential.

12. Defendant is liable to Plaintiff William Scott DeLong for his injuries described herein inasmuch as Plaintiff's injuries are the direct, proximate, natural, foreseeable and probable consequence of Defendant's negligence, carelessness and recklessness as set forth herein.

WHEREFORE, Plaintiff William Scott DeLong demands judgment to be entered in his favor, against Defendant, in an amount in excess of \$20,000.00, together with interest, costs of suit, damages for delay and other such relief as the Court deems just and appropriate.

**COUNT II**

**Plaintiff Christine DeLong vs. Defendant**

13. Plaintiff Christine DeLong incorporates all of the preceding paragraphs of this Complaint as if each and every one were individually set forth within this Count.

14. As a result of Defendant's negligence, Plaintiff Christine DeLong has been deprived of the society, companionship, contributions and consortium of her husband, Plaintiff William Scott DeLong, to her great detriment and loss.



**COMPLAINT**

NOW, COMES the Plaintiffs, William Scott DeLong and Christine DeLong, by and through their attorneys, The Hopkins Law Firm, and says as follows:

1. On April 30, 2000, David Iorfida was traveling north on Route 255 in Sandy Township, Clearfield County when he failed to negotiate a turn and drove his vehicle directly into a house in which Petitioners were sleeping. Due to the forceful impact of Mr. Iorfida's vehicle, Petitioner, William Scott DeLong was thrown out of his bed and suffered personal injuries.

2. Mr. DeLong was diagnosed with an A/C joint separation by Orthopedic Surgeon, Samuel Barley. Mr. DeLong underwent physical therapy on thirty (30) occasions with elevated pain at level 7 out of 10.

3. Mr. DeLong treated with Casteel Chiropractic Center on twenty-one (21) occasions.

4. Mr. DeLong's medical expenses total \$11,299.91.

5. Mr. DeLong was employed at Gertz Electric as a delivery and stockperson. As a result of the collision, he has been unable to work for nine (9) months and his lost wage claim is

over \$8,000.00.

6. Various criminal charges were filed against Mr. Iorfida including leaving the scene of a motor vehicle accident. To the best knowledge, information and belief of Petitioner, Mr. Iorfida plead guilty to some or all of the charges filed against him and served some period of incarceration as imposed by the criminal courts of Common Pleas of Clearfield County.

7. On June 15, 2001, Petitioners filed a Complaint against Mr. Iorfida. Thereafter, Mr. Iorfida's insurance company, Kemper Insurance Companies, offered to settle all of Petitioner's claims against Mr. Iorfida upon payment of Mr. Iorfida's entire automobile policy limit of \$15,000.00.

8. Petitioners maintain automobile insurance of their own issued by Respondent, Shelby Casualty Insurance Company, providing stacked underinsured motorist coverage of \$25,000.00 per person.

9. Petitioners' claims against Mr. Iorfida far exceed \$15,000.00 and as a result thereof Petitioners intend to pursue an underinsurance motorist claim against Shelby Casualty Insurance Company.

10. After receiving the July 26, 2001 offer from Kemper Insurance Companies, Petitioner wrote to Shelby Casualty Insurance Company requesting authorization to settle and then pursue an underinsurance motorist claim. See Exhibit "A".

11. No response was received from Respondent, Shelby Casualty Company, and on August 30, 2001, Petitioner set a similar written request by certified mail which Respondent received on September 4, 2001. See Exhibit "B".

12. To date, Respondent has failed to acknowledge the claims of Petitioner.

WHEREFORE, Petitioner respectfully requests this Court enter an Order authorizing Petitioners, William S. Delong and Christine DeLong, to accept \$15,000.00 from Kemper Insurance Companies and execute a general release in favor of Kemper Insurance Companies and David Iorfida without prejudicing Petitioners' underinsurance claim against Respondent Shelby Insurance Company.


