**COMPLAINT IN A CIVIL ACTION**

AND NOW, comes the Plaintiff, NATURE'S BLEND WOOD PRODUCTS, INC., by and through its attorneys, HANAK, GUIDO AND TALADAY, and files this Complaint and in support thereof aver the following:

1. Plaintiff, NATURE'S BLEND WOOD PRODUCTS, INC., is a corporation organized under the laws of the Commonwealth of Pennsylvania, with its principal place of business at 202 First Avenue, Ford City, Armstrong County, Pennsylvania, 16226.

2. Defendant, HORCHEN'S CABINETRY AND FINE WOODWORK, is a business operating and existing under the laws of the State of Pennsylvania, with its principal place of business at 305 Aspen Way, DuBois, Clearfield County, Pennsylvania, 15801.

3. At all times relevant hereto, Plaintiff's business activities include the sale of wood and wood products.

4. At all times relevant hereto, the Defendant's business activities include the purchase and fabrication of wood and wood products.

5. In the ordinary course of business, Defendant purchased from Plaintiff numerous orders of wood and wood products, which transactions are summarized as follows:

(a) On or about October 27, 1999, a purchase order of red oak more fully set forth in Invoice No. 382951, attached hereto as Exhibit "A", and for the purchase price of \$16,635.70;

(b) On or about November 17, 1999, a purchase order of red oak wood products more fully set forth in Invoice No. 387233, attached hereto as Exhibit "B", and for the purchase price of \$15,614.52;

(c) On or about November 30, 1999, a purchase order of red oak more fully set forth in Invoice No. 389041, attached hereto as Exhibit "C", and for the purchase price of \$9,564.14;

(d) On or about December 9, 1999, a purchase order of red oak more fully set forth in Invoice No. 390535, attached hereto as Exhibit "D", and for the purchase price of \$11,856.79;

(e) On or about December 15, 1999, a purchase order of red oak more fully set forth in Invoice No. 391669, attached hereto as Exhibit "E", and for the purchase price of \$13,517.70.

6. Against the above referenced charges, Defendant has made payments as follows:

(a) 10/26/00 - \$ 28.81



8. All purchased goods as above described have been delivered by Plaintiff to Defendant.

9. Because of Defendant's failure and/or refusal to pay Plaintiff, Defendant owes Plaintiff the sum of \$61,245.31, plus interest.

WHEREFORE, Plaintiff respectfully requests this Honorable Court to award judgment in its favor and against the Defendant in an amount of \$61,245.31, plus interest, costs and such other relief as the Court may deem appropriate.
