DO HEREBY AGREE TO PAY TO THE DEPARTMENT OF PUBLIC WELFARE OF THE COMMONWEALTH OF PENNSYLVANIA, ITS SUCCESSORS OR ASSIGNS, OR ITS DULY AUTHORIZED AGENT, THE SUM OF NINE HUNDRED DOLLARS AND 00/100
(\$ 900.00) FOR ASSISTANCE RECEIVED

by or for me, by or for those persons for whom I am responsible under the Pennsylvania Support Law.

The judgment to be obtained by the recording of this instrument shall be a lien upon my real property and be collected as other judgments, except that the real and personal property comprising my home and furnishings shall not be subject to execution on such judgment so long as it continues to be occupied as my home or that of my spouse or dependent children. No interest is to be added.

It is understood that my property at Route 1, West Decatur, Newtown, Clearfield County, Pennsylvania which I am purchasing from the Standard Real Estate Company, 311 Ross Street, Room 218, Pittsburgh 19, Pennsylvania, under unrecorded Articles of Agreement dated June 1, 1960 for repayment of all assistance received as above on or after June 1, 1960.

I DO HEREBY AUTHORIZE THE PROTHONOTARY OF, OR ANY ATTORNEY, OF ANY COURT OF RECORD OF PENNSYLVANIA OR ELSEWHERE, TO APPEAR FOR AND TO ENTER JUDGMENT AGAINST ME FOR THE SAID SUM, WITH OR WITHOUT DECLARATION, WITH COSTS OF SUIT, RELEASE OF ERRORS, WITHOUT STAY OF EXECUTION. I ALSO WAIVE THE RIGHT OF INQUISITION ON ANY REAL ESTATE THAT MAY BE LEVIED UPON TO COLLECT THIS SUM, AND HEREBY VOLUNTARILY CONDEMN THE SAME, AND AUTHORIZE THE PROTHONOTARY TO ENTER UPON THE FIERI FACIAS MY SAID VOLUNTARY CONDEMNATION AND I FURTHER AGREE THAT THE SAID REAL ESTATE MAY BE SOLD ON A FIERI FACIAS. I HEREBY WAIVE AND RELEASE ALL RELIEF FROM ANY OR ALL APPRAISEMENT, STAY OR EXEMPTION LAWS OF ANY STATE, NOW IN FORCE OR HEREAFTER TO BE PASSED.
