

COMPLAINT

AND NOW, comes the Plaintiff, KIMBERLY S. BUCHANAN, by and through her attorneys, Tomb, Mack & Kauffman by Myron Hay Tomb, Esquire, and files this Complaint in Civil Action and in support thereof avers the following:

1. The Plaintiff, Kimberly S. Buchanan, is an individual having her principal place of residence at 89 Wolfe Road, Indiana, PA 15701.

2. The Defendant, Justine Toombs, is an individual having her principal place of residence at 1217 Worth Street, Reynoldsville, PA 15851.

3. The events herein complained of occurred on or about September 6, 1999 at approximately 1:30 p.m. in the parking lot of Sheetz, in DuBois, Clearfield County, PA.

4. At said time and place, the Plaintiff was slowly pulling into her parking space when her vehicle was struck on the front passenger side by a vehicle operated by the Defendant.

5. At said time and place, Defendant caused, allowed or permitted her vehicle to violently strike the vehicle operated by the Plaintiff. Plaintiff was seriously, severely and perhaps permanently injured as a result of the accident in question.

6. The Defendant was negligently generally and in the following particulars:

- a. In failing to maintain a proper lookout for vehicles upon the roadway;
- b. In failing to operate her vehicle within the assured cleared distance ahead;
- c. In operating her vehicle at an excessive rate of speed;
- d. In operating her vehicle at a speed too fast for conditions;

e. In operating her vehicle in negligent or reckless disregard of the rights of the Plaintiff;

f. In failing to observe or attempt to observe the slowly moving vehicle in the Sheetz parking lot;

g. In failing to take all reasonable measures to avoid colliding with the motor vehicle being operated by Plaintiff, Ms. Kimberly S. Buchanan;

h. In failing to stop or turn her motor vehicle or to take other appropriate action so that the collision with the motor vehicle operated by Plaintiff could be avoided;

7. As a direct and proximate result of the negligence of the Defendant, the Plaintiff suffered the following injuries:

a. sprain or strain of the nerves, muscles, tissues, ligaments and vessels of the musculoskeletal system;

b. trauma to the musculoskeletal system resulting in severe and prolonged headaches and dizziness;

c. trauma to the muscles, nerves and cervical vertebrae;

d. sprain or strain to the nerves, muscles, tissues, ligaments and vertebrae of the cervical spine;

e. trauma and contusions of the left shoulder and arm;

f. sprain or strain of the nerves, muscles, tissues, and ligaments of both shoulders;

g. trauma to the lumbar spine;

h. sprain or strain of the nerves, muscles, tissues, ligaments and vertebrae of the lumbar spine;

i. trauma to the lumbar spine causing damage to the nerves with symptomatic radiating pain to both legs;

j. trauma and contusions of the nerves, muscles, bones and connecting tissue of the right leg;

k. severe shock;


1. other damages and injuries which may be permanent in nature, the exact nature of which are not known at this time.

8. As a result of her aforesaid injuries, Plaintiff has suffered economic loss in the form of lost income from the date of the accident to the present.

WHEREFORE, Plaintiff demands judgment against the Defendant for a sum in excess of Twenty-Five Thousand (\$25,000.00) Dollars.




5. Venue is proper in Clearfield County as the motor vehicle accident took place in DuBois, Clearfield County, Pennsylvania.


22. Defendant hereby raises the defenses of comparative and/or contributory negligence.

**DEFENDANT JUSTINE TOOMBS' MOTION TO COMPEL
AM-GUARD, INC. TO COMPLY WITH DEFENDANT'S SUBPOENA
TO PRODUCE DOCUMENTS AND THINGS FOR DISCOVERY**

AND NOW, comes Defendant, JUSTINE TOOMBS, by and through her attorneys, McQuaide, Blasko, Schwartz, Fleming & Faulkner, Inc., to respectfully move this Honorable Court to issue an appropriate Order compelling Am-Guard, Inc. to fully and completely comply with Defendant's subpoena to produce documents and things for discovery. In support thereof, Defendant avers as follows:

1. Plaintiff commenced the instant personal injury action by filing a Writ of Summons in Indiana County on August 1, 2001. Plaintiff thereafter filed a Complaint devoted to the same action in Clearfield County on August 31, 2001.
2. Upon consideration of Plaintiff's Motion to Consolidate the Clearfield County and Indiana County actions, this Court entered an Order consolidating same on October 3, 2001.
3. Defendant filed an Answer with New Matter to Plaintiff's Complaint on October 17, 2001.
4. This personal injury action seeks recovery in an amount in excess of \$25,000 for injuries Plaintiff allegedly sustained in a motor vehicle accident which occurred on September 6, 1999.

5. As part of this action, Plaintiff makes a substantial claim for economic loss in the form of lost income attributed to the injuries she sustained in the accident. (See ¶ 8 of Plt.'s Compl. attached hereto as Exhibit "A").

6. Specifically, Plaintiff claims to have lost approximately \$17,000 in wages from her former employer, Am-Guard Security, due to lost business opportunities with same as a direct result of the injuries she sustained in the September 6, 1999 motor vehicle accident. (See excerpts of Plt.'s Answers to Def.'s Interrogs. and Request for Production of Documents (Set One), Nos. 6-9, attached hereto as Exhibit "B.")

7. In this regard, on or about April 4, 2002, Defendant Toombs served a subpoena to produce or things for discovery pursuant to Rule 4009.22 upon Am-Guard, Inc. with a business address of 600 Main Street, Pittsburgh, PA 15215, in order to ascertain and evaluate the extent of Plaintiff's economic loss relative to her employment. (See Notice of Intent to Serve Subpoenas to Produce Documents and Things for Discovery Pursuant to Rule 4009.21 dated March 15, 2002, attached hereto as Exhibit "C"; subpoena to produce documents and things for discovery pursuant to Rule 4009.22 and applicable Certificate of Service, attached hereto as Exhibit "D"; correspondence dated April 4, 2002, attached hereto as Exhibit "E").

8. Said subpoena was received by Am-Guard, Inc. as evidenced by the certified mail receipt signed by Joanne Reynolds on April 5, 2002, copy of which is attached hereto within Exhibit "E."

9. Said subpoena directed Am-Guard, Inc. to produce a true and correct copy of any and all personnel/employment records of Kimberly Buchanan, including but not limited to, "application for employment, pre-employment physical examination, annual evaluations, wage scale, hours worked, absences due to sickness, absences due to vacations, absences for other

reasons, sick days accumulated/used, vacation days accumulated/used, any and all correspondence pertaining to Kimberly Buchanan's employment status, and any and all Workers' Compensation documents, etc.," within twenty (20) days of said subpoena. (See Exhibit "D").

10. Given Plaintiff's substantial wage loss claim relative to the instant action, Defendant's review and analysis of Am-Guard, Inc.'s employee records for Plaintiff Kimberly Buchanan is an essential aspect of Defendant's preparation of this case in order for Defendant to ascertain and evaluate the extent of Plaintiff's wage loss with Am-Guard, Inc., if any, that is related to the September 6, 1999 motor vehicle accident which serves as the basis for the instant action.

11. On or about June 11, 2002, counsel for Defendant Toombs directed correspondence to David Duncan, Vice President of Administration for Am-Guard, Inc., to inquire about the status of Am-Guard, Inc.'s response to the subpoena to produce documents and things for discovery. (A copy of said letter is attached hereto as Exhibit "F").

12. In addition, counsel for Defendant Toombs has made numerous telephone calls to Mr. Duncan to inquire about the status of the records requested by said subpoena.

13. Although Mr. Duncan represented that a portion of the employment records subject to the subpoena may have been destroyed in a flood, he also indicated that he would forward the remaining records pertaining to Plaintiff in response to Defendant's subpoena. (See Exhibit "F").

14. Despite the foregoing and the passage of over seven months, as of this date, Am-Guard, Inc. has failed and refused to produce its employee file for Plaintiff Kimberly Buchanan in response to the subpoena to produce documents and things for discovery served upon it by Defendant Toombs.

15. Moreover, to date, Am-Guard, Inc., has not filed any objections to Defendant's subpoena.


16. Without the benefit of Am-Guard, Inc.'s employee file for Plaintiff Kimberly Buchanan, Defendant Toombs is severely prejudiced in her preparation of this case and her pursuit of any and all aspects of discovery, including but not limited to obtaining expert review of the case and making determinations regarding the necessity for and nature of further discovery.

17. Consequently, Defendant Toombs has no way to adequately and appropriately evaluate Plaintiffs' substantial wage loss claim as it relates to the September 6, 1999 accident.

WHEREFORE, Defendant, Justine Toombs, respectfully requests that an Order be issued compelling Am-Guard, Inc. to fully and completely with Defendant's subpoena to produce documents and things for discovery pursuant to Rule 4009.22, within ten (10) days of the date of such Order or suffer appropriate sanctions, which may include the imposition of attorneys' fees and costs. A proposed Order is attached hereto.

DEFENDANT JUSTINE TOOMBS' MOTION FOR SUMMARY JUDGMENT

AND NOW, comes Defendant, Justine Toombs, by and through her attorneys, McQuaide, Blasko, Schwartz, Fleming & Faulkner, Inc., and respectfully moves this Court pursuant to Pennsylvania Rule of Civil Procedure 1035.2 to enter summary judgment in her favor. In support of her Motion, Defendant avers as follows:

1. This action arises from a relatively minor two vehicle accident that occurred on September 6, 1999 in the parking lot of Sheetz in Dubois, Clearfield County, Pennsylvania. (See Compl. ¶¶ 3-4).

2. Plaintiff initiated this action against Defendant via Writ of Summons filed on or about August 1, 2001 in Indiana County. Defendant filed preliminary objections to venue, and the case was thereafter transferred to Clearfield County. Plaintiff filed her Complaint on or about August 31, 2001.

3. Plaintiff seeks recovery for alleged pain, suffering, and other such non-economic losses, as well Plaintiff's alleged economic losses. (See Compl. ¶¶ 7-8).

4. Defendant filed an Answer with New Matter to Plaintiff's Complaint on or about October 17, 2001 pursuant to an extension agreement between the parties. Defendant raised, inter alia, Plaintiff's selection of the limited tort option and the preclusions of section 1722 of the Motor Vehicle Financial Responsibility Law in defense of Plaintiff's claims.

5. The parties have exchanged written discovery, and depositions of both parties have been taken. Defendant has subpoenaed various records, including Plaintiff's first party automobile file, Plaintiff's employment records, and medical records.

6. Defendant also served Requests for Admission on Plaintiff on August 8, 2003. Plaintiff never filed responses to the Requests. (A true and correct copy of Defendant's Requests for Admission is included as Exhibit "A" in Defendant's Exhibits in Support of Motion for Summary Judgment, filed on even date herewith (hereinafter "S.J. Exhibits")).

7. At the time of the automobile accident giving rise to this action, Plaintiff had a policy of automobile insurance with State Farm Insurance Company. Plaintiff was bound by the limited tort selection under the State Farm Policy. (See Plaintiff's Declarations Page from State Farm Insurance, Exhibit "B" of S.J. Exhibits).

8. Plaintiff had \$10,000 in first party medical benefits available to her under the State Farm Policy, and up to \$15,000 available in first party wage loss coverage. (See id.)

9. As further set forth below, discovery pertinent to the instant motion is complete, and it is clear that Plaintiff did not suffer a "serious injury" sufficient to surpass the limited tort threshold under section 1705 of the Motor Vehicle Financial Responsibility Law ("MVFRL"), such that Plaintiff may not seek non-economic damages at trial. Additionally, discovery reveals that Plaintiff cannot prove any recoverable special damages pursuant to MVFRL section 1722.

10. Consequently, Defendant files this Motion for Summary Judgment, seeking dismissal of Plaintiff's claims and the entry of judgment in Defendant's favor.

A. Defendant Is Entitled To Summary Judgment With Respect To Plaintiff's Non-Economic Loss Claims Because Plaintiff Is Bound By The Limited Tort Option, And It Is Clear From The Record Adduced In Discovery That Plaintiff Cannot Meet The Serious Injury Threshold As A Matter Of Law

11. MVFRL section 1705 precludes an individual who is bound by the limited tort option from maintaining an action for non-economic loss resulting from an automobile accident unless the individual sustained a "serious injury." 75 Pa. C.S.A. § 1705.

12. The burden is on a limited tort plaintiff seeking to recover non-economic losses to prove a “serious injury” sufficient to overcome the limited tort threshold. See Washington v. Baxter, 553 Pa. 434, 719 A.2d 733 (1998).

13. As defined by Section 1702 of the MVFRL, a “serious injury” is a “personal injury resulting in death, serious impairment of body function or permanent serious disfigurement.” See 75 Pa. C.S.A. § 1702.

14. To prove a “serious impairment of body function” sufficient for recovery of non-economic damages, a plaintiff must demonstrate: (1) that a body function was impaired because of injuries sustained in an automobile accident; and, (2) that the impairment was serious. In ascertaining whether an impairment is “serious,” courts look to the following nonexclusive list of factors: the extent of the impairment, the particular body function impaired, the length of the impairment, and the treatment required to correct it. See Washington, 553 Pa. at 447, 719 A.2d at 740.

15. In addition to the above, the Pennsylvania Supreme Court has stated that medical testimony is generally necessary to establish the existence, extent, and permanency of a claimed impairment. Id.

16. In her Complaint, Plaintiff in the case at bar alleges that she suffered “trauma” and “sprain or strain” to the musculoskeletal system, lumbar spine, cervical spine, left shoulder and right leg allegedly resulting in numerous symptoms, including prolonged headaches and dizziness, symptomatic radiating pain to both legs,” “severe shock,” and “other damages and injuries which may be permanent in nature” (See Compl. ¶ 7a-l).

17. Despite these bare allegations, however, discovery in this case reveals that Plaintiff’s alleged injuries do not rise to the level of a “serious injury” as a matter of law.

18. As further described herein, Plaintiff’s treatment for symptoms and complaints she relates to the accident was fairly minimal.

19. Plaintiff was evaluated at the emergency room on the day of the accident and released. (See Indiana Hosp. record, Exhibit “C” of S.J. Exhibits). X-rays of the lumbar spine,

cervical spine and left shoulder were unremarkable except for degenerative disc disease in the lumbar area. (Id.).

20. Plaintiff reported to Dr. Anne Jesick, her family doctor, in follow-up four days later, and subsequently had various follow-up phone calls with Dr. Jesick regarding her complaints. (See Dr. Anne Jesick records, pertinent portions of which are attached as Exhibit “D” in S.J. Exhibits).

21. Plaintiff then saw her chiropractor,¹ Lawrence Bouma, D.C., for thirteen chiropractic visits through November 15, 1999. Dr. Bouma’s records indicate improvement over the course of these visits. (See records of Bouma Chiropractic Clinic, D.C., pertinent portions of which are attached as Exhibit “E” in S.J. Exhibits).

22. In addition, Plaintiff was evaluated by Dr. Daniel A. Wecht one time at Tri-State Neurological Associates on November 16, 1999. (See record of visit with Dr. Daniel A. Wecht, included in S.J. Exhibits as Exhibit “F”). Dr. Wecht interpreted MRIs of Plaintiff’s cervical and lumbar spines as showing slight disc bulges but no herniation. (Id.).

23. After one and a half years of no treatment at all, Plaintiff again went to see Dr. Bouma for six more visits on the advice of her attorney. (See Exhibit E and Exhibit G, at 75-76).

24. Plaintiff’s last treatment for injuries she claims were caused by the accident was in October of 2001. At that point, Plaintiff herself testified that she felt better and did not need to return for further treatment. (See Plaintiff Kimberly Buchanan Depo., attached as Exhibit “G” in S.J. Exhibits, at 79-81).

25. As of the time of her deposition on November 12, 2003, despite ostensibly having continuing subjective complaints, Plaintiff had not sought any treatment since her last chiropractic visits with Dr. Bouma, and did not have any plans for further treatment. (See id. at 83-84).

¹ Plaintiff had seen Dr. Bouma in the past for neck and back injuries sustained in a work-related incident. (See Exhibit E-1, S.J. Exhibits).

26. In addition, Plaintiff's medical records do not document any significant physician-imposed restrictions, or reflect any substantial, lasting impairment as a result of the automobile accident at issue. (See, Exhibits C-F, generally).

27. During her deposition, Plaintiff testified that she has worked continually since the accident, even at a physically demanding job as a nurse's aid in a personal care home, (see Exhibit G, at 20-31), and that she at times worked two physically demanding jobs. (Id. at 27-31).

28. Plaintiff also testified that she carried on with her daily routine and was never prevented from engaging in any activities on account of accident-related injuries. (See id. at 68, 83-84).

29. In sum, the record as developed through discovery reveals that Plaintiff cannot adduce sufficient competent evidence from which a jury could find that Plaintiff suffered a "serious injury" as that term is defined under Pennsylvania law.

30. Accordingly, Plaintiff cannot meet the serious injury threshold necessary to recovery of any non-economic losses in the instant case, and Defendant is entitled to summary judgment on Plaintiff's claims for non-economic losses.

WHEREFORE, Defendant Justine Toombs respectfully requests that this Honorable Court enter summary judgment in her favor and against Plaintiff on Plaintiff's claims for non-economic losses.

B. Defendant Is Entitled To Judgment As A Matter Of Law With Respect To Plaintiff's Claims For Economic Damages Because MVFRL Section 1722 Precludes Plaintiff From Recovering Any Such Damages Under The Circumstances Of This Case, And Because Plaintiff Cannot Come Forward With Competent Evidence Of Recoverable Wage Loss

31. Section 1722 of the Motor Vehicle Financial Responsibility Law prohibits recovery of medical expenses and/or wage loss paid or payable under a policy of insurance. 75 Pa. C.S.A. § 1722.

32. At the time of the September 6, 1999 vehicle accident, Plaintiff was insured under an automobile insurance policy which provided \$10,000.00 in first party medical expense coverage, and wage loss coverage of up to \$15,000.00. (See Exh. B hereto).

33. Plaintiff never exhausted the \$10,000.00 in first party medical coverage, and all medical expenses for injuries allegedly related to the accident have been paid by her automobile insurance carrier. (See First Party Pay Out Log, Exhibit "H" of S.J. Exhibits).

34. Consequently, Plaintiff is precluded from recovering any medical expenses at trial of this case. (See 75 Pa.C.S.A. §1722; Carlson v. Bubash, 432 Pa. Super. 514, 639 A.2d 458, 461 (1994)).

35. Although Plaintiff claims to have suffered a limited period of lost wages as a result of the accident, (see Exh. G, at 45-46), Plaintiff has never come forward with documentation to support her wage loss claim, or with competent evidence of any accident-related disability that prevented Plaintiff from working at any time.

36. In fact, Plaintiff's deposition testimony establishes that she has worked fairly continuously since the accident at various different jobs. (See ¶ 27, above, and related citations).

37. Even assuming, without conceding, that Plaintiff could otherwise prove a viable wage loss claim, Plaintiff would be precluded from proving or recovering such losses to the extent they were payable under her own automobile insurance policy. (See 75 Pa. C.S. § 1722).

38. Plaintiff's discovery responses reveal that Plaintiff either never applied for and/or never received wage loss payments under her own automobile policy, (see Exh. G, at 47), such that the \$15,000.00 available in wage loss coverage under the policy cannot have been exhausted.

39. In sum, discovery reveals that all medical expenses have been paid under Plaintiff's automobile insurance policy, and even assuming some limited period of disability, Plaintiff had first party wage loss coverage available to her that was never exhausted.

40. Thus, Defendant submits that Plaintiff cannot come forward with evidence of recoverable economic losses in this case, and Defendant is therefore entitled to summary judgment with respect to Plaintiff's claims for economic losses such as medical expenses and wage loss.


WHEREFORE, Defendant Justine Toombs respectfully requests that summary judgment be granted in her favor with respect to any claims for economic losses and damages, such as medical expenses and wage loss (past, present, or future), because the evidence adduced in discovery shows that Plaintiff cannot present competent proof of recoverable losses of this nature, and because Plaintiff is precluded from recovering the same under section 1722 of the Motor Vehicle Financial Responsibility Law.



R.C.P. 4005, 4006, 4009 and 4014.

If your answer to any of the Requests for Admission is anything other than a complete admission, please state all facts upon which you rely to support your denial or qualified admission. Each matter set forth herein shall be deemed admitted unless you serve an answer or objection upon counsel for Defendant, within thirty (30) days of the date of service thereof.

The interrogatories and document requests shall be deemed to be continuing interrogatories and document requests, pursuant to Pa. R.C.P. 4005, 4006, and 4009. If, between the time of your answers and the time of trial of this case, you or anyone acting on your behalf learn of any further information not contained in your answers, you shall promptly furnish said

information to the undersigned by supplemental answers or supplemental production of documents.

DEFINITIONS

A. "You" and/or "your" means Plaintiff, her agents and employees and others acting on her behalf with regard to asserting the cause of action to be set forth in Plaintiff's Complaint in the above-captioned case.

B. "Document" shall mean any writing (whether handwritten, typed, printed or otherwise made), drawing, graph, chart, photograph, phonograph record, or electronic or mechanical matter (including microfilm of any kind or nature, tape or recording), or other data compilations from which information can be obtained (translated, if necessary, by Plaintiff, through detection devices into reasonably usable form), and shall include, without limiting the generality of the foregoing, all records, correspondence, telegrams, teletypes, agreements, studies, reports, drafts, memoranda, and computer print outs.

C. As used herein "identify," when used in reference to an individual, means his/her full name and present or last known residence and business address, his/her present or last known position or title and business affiliation, and his/her position at the time in question.

D. "Health care provider" means a person, corporation, facility, institution or other entity licensed or approved by the Commonwealth to provide health care or professional services as a physician, including a medical doctor and a doctor of osteopathy and a doctor of podiatry; hospital; nursing home; health maintenance organization; or an officer, employee or agent of any of them acting in the course and scope of his employment.

Where the Interrogatories request that documents be identified, an identification of it should include at least the following: author, addressee, type of document, date, subject matter, and the name and address of the person or party presently having custody of the document and any known copies of it.

INSTRUCTIONS FOR ANSWERING INTERROGATORIES

1. In accordance with Pa. 3. In accordance Pa. R.C.P. 4006(b), a sufficient answer to such an Interrogatory shall be to specify the records from which the answer may be derived or ascertained.

4. Please file and serve answers to these Interrogatories in accordance with the Pennsylvania Rules of Civil Procedure.

**INSTRUCTIONS FOR RESPONDING TO
REQUEST FOR PRODUCTION OF DOCUMENTS**

1. With respect to each of the following requests, you shall identify and/or produce all documents which are known to you or which can be located or discovered by you through diligent effort on the part of you, your employees, representatives, attorneys or accountants, including but not limited to, all documents which are in the business or personal files of your employees, in the possession of your representatives, attorneys or accountants, or accessible to you, your employees, or your representatives, attorneys or accountants.

2. The following requests shall be deemed to be continuing so as to require further and supplemental production of documents by you in accordance with Pa. R.C.P. 4009.

3. If any documents requested herein have been lost or destroyed, you shall provide in lieu of a true and correct copy thereof, a list of each document so lost or destroyed, together with the following information: (1) the date of origin; (2) a brief description of such document; (3) the author of such document; (4) the date upon which the document was lost or destroyed; and (5) a brief statement of the manner in which the document was lost or destroyed.

4. HISTORY:

On September 14, 1999, Ms. Buchanan came into my office for the purpose of evaluation and treatment for injuries sustained in an auto accident on September 6, 1999. The patient described accident as "pulling into parking space, almost to complete stop" (broad-sided on passenger side).

Patient entered this office with the following complaints:

1. Numbness in legs
2. Low Back pain
3. Left shoulder and shoulder blade pain
4. Neck pain
5. Headaches

EXAMINATION:

THERMOGRAPHY EXAMINATION:

Thermographic examination performed on September 14, 1999, revealed asymmetrical patterns in the cervical, thoracic and lumbar regions with possible nerve root or nerve fiber irritation and possible peripheral nerve irritation. Cervical, thoracic and lumbar altered range of motion and orthopedic examination suggests injury to the cervical, thoracic and lumbar spine

Thermography is a noninvasive and radiation-free method of evaluating certain types of pathology, vascular changes, and nerve involvement. Thermographic equipment uses colors to reveal the detected heat emissions and in a normal individual, the color representation should be symmetrical.

Thermographic examination displays the effect of those injuries at the neuro-musculature level.

RADIOLOGIC EXAMINATION:

DISCUSSION:

Ms. Buchanan suffered sprain/strain of moderate degree in both cervical and lumbar spine. This is demonstrated by our objective exam using x-ray, orthopedics, range of motion, thermography, pain scales and pain drawing analysis. Advanced imaging was performed at Indiana MRI which demonstrated disc damage at C5/C6 and C6/C7 and also L1/L2, L2/L3 and L5/S1.

DISCUSSION CONTINUED:

Ms. Was treated conservatively and demonstrated slight improvement in the severity of her complaints. The patient discontinued care after six weeks. She was last seen in this office on November 15, 1999 with complaints similar to her initial visit.

The MRI results indicated disc damage in both cervical and lumbar spine. The left-sided disc herniation at C6/C7 is consistent with the patient complaints of left arm paraesthesia. It appears that her accident has caused this damage which results in her complaints.

My last contact with the patient was November 1999. It is reasonable to expect that her symptoms will continue as they were since I had minimal success with the patient.


HISTORY: This is a 35 year old female with a history of left arm paresthesia, left lower extremity paresthesia, leg numbness.

TECHNIQUE: T1 and T2 sagittal images. T1 and gradient axial images were obtained from C3 through the intervertebral disc space of T1-2. Some patient motion artifacts are seen on this which due degrade the quality of and somewhat limit this study.

FINDINGS: There is straightening of the normal curvature of the cervical spine which is non specific, possibly due to spasm. Mild disc space narrowing is seen between C5-6 and C6-7. The height and marrow appearance of the vertebral bodies are unremarkable. There is a very small central and slightly to the left side disc herniation at C6-7 which is mildly compressing the dura. The neural canal is otherwise normal. The cord is normal. The neural foramina are patent bilaterally.

IMPRESSION: THERE IS A VERY SMALL CENTRAL AND SLIGHTLY LEFT SIDED DISC HERNIATION AT C6-7 WHICH IS MILDLY COMPRESSING THE DURA.

MRI OF THE LUMBAR SPINE

HISTORY: This is a 35 year old female with a history of left arm paresthesia, left lower extremity paresthesia, leg numbness.

TECHNIQUE: T1 and T2 sagittal images. T1 axial images were obtained through the intervertebral disc space of L1 through S1.

FINDINGS: Mild arthritic changes are seen. There is intervertebral disc space narrowing between L1 through L3 and L5-S1.

A slight disc bulge is seen at L1-2 minimally compressing the dura. There is a slight disc bulge at L5-S1 which is not involving the central canal or neural elements. There are no disc herniations on this exam. The neural foramina are patent bilaterally. The central canal and conus are normal. The height and marrow appearance of the vertebral bodies are unremarkable.

IMPRESSION: THERE IS A SLIGHT DISC BULGE AT L1-2 WHICH IS MINIMALLY COMPRESSING THE DURA.

THERE IS A VERY SMALL DISC BULGE AT L5-S1 WHICH IS NOT INVOLVING THE NEURAL CANAL OR NEURAL ELEMENTS.

NO DISC HERNIATIONS ARE SEEN ON THIS EXAM.



On February 7, 1996, Mrs. Buchanan came into my office for the purpose of evaluation and treatment for injuries sustained while working for Emerson Square Personal Care on February 4, 1996. The patient stated "I was lifting a gentleman that weighed about 200 pounds from the shower to his wheelchair with assistance, and my lower half went to opposite than my top half. It felt like a rubber band snapping".

Patient entered this office with the following complaints:

1. Low back pain
2. Mid back pain
3. Upper back pain
4. Neck pain
5. Pain in both legs with tingling and numbness
6. Pain in right arm

M. Buchanan was examined by Dr. Jose Amayo on April 9, 1996. His report is enclosed.

THERMOGRAPHIC EXAMINATION

Thermographic examination performed February 7, 1996 revealed asymmetrical patterns in the cervical, thoracic and lumbar regions with possible nerve root or nerve fiber irritation. Thermography is a noninvasive and radiation-free method of evaluating certain types of pathology, vascular changes, and nerve involvement. Thermographic equipment uses colors to reveal the detected heat emissions and in a normal individual, the color representation should be symmetrical. Lumbar altered range of motion and orthopedic examination suggest injury to the lumbar spine. Thermographic examination displays the effect of those injuries at the neuro-musculature level.

RADIOLOGIC EXAMINATION

Radiologic examination performed February 7, 1996 demonstrated a mildly decreased loss of cervical lordotic curve. Cervical curve measures +27 degrees. Subluxation noted at C5. Mild dextro-scoliosis apexed at T6. Subluxation noted at T6. Mild dextro-lumbar lordotic curve. Levo-scoliosis apexed at L3. Mild loss of spaces between L5/S1. Left ilium rotated P12/EX2. Pelvic unleveling high on left. Lumbar curve measures +33 degrees. Facet hypertrophy at L5.

FUNCTIONAL CAPACITY EVALUATION

Mrs. Buchanan underwent computerized mechanical, isometric muscle test with torque curves and printed report of March 12, 1996. The equipment used in this testing measures precise strength capability. Test data provides accurate measurements needed to identify areas of weakness, to quantify performance deficiencies, to determine the extent of injury or disability, and evaluate rehabilitation goals and progress. The following tests representing critical job tasks were performed:

The strength features indicate that Mrs. Buchanan should be capable of light duty work. The definition of light duty work includes the following weight restrictions:

Patient may lift up to 10 pounds frequently (14-68% of the time);
Patient may lift 10 - 20 pounds occasionally (0-33% of the time).

TREATMENT

Chiropractic care to include specific corrective adjustments to the interosseous disrelationship of the vertebrae of the spine with gentle mobilizing and extension maneuvers. These adjustments were initiated at the frequency of three times a week.

DIAGNOSIS

T-6 subluxation; Acute, mild thoracic sprain/strain; Thoracic intervertebral disk disease disorder; Pain in thoracic spine; C-5 subluxation; Acute, mild cervical sprain/strain

A visual analog scale (VAS) was given to the patient to rate her perception of pain. Initially, she reported an 9 (out of 10) for her current pain, an average of 9 and worst pain ever as 10. Her best recent VAS on April 1, 1996 reported a 7 for her current pain, an average of 8 and worst pain ever as 9. This VAS shows no signs of symptom magnification or inappropriate pain behavior.

The functional capacity evaluation demonstrated no signs of symptom magnification or inappropriate pain behavior. The patient's effort was unsatisfactory on none of the tests. All tests indicate that the patient put forth the maximum effort. The tests suggest that Mrs. Buchanan is capable of performing work at light duty.

The patient's objective assessment for her disability was measured using the Roland-Morris Neck and Low Back Questionnaires, the Oswestry Pain Questionnaire for low back and Visual & Mair Neck Disability Index. All tests show appropriate response, no signs of symptom magnification, and evidence of mild disability. Copies of all questionnaires are included for your information.

DISCUSSION

Mrs. Buchanan suffered an injury of the cervical, thoracic and lumbar spine, of sprain/strain nature. This is demonstrated through X-ray, orthopedic test, range of motion and thermographic studies.

She made good progress while under our conservative chiropractic care. She was released to return to light duty on March 4, 1996. This was increased to medium duty on March 18, 1996. She indicated on March 25, 1996 she started to work for a friend at the pet boutique 15 to 30 hours a week maximum lifting was about 20 pounds occasional.

Mrs. Buchanan was last seen on March 29, 1996. At that time she was capable of light to medium duty as outlined in our functional capacity March 12, 1996 and jrb analysis correspondence which was forwarded to Betty McCloskey on March 29, 1996. She was released May 30, 1996 due to her withdrawal from treatment.

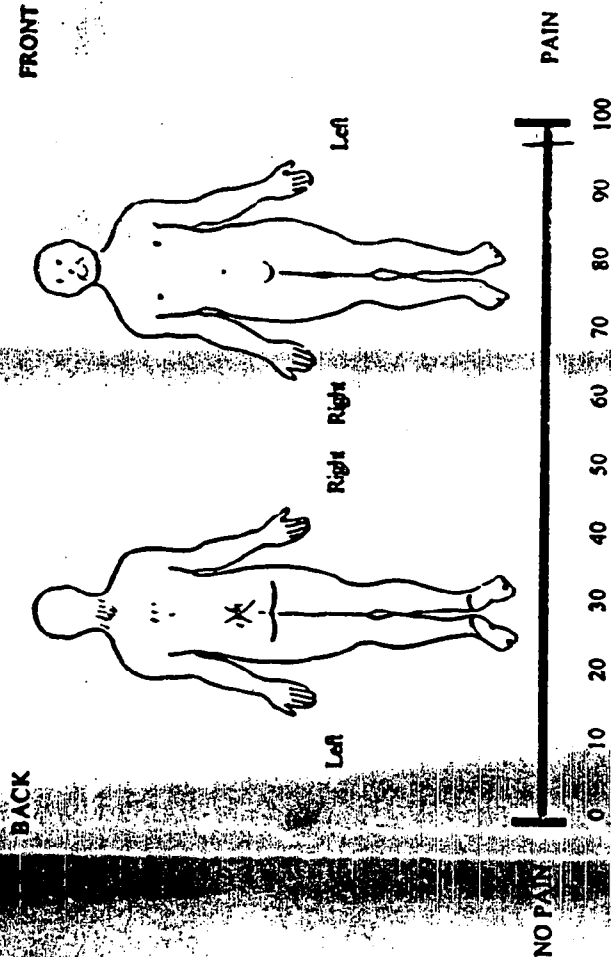

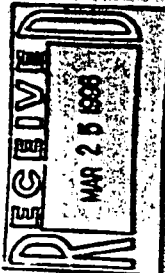

3. Lift less than 10 pounds frequently.

Kim must avoid continuous bending or lifting from the floor. When Kim is doing her laundry duties she needs to work within the restrictions given. If she needs to lift 2 or 3 articles of clothing at a time, Kim should do this even if it takes her the entire shift to complete her duty. These restrictions apply from February 9, 1996 until February 19, 1996. Dr. Bouma will update you on Kim's progress. Please contact our office at the above address if you have any questions.

Today Ms. Buchanan states that she has neck and left shoulder pain which radiates down her arm to her fingers. She also has numbness and tingling of her hand with some right arm numbness. She states that her left side of her ~~left~~ shoulder is worse than her right.

She also complains of low back pain which radiates to her buttocks. She states that both legs are numb off and on and she has some knee discomfort. She also states that she has burning in her right wrist.

PAST MEDICAL HISTORY:

Past medical history is significant for hypertension, cancer, and thyroid disease.

Family history is significant for hypertension, diabetes, heart disease, cancer, thyroid disorders, and GI problems.

REVIEW OF SYSTEMS:

Cardiovascular: Negative for shortness of breath, palpitations, chest pain, or hypertension.

Respiratory: Negative for cough, wheezing, or shortness of breath.

Gastrointestinal: Negative for heartburn, abdominal pain, diarrhea, or rectal bleeding.

Genitourinary: Negative for dysuria, hematuria, or incontinence.

PHYSICAL EXAMINATION:

General: This is a well-developed female in no acute distress.

Neurologic: The patient ambulated through the office with a steady gait. Strength testing revealed no motor deficits. Sensation was intact to pinprick evaluation. Reflex testing revealed normal, intact and symmetrical reflexes of the bilateral upper extremities.

DIAGNOSTIC STUDIES:

An MRI was presented for review dated September 29, 1999. The MRI of the cervical spine reveals a small disc bulge at the C6-7 level eccentric to the left. The lumbar MRI revealed a slight disc bulge at the L1-2 and the L5-S1 levels with no herniation seen.

FINAL RECOMMENDATIONS:

I had a lengthy discussion with Mrs. Buchanan concerning her condition. Because of the severity of her symptoms, I have asked her to undergo EMG studies to help us further delineate the source of her pain. 3 with Environmental Service Labs?

4 A. No.

5 Q. Before working for
6 Environmental Service Labs, what was
7 the last job you had before that?

8 A. Victorian Gardens Personal
9 Care Home.

10 Q. What were your job duties
11 there?

12 A. Nurse's aide.

13 Q. How long did you work there?

14 A. Three years.

15 Q. Can you give me a month and a
16 year that you started?

17 A. I can't give you an actual
18 ---. I know it was October, the end
19 of September, close to October.

20 Q. Of what year?

21 A. '99.

22 Q. You seem like you're guessing.

23 A. No, I just want to make sure
24 --- I'm trying to give you a specific
25 date and I don't think I can give you

1 a specific date.

2 Q. But you think that it was
3 1999?

4 A. No, I know it was '99, I'm
5 just trying to ---.

6 Q. And when did you stop working
7 there?

8 A. January 2002.

9 Q. But you didn't work there that
10 whole time continuously, did you?

11 A. Yeah.

12 Q. You did?

13 A. Uh-huh (yes).

14 Q. Why did you stop working there
15 in January 2002?

16 A. I needed a better job. I
17 needed more money.

18 Q. Is that the only reason?

19 A. Yeah.

20 Q. Was it ever communicated to
21 you by anyone at Victorian Gardens
22 that you had been discharged?

23 A. Yeah. Yes.

24 Q. Was that part of the reason
25 you left, were you fired?

1 A. No, I wasn't fired. I think
2 it was a mutual agreement because we
3 had some difficulties. I don't know
4 what the difficulties --- I don't
5 know. Whether it was working
6 together or communicating.

7 Q. So it's your testimony that
8 you were not fired from that job,
9 that you left of your own accord? Is
10 that fair?

11 A. It was mutual.

12 Q. I'm just going to hand you
13 ---. I'm going to mark this Buchanan
14 One and ask you to take a look at
15 that, please, for me. You want to
16 read through it?

17 (Buchanan One marked
18 for identification.)

19 WITNESS COMPLIES

20 BY ATTORNEY OLIVER:

21 Q. And I represent to you that
22 that was provided to me by Victorian
23 Gardens along with their file.

24 A. That's everything I had to do.

25 Q. I would ask you, on the top of

1 that, it indicates that it's a list
2 of job duties; right? Go ahead and
3 take a look.

4 A. Job description, yeah.

5 Q. And you just stated it was
6 everything you had to do. Let me
7 just ask the question so we're clear.
8 Does that list accurately describe
9 your job duties for Victorian
10 Gardens?

11 A. Yeah, 95 percent of it.

12 Q. You think there were more
13 duties than that?

14 A. Yeah.

15 Q. Why don't you tell me what
16 those were?

17 A. Well, I mean, you know, the
18 responsibility of taking care of the
19 residents. Making sure, you know,
20 that everything was done properly.
21 That's about it.

22 Q. What kind of hours did you
23 work for Victorian Gardens?

24 A. When I first was employed
25 there, I worked 7:00 to 3:30.

- 1 Q. 7:00 a.m.?
- 2 A. Yes, ma'am.
- 3 Q. And how long did that go on?
- 4 A. I would say about nine months
- 5 to a year. I can't pinpoint the
- 6 actual time. And then I was moved to
- 7 the midnight shift. I volunteered to
- 8 go to the midnight shift.
- 9 Q. And what would the midnight
- 10 shift hours be?
- 11 A. 12:00 to 8:30.
- 12 Q. 12:00 a.m. to 8:30 a.m.?
- 13 A. Yes.
- 14 Q. And was that, then, until you
- 15 left in January 2002?
- 16 A. Uh-huh (yes). I switched off
- 17 and on.
- 18 Q. Any reason that you switched
- 19 off and on? I mean was that ---?
- 20 A. If they needed me to.
- 21 Q. How many days a week was that
- 22 work?
- 23 A. Six. Five, six, seven. It
- 24 just depended.
- 25 Q. I'm going to hand you

1 something that's two pages I've
2 marked as Buchanan Two. And I'll ask
3 if you can identify that for me,
4 please?

5 (Buchanan Two marked
6 for identification.)

7 BY ATTORNEY OLIVER:

8 Q. And for the record I'll
9 represent to you that that too came
10 from Victorian Gardens' file.

11 A. Okay.

12 Q. Did you have a chance to look
13 that over?

14 A. Yes.

15 Q. And do you recognize that
16 document?

17 A. An application for employment.

18 Q. Is that something you've seen
19 before?

20 A. I haven't seen it for awhile,
21 but yes.

22 Q. And is that your handwriting
23 that appears on the application?

24 A. Yes, it is.

25 Q. And it's two pages. On page

1 two, is that your signature at the
2 bottom?

3 A. Uh-huh (yes).

4 Q. And the date beside it
5 9/10/99. Do you believe that that is
6 when you would have filled that out
7 and signed it?

8 A. Yes.

9 Q. At the time that you worked at
10 Victorian Gardens, that approximately
11 three year period, did you work
12 anywhere else at the same time?

13 A. Amguard Security.

14 Q. Anywhere else?

15 A. No. Prior to this or ---?

16 Q. No, at the same time. I don't
17 want you to focus on the application
18 anymore unless there's something on
19 there that jogs your memory. But
20 what I'm asking is during that time
21 frame that you said you worked at
22 Victorian Gardens, did you hold any
23 other jobs at the same time for any
24 of that period?

25 A. Yes.

- 1 Q. And where?
- 2 A. At Sandy's Cleaning Service.
- 3 Q. And when did you work at
- 4 Sandy's Cleaning Service?
- 5 A. The last couple of months.
- 6 Q. The last couple of months that
- 7 you were at Victorian Gardens?
- 8 A. Yes.
- 9 Q. So end of 2001, beginning of
- 10 2002?
- 11 A. Yes.
- 12 Q. How many hours did you work at
- 13 Sandy's Cleaning Service?
- 14 A. Just part-time. Maybe 15.
- 15 Q. Fifteen (15) hours a week?
- 16 A. Yeah. And that too of course
- 17 depended on the work.
- 18 Q. So you're saying you did not
- 19 have a set schedule there?
- 20 A. No. I mean I had to be there
- 21 --- I had to report to work or to her
- 22 when I got off work at Victorian
- 23 Gardens, but I could work until
- 24 11:00, I could work until 1:00, I
- 25 could work until ---.

1 Q. So you'd go from working the
2 night shift at Victorian Gardens and
3 then you'd report to Sandy's Cleaning
4 Service, stay for a few hours and
5 then go home? Is that what your day
6 was like?

7 A. Yeah.

8 Q. First of all, where is Sandy's
9 Cleaning Service?

10 A. In Indiana.

11 Q. And is that a corporation or
12 is that one person that kind of runs
13 something from her home?

14 A. Runs something from her home.

15 Q. Do you know what her address
16 is?

17 A. No.

18 Q. And what was your employer's
19 name, full name?

20 A. Sandy.

21 Q. And her last name, please?

22 A. Vulseski (phonetic).

23 Q. And why did you stop working
24 there?

25 A. Because I got the job I'm

1 doing now.

2 Q. Do you think that you worked
3 at Sandy's Cleaning Service up
4 through April of 2002?

5 A. I didn't work there the last
6 --- I would say through March.

7 Q. What were your duties for
8 Sandy's Cleaning Service

9 A. Cleaning.

10 Q. What kind of cleaning?

11 A. House.

12 Q. House cleaning, residences?

13 A. Uh-huh (yes).

14 Q. How many houses do you think
15 you'd clean a day?

16 A. I don't know, it depended.
17 Two maybe. It could be more.

18 Q. So you'd do things like you'd
19 vacuum, you'd mop, those kind of
20 duties?

21 A. Just did windows.

22 Q. Did you have any difficulty
23 with that? I mean, anything you
24 couldn't do because of physical
25 limitations in that house cleaning

1 job?

2 A. I couldn't lift, you know, I
3 couldn't move any furniture that
4 needed to be moved. I had a hard
5 time with the bending over aspect of
6 dusting, you know, without sitting
7 back up real quick, you know, and
8 taking a break.

9 Q. Was that a problem for you in
10 that job? I mean did it prevent you
11 from doing anything you were supposed
12 to be doing?

13 A. No.

14 Q. And those problems you said,
15 bending, lifting, was that something
16 that you think is --- that you're
17 claiming is related to the September
18 1999 accident?

19 A. Yes.

20 Q. Now, you've mentioned Sandy's
21 Cleaning. Were there any other jobs
22 that you had at the same time that
23 you worked at Victorian Gardens?

24 A. No.

25 Q. What about Amguard?

1 A. That was just right at the
2 beginning.

3 Q. You worked at both places
4 right at the beginning?

5 A. Yes.

6 Q. How long do you think that
7 was? A couple of weeks, a month?

8 A. Yeah, a couple of weeks.

9 Q. Now, you were working the day
10 shift at that point for Victorian
11 Gardens. So were you working Amguard
12 at night?

13 A. Uh-huh (yes).

14 Q. And what kind of hours were
15 you working there?

16 A. I would leave one and go right
17 to the other. They gave me leeway to
18 get there. It was like 4:00 to
19 12:00.

20 Q. So there were a couple of
21 weeks there that you worked double
22 shift, so to speak; right?

23 A. Not every day, but yes.

24 Q. How many days a week do you
25 think you did that?

1 A. Three to four.

2 Q. And what made you apply for
3 the job at Victorian Gardens?

4 A. Money. I needed to get
5 another job to be able to pay the
6 bills, so I did. I applied there.

7 Q. Can you elaborate on that?
8 Did Amguard not pay you enough or
9 were the hours not enough?

10 A. Yeah, the hours were enough, I
11 just needed something to supplement.

12 Q. To supplement what?

13 A. Just to supplement the money.

14 Q. To supplement the money from
15 Amguard?

16 A. Yes.

17 Q. Were you under the impression
18 at the time that you applied for the
19 job at Victorian Gardens that the
20 Amguard employment was going to end
21 for some reason?

22 A. No.

23 Q. And referring back to Buchanan
24 Two again. Can you tell me --- under
25 the former employer section here, you

1 have Amguard listed. And then
2 there's a reason, you have position,
3 security, and you see the reason for
4 leaving column? I just can't read
5 what that says. Can you tell me what
6 you've written under there?
7 A. Seasonal hire.
8 Q. What does that mean?
9 A. Well, there's more of the
10 seasons of the year that I work more
11 than others (sic).
12 Q. At Amguard?
13 A. Yes.
14 Q. So did you think the job was
15 ending then?
16 A. No. I just needed to be able
17 to pay my bills.
18 Q. Did you anticipate that there
19 was going to be less work for some
20 period coming up, though?
21 A. No.
22 Q. Why did you write seasonal
23 hire there?
24 A. Because during --- at this
25 working period, the work was there,

1 the hours were there. Now, four
2 months down the road it wouldn't be
3 as much. But at that point in time I
4 was not worried about it not being
5 ---.

6 Q. So when you sought the job at
7 Victorian Gardens, then, is it fair
8 to say that that wasn't because of
9 injuries that you relate to this
10 accident, it was more because of a
11 concern for supplementing your
12 income?

13 A. I wouldn't say that.

14 Q. Okay. Why don't you explain
15 what's not right about that to me,
16 please?

17 A. Well, at the time I was
18 looking for the job to supplement the
19 money, like I said. And as I
20 continued to do the job at Amguard,
21 the continual sitting at the desk,
22 the hard, you know, --- my job was in
23 a cold area, I sat at a hard desk.
24 It became increasingly harder to be
25 able to do that job at that position.

1 Q. But did you know that when you
2 applied for this job in September of
3 '99?

4 A. Know what?

5 Q. All these things that you just
6 told me. That it became hard to do
7 the position. When did this become a
8 concern of yours?

9 A. The very day I started back to
10 work.

11 Q. So it was an immediate
12 concern?

13 ATTORNEY TOMB:

14 Answer the question.

15 A. Yes. I'm sorry.

16 BY ATTORNEY OLIVER:

17 Q. How many days were you off of
18 work because of this accident? Any?
19 This happened on Monday, September
20 6th. Do you think you went to work
21 on Tuesday?

22 A. No.

23 Q. Did you actually miss days of
24 work where you had to call off and
25 say I can't come because I've been in

1 an accident?

2 A. Uh-huh (yes).

3 Q. How many days was that?

4 A. At least three, two or three.

5 I don't remember.

6 Q. You're looking around. Is

7 there something you can look at that

8 would help you to determine that?

9 A. No, I just didn't know ---.

10 No, I don't remember.

11 Q. Do you have any documentation

12 to prove that you were out those

13 days?

14 A. I don't have any personally,

15 no.

16 Q. But in any event, you think

17 two or three days would have been it?

18 A. Yeah, because I could not

19 afford to not go back to work.

20 Q. In fact, it looks like about

21 four days later you applied for a

22 second job right?

23 A. Uh-huh (yes).

24 Q. And just to be clear, when you

25 applied for that second job you, at

1 that point, thought that your duties
2 at Amguard would be continuing just
3 on a seasonal basis; right?

4 A. Yeah.

5 Q. Now, I thought somewhere along
6 the line that you, or through your
7 attorney, had represented that you
8 had been laid off from your job at
9 Amguard. Is that not accurate, or
10 were you laid off?

11 A. Laid off?

12 Q. Yes.

13 A. Now?

14 Q. From Amguard.

15 A. Well no, because I was told if
16 I could not do my job I would be laid
17 off.

18 Q. Let me back up a little bit.
19 When did you start working at
20 Amguard?

21 A. Off and on from '97.

22 Q. Sometime in '97?

23 A. March of '97, if I'm not
24 mistaken.

25 Q. And when did you stop working

1 there?

2 A. Shortly after I got this job.

3 Q. Shortly after the Victorian
4 Gardens job?

5 A. Yeah.

6 Q. And through the time from when
7 you started to when you stopped, were
8 your duties for Amguard pretty much
9 the same?

10 A. Yes.

11 Q. And would you describe those
12 for me, please?

13 A. Sat at a desk and made, you
14 know, --- controlled the people going
15 in and out of the gate.

16 Q. A gate for what?

17 A. A guard shack for the power
18 plant.

19 Q. And it was outside?

20 A. Yes.

21 Q. In one of those little booth
22 type things?

23 A. Uh-huh (yes).

24 Q. And what was the actual
25 location where you worked?

- 1 A. There was three.
- 2 Q. And where were they?
- 3 A. Keystone, Conemaugh and Homer
- 4 City.
- 5 Q. Keystone, Conemaugh and where?
- 6 A. Homer City.
- 7 Q. Can you spell the first part
- 8 of that, please?
- 9 A. Homer?
- 10 Q. Yes, H-O-M-E-R?
- 11 A. Yes.
- 12 Q. Any particular location that
- 13 you were assigned to or did you
- 14 regularly circulate between them?
- 15 A. No, I circulated between all
- 16 three.
- 17 Q. And you told me that --- you
- 18 said something about working for
- 19 Amguard on and off over that period
- 20 of time. What did you mean by that?
- 21 A. If the work was slow at a
- 22 particular plant, I was off for a
- 23 couple of weeks.
- 24 Q. Was it ever more than a couple
- 25 of weeks?

1 A. Sometimes it was like a month
2 and a half. Two months was the
3 longest.

4 Q. In 1998, did you have any
5 other jobs other than Amguard?

6 A. I worked at Kaufmann's.

7 Q. Was that in '98?

8 A. '98, I don't --- that was in
9 '99. In '98, no. I think I worked
10 at Emerson Square.

11 Q. And that was as a nurse's
12 aide; right?

13 A. Yeah.

14 Q. Same kind of duties that you
15 did at Victorian Gardens?

16 A. Uh-huh (yes).

17 Q. During the time that you
18 worked at Amguard, was it typical for
19 you to have a second job at the same
20 time?

21 A. No, not really because my
22 fiancé kind of helped me with money.

23 Q. What does he do?

24 A. He's a truck driver.

25 Q. Can you tell me for the year

1 1999, before this accident, how many
2 months --- or how much time do you
3 think you were not working for
4 Amguard because of the seasonal
5 nature of this business?

6 A. I can't be sure.

7 Q. Do you think if we looked at
8 your tax returns we could get an idea
9 of that?

10 A. Yes, probably. I'm sorry.

11 Q. Other than the Amguard job,
12 had you ever worked in security
13 before?

14 A. No.

15 Q. And you had had jobs with
16 bookkeeping duties before that?

17 A. Yes.

18 Q. I don't know if you can do
19 this or not, but is it possible for
20 you to tell me, --- if somebody asked
21 you to kind of sum up your work
22 history and what, you know, what the
23 nature of your work was, could you do
24 that or is it so varied that you
25 couldn't even tell me?

1 A. Up to this point?

2 Q. Up to the point of the
3 accident.

4 A. Retail, I worked in retail.
5 Retail management.

6 Q. That pretty well summarizes
7 your work history in your mind?

8 A. Uh-huh (yes).

9 Q. When you say retail
10 management, were you a sales clerk?

11 A. I was a sales clerk and I was
12 a manager.

13 Q. Stores like Kaufmann's?

14 A. I was a sales clerk at
15 Kaufmann's.

16 Q. How many stores did you
17 actually have a manager position?

18 A. One. No, two. I'm sorry,
19 two.

20 Q. At Amguard, who was your
21 immediate supervisor?

22 A. Whoever was on guard duty at
23 the power plant at the time. I
24 didn't, you know, have an immediate
25 there.

1 Q. So there's no name that you
2 can give me?

3 A. Not that I can remember, no.
4 Because they were --- each shift was
5 a different person that I didn't
6 know, you know, that well.

7 Q. Do you know Dave Dunkin? Does
8 that name sound familiar to you?

9 A. No, that doesn't.

10 Q. And I'm sorry if I've asked
11 you this, but can you --- what kind
12 of hours did you work in a typical
13 day for Amguard?

14 A. Anywhere from 8 to 12,
15 sometimes 16. If someone didn't show
16 up, you had to stay.

17 Q. And was that generally the
18 night shift?

19 A. Yes.

20 Q. You haven't worked there since
21 shortly after this accident, the
22 September '99 accident, is that your
23 testimony?

24 A. Uh-huh (yes).

25 Q. And why did you stop working

1 there, at Amguard?

2 A. I couldn't sit for the long
3 periods of time. I couldn't sit,
4 it'd be cold, you know, in the cold
5 area where I was at without having a
6 headache or a backache or being
7 uncomfortable. You couldn't leave
8 your position, you had to stay there.
9 You couldn't get up, you know, you
10 could get up and move around for like
11 two minutes but, you know, you had to
12 be in the secure area at all times.
13 And they didn't supply you with a
14 lavish chair to sit in. They just
15 gave you a hard chair.

16 Q. So it's your testimony that
17 you left fully of your own accord for
18 those reasons?

19 A. Yes.

20 Q. And were you laid off from
21 Amguard?

22 A. No.

23 Q. And had you not had this
24 accident, do you think you'd still be
25 working at Amguard today?

1 A. Yeah, I think. My original
2 plans were to go take a course and
3 get my Act 357 so that I would be
4 able to be increased wage-wise. That
5 was my original plan.

6 Q. What's Act 357?

7 A. Where you're allowed to carry
8 firearms.

9 Q. Did you ever do that, take
10 that course?

11 A. No, I never did.

12 Q. Do you only have that one job
13 now?

14 A. Yes.

15 Q. Now, it's my understanding you
16 were making a wage loss claim in this
17 case; is that right?

18 A. Yes.

19 Q. And how much money do you
20 claim that you've lost? Can you tell
21 me that?

22 A. I can't tell you that.

23 Q. Is it your contention that you
24 still have a continuing wage loss
25 claim or is it just a discreet period

1 of time that we're talking about?

2 A. It's just a discreet period of
3 time.

4 Q. And what is that period of
5 time?

6 A. Until, I would say, April when
7 I started this job.

8 Q. April of 2002?

9 A. Uh-huh (yes).

10 Q. Beginning when? Right at the
11 day of the accident or sometime after
12 that?

13 A. Sometime after that.

14 Q. So your wage loss claim ends
15 in April of 2002 and you began your
16 current job?

17 A. Yes.

18 Q. And I want to ask you to think
19 for a few minutes and tell me if you
20 can say or connect it to some event
21 of when it began?

22 A. Well, it began, I would say,
23 whenever I couldn't properly do my,
24 you know, the ability to do my job at
25 Amguard. And I tried it, you know,

1 to handle both, but I just couldn't
2 do the sitting aspect of it.

3 Q. Did you ever file a claim for
4 wage loss benefits with your own
5 insurance, under your own insurance
6 policy?

7 A. No.

8 Q. You did not?

9 A. I don't think.

10 Q. Are you aware of whether or
11 not you have wage loss benefits under
12 your own insurance policy?

13 A. No.

14 Q. You just don't know that one
15 way or the other; is that right?

16 A. No. I don't know if I have it
17 or not. It was never specified to
18 me.

19 Q. By who, by your insurance
20 company?

21 A. Yeah.

22 Q. I'm not going to make a copy
23 of this unless anybody wants to. I'm
24 going to point your attention to one
25 of the documents that I received when

1 I subpoenaed your insurance company.
2 And it looks like an application to
3 me. It's not signed. I just want to
4 ask you if you recognize the
5 handwriting on that application?

6 A. Yes, I recognize the writing.

7 Q. And who's is it?

8 A. That's mine.

9 Q. So you filled out that
10 application?

11 A. Yeah. Anything the insurance
12 company sent me I filled it out. I
13 don't know ---. What was that for?

14 Q. All I can say is that they
15 were documents provided to me by your
16 insurance company. Now, how was it
17 that you learned the Victorian
18 Gardens position?

19 A. I think it was in an ad in the
20 paper.

21 Q. While you were working there,
22 did you ever look for employment at
23 any places that might have paid more?

24 A. Yes.

25 Q. Did you interview anyplace

- 1 else?
- 2 A. At Indian Haven Nursing Home.
- 3 Q. Anyplace else?
- 4 A. Not that I recollect.
- 5 Q. Did you fill out an
- 6 application there?
- 7 A. Yes, I did.
- 8 Q. And you just didn't get that
- 9 job, or what happened with that?
- 10 A. I didn't have the
- 11 qualifications, I didn't have the
- 12 certification that I needed.
- 13 Q. You don't have any special
- 14 training in security or to be a
- 15 security guard, do you?
- 16 A. No.
- 17 Q. And was Amguard your only
- 18 experience in that field?
- 19 A. Yes.
- 20 Q. Do you keep a diary?
- 21 A. No.
- 22 Q. Did you keep a diary at the
- 23 time of this accident?
- 24 A. No.
- 25 Q. What about between the

1 accident and today?

2 A. No.

3 Q. Have you kept a diary in that
4 time?

5 A. No.

6 Q. Have you, to your
7 recollection, given any statements
8 about how this accident occurred?
9 And by this, I mean the September '99
10 accident. And I don't want to know
11 about discussions you may have had
12 with your attorney.

13 A. Other than the insurance
14 company, State Farm itself?

15 Q. Yes.

16 A. No, I have not given anything
17 to anyone.

18 Q. And do you recall giving a
19 statement to State Farm Insurance
20 Company that was recorded?

21 A. I don't remember that, but I
22 think ---. Yes, I think.

23 Q. You think that that occurred?

24 A. Yeah, I think. I can't be
25 sure.

1 Q. Have you ever seen a copy of a
2 statement that was attributed to you?
3 You know, a transcribed ---

4 A. No.

5 Q. --- paper of that recording?

6 A. Not to my recollection. I
7 don't ---.

8 Q. Do you have any photographs
9 showing either the location of this
10 accident or your vehicle? Anything
11 like that?

12 A. No, I don't.

13 Q. Have you ever had any
14 photographs like that?

15 A. No.

16 Q. How about any pictures
17 showing, you know, what you contend
18 are injuries relating to this
19 accident?

20 A. I don't have any photos of
21 anything.

22 Q. No vehicle photos?

23 A. No. The guy who fixed my car
24 may have, but I don't have any.

25 Q. And as far as witnesses to

1 this accident ---. I know that you
2 were obviously were involved, Justine
3 Toombs. Jeff Williams was in your
4 car; right?

5 A. Yes.

6 Q. And there was also an occupant
7 in Ms. Toombs' car?

8 A. Right.

9 Q. Were there any other witnesses
10 to the accident that you're aware of?

11 A. Not that I'm aware of.

12 Q. And since this accident
13 occurred, have you had any contact
14 with Justine Toombs?

15 A. No.

16 Q. And how about with her
17 brother?

18 A. No.

19 Q. Do you have a current driver's
20 license?

21 A. Yes.

22 Q. Is it a Pennsylvania license?

23 A. Yes.

24 Q. Did you have a valid license
25 at the time of the accident?

- 1 A. Yes, I did.
- 2 Q. And that was a Pennsylvania
- 3 license?
- 4 A. Yes, ma'am.
- 5 Q. Has your license ever been
- 6 suspended?
- 7 A. No.
- 8 Q. How about revoked?
- 9 A. No.
- 10 Q. Do you have any restrictions
- 11 on your license?
- 12 A. No.
- 13 Q. Is wearing glasses a condition
- 14 of your license?
- 15 A. No.
- 16 Q. You have glasses on today, I
- 17 see?
- 18 A. Yeah.
- 19 Q. What's that for?
- 20 A. I only use them for like
- 21 computer glasses. Like to do, you
- 22 know, computer work, but it's such a
- 23 habit to put them on in the morning
- 24 that I just automatically put them
- 25 on.

1 Q. Were you wearing them at the
2 time of the September '99 accident?

3 A. No, I didn't develop this
4 until I started working closely with
5 the computer every day.

6 Q. So you didn't wear glasses at
7 all in September of '99; is that
8 accurate?

9 A. I wore them for like just the
10 same as --- just like needlework, you
11 know, like to sew. But nothing that
12 required me to have them for reading
13 or anything like that.

14 Q. Have you ever served in the
15 military?

16 A. No.

17 Q. And have you ever been
18 arrested?

19 A. No.

20 Q. I'm sorry. No?

21 A. No.

22 Q. I guess it would follow that
23 you've never been convicted for a
24 crime; is that right?

25 A. Right.

1 Q. Do you need to take a break?

2 A. I'm all right. If you don't
3 mind me standing up for a few
4 minutes.

5 Q. That's fine. Do you know if
6 you've ever been the subject of a
7 criminal investigation at all, that
8 you're aware of?

9 A. They did like a criminal
10 background check when I became
11 employed with the security company.
12 Other than that, I had to have one
13 also when I became working at the
14 nursing home to see if I like had a
15 criminal past with children or
16 elderly, you know, to see if I would
17 be --- to work with, you know, the
18 elderly people. Other than that, no,
19 I don't know of anybody investigating
20 that ---.

21 Q. And you're not aware of ---?
22 I'm sorry, go ahead.

23 A. All right. Go ahead.

24 Q. You're not aware of the police
25 ever investigating you or accusing

1 you of committing a crime?

2 A. Yeah, I'm aware of that.

3 Q. And can you tell me about
4 that?

5 A. I used a girlfriend's credit
6 card to buy my fiancé a gun which, in
7 fact, it wasn't hers. I did not know
8 that, I was not aware of that. I had
9 another attorney and went to --- was
10 put on the ARD program.

11 Q. For that use of the credit
12 card?

13 A. Yes. And I had to do --- I
14 didn't have a record or anything like
15 that, but that's what that was for.

16 Q. Were you charged then with a
17 crime? Were you charged with theft
18 by deception?

19 A. I don't think so because --- I
20 don't know.

21 Q. Have you ever pled guilty to a
22 criminal charge?

23 A. I don't think.

24 Q. When was that incident with
25 the credit card?

1 A. '98 I think.

2 Q. Was that only one time?

3 A. Oh, yeah.

4 Q. And was that the only time
5 you've ever been arrested or ---

6 A. Yes.

7 Q. --- or the subject of a
8 criminal investigation?

9 A. Yes.

10 Q. No driving incidents or
11 anything like that?

12 A. No.

13 Q. Have you ever given testimony
14 before, either as a party or a
15 witness in a legal proceeding?

16 A. No.

17 Q. Have you ever brought a claim
18 for personal injuries before?
19 Whether or not it was a lawsuit, just
20 a claim that somebody should give you
21 money because of an injury?

22 A. No.

23 Q. Have you ever brought a
24 Workers' Compensation claim before?

25 A. No.

1 Q. Are you certain of that?

2 A. Well, I don't understand what
3 you mean by brought a claim.

4 Q. Have you ever sought money
5 through the Workers' Compensation
6 system claiming you were injured on
7 your job?

8 A. No.

9 Q. Before the accident in October
10 of 1999, had you ever been in a car
11 accident before?

12 A. No.

13 Q. No other car accidents?

14 A. No other car accidents.

15 Q. How about after it? Any other
16 car accidents after the '99?

17 A. No.

18 Q. Have you ever brought a claim
19 for Social Security disability, any
20 kind of benefits like that?

21 A. No.

22 Q. I want to broaden it from car
23 accidents. Let's say going back to
24 1995. Since 1995 and up to September
25 of 1999, let's take that window. Did

1 you have any accidents that caused
2 you injury?

3 A. I had one accident when I
4 worked at Emerson Square Personal
5 Care Home.

6 Q. And when was this?

7 A. I don't know. I can't
8 remember the date.

9 Q. Can you give me a year or you
10 just can't even do that?

11 A. I would say late '95, early
12 '96.

13 Q. And why don't you describe for
14 me what occurred?

15 A. I was giving a gentleman a
16 shower who was 270 pounds, if not
17 more. I was trying to move him from
18 his wheelchair to the shower stall
19 and he decided he didn't want to
20 stand up anymore and he just like
21 dropped himself. And in that time I
22 went to catch him, and when I did I
23 pulled a muscle in my back at the
24 time.

25 Q. And so you were injured during

1 that incident?

2 A. I went to the chiropractor
3 care and was put on light duty.

4 Q. You seemed to hesitate when I
5 asked if you were injured. Are you
6 ---?

7 A. Well, I don't know if you want
8 to call a --- you know, a muscle,
9 like a pulled muscle, I guess that's
10 an injury.

11 Q. So your answer is yes you were
12 injured or you don't know or ---?

13 A. I don't know.

14 Q. And how long did you have
15 treatment for that injury or that
16 muscle pull?

17 A. Less than two weeks.

18 Q. Did you see anybody other than
19 a chiropractor after that incident?

20 A. No.

21 Q. Only the chiropractor. And
22 you think about two weeks of care?

23 A. Yes.

24 Q. And what was bothering you,
25 exactly, then? Do you remember?

1 A. It was just like something was
2 out of place. I had to readjust it a
3 couple of times. He had put me onto
4 a restriction of light duty until,
5 you know, everything got back to
6 normal or until I felt comfortable
7 with it.

8 Q. And it's your testimony that
9 everything did get back to normal?

10 A. Yes.

11 Q. Just kind of on its own?

12 A. With not lifting 200 pound men
13 for a couple of weeks, but yes it
14 did. I went right back to normal.

15 Q. After a couple of weeks you
16 think?

17 A. Yeah, I would say, give or
18 take.

19 Q. Who was the chiropractor that
20 you saw for that?

21 A. Doctor Bouma.

22 Q. And he's the same chiropractor
23 that you saw after the September '99
24 accident; right?

25 A. Yes.

1 Q. Have you ever been to see
2 another chiropractor other than
3 Doctor Bouma?

4 A. No, I don't ---. No, wait,
5 I'm sorry. Doctor --- I forget his
6 name. Me and my ex-husband went
7 there one time just to get adjusted,
8 it was just the thing to do then I
9 guess. But it wasn't --- I didn't --
10 -. I don't remember his name.

11 Q. Do you know where the practice
12 was?

13 A. It's right on Philadelphia
14 Street, I think.

15 Q. Is that in Indiana?

16 A. Yes.

17 Q. It's your testimony that was
18 just one time?

19 A. Yeah, I think it was just one.
20 Because he went back more than I did,
21 but it was just once.

22 Q. Do you have any idea, you
23 know, approximately what year that
24 was?

25 A. No. To be honest, I don't. I

1 don't remember.

2 Q. Now, you've identified one
3 other accident between 1995 and the
4 September '99 car accident. Were
5 there any other incidents during that
6 time period where you were injured
7 and sought medical treatment?

8 A. I had one incident at the
9 nursing home, at Victorian Gardens,
10 where there again I fell in the
11 shower. I don't know if I just
12 stoved it, like my wrist.

13 Q. That would have had to be
14 after this September '99 accident
15 though; right?

16 A. Yes.

17 Q. I want to focus on that window
18 between 1995 and September of '99.
19 We have the car accident, and we have
20 the one that you just told me about
21 at the first nursing home. Were
22 there any other injuries you had? No
23 slip and falls?

24 A. No.

25 Q. Assaults?

1 A. No.

2 Q. Nothing like that at all?

3 A. Not that I can recollect, no.
4 Nothing.

5 Q. When you had that slip and
6 fall before in the shower with that
7 200-something pound man, I think you
8 identified that as late '95, early
9 '96. Did you go to the hospital
10 after that?

11 A. I went through the
12 administrative procedures where at
13 that time I felt I just had pulled
14 something and I just needed to get
15 adjusted. So I went with one of
16 their Workmen's Compensation approved
17 chiropractors at that time, and
18 that's who was on their list.

19 Q. So you did not go to a
20 hospital emergency room; is that
21 right?

22 A. No.

23 Q. Now, I want you to describe
24 for me the injuries that you feel you
25 sustained in this accident, what your

1 symptoms have been. Again the
2 September '99 accident. Sorry.

3 A. The injuries that I had
4 sustained at the accident?

5 Q. Yes. We're here about an
6 accident of September 6th, 1999;
7 right?

8 A. Okay, yeah.

9 Q. And what I want you to do for
10 me, if you can, is to just tell me
11 what you think your injuries were.

12 A. I had severe headaches, a lot
13 of neck pain, low back pain, I had a
14 lot of numbness in my legs. I can't
15 sit for very long without, you know,
16 getting uncomfortable or numb, or
17 riding in a car for 15, 20 minutes my
18 back is already starting to become
19 numb. I never had that before. Just
20 --- sleeping at night.

21 Q. What about sleeping?

22 A. It's hard to sleep because if
23 I lay on my --- either one of my
24 sides they go numb, so I have to
25 continue --- I have to toss and turn

1 around and to get comfortable.
2 Because, you know, because it's going
3 numb I never had that before. I
4 can't ride on my fiancé's motorcycle
5 like 15 miles without my back and my
6 legs going numb, you know, that was
7 ---. I had a lot of muscle spasms at
8 the time also, they have subsided.

9 Q. Anything else?

10 A. No.

11 Q. Are there any of those things
12 that you just told me about that you
13 still experience today?

14 A. Yes.

15 Q. And why don't you tell me what
16 symptoms that you still have today
17 that you relate to the accident?

18 A. Each and every one of them.

19 Q. All of those continue?

20 A. Yes.

21 Q. Now, you told me that the
22 muscle spasms though have subsided?

23 A. Yes, they have subsided. I
24 don't have to rely on any, you know,
25 medication. Just the Tylenol here

1 and there. But as far as the
2 numbness, the backaches, they still
3 --- everything ---.

4 Q. Is it any different than it
5 was a week after the accident? Have
6 those symptoms improved at all or do
7 you think they're the same?

8 A. Well, they have improved. The
9 headaches have improved greatly, you
10 know, they used to be all the time.
11 And now their just ---. You know
12 what I mean? They're not like they
13 used to be, you know.

14 Q. How often do you have
15 headaches now?

16 A. I think the headache part has
17 --- once a week maybe, not even that.

18 Q. And you think those headaches
19 are related to the accident of
20 September '99?

21 A. I don't know that to be true.
22 I don't know.

23 Q. You said there was a period
24 when they were all the time. When do
25 you think that was?

1 A. The first --- I had them clean
2 up until six, eight months after, you
3 know, continual --- I just had a
4 headache all the time.

5 Q. For about six to eight months?

6 A. I can't --- yeah. It's hard
7 to say because at the time when I
8 didn't pay attention to the time.

9 Q. You just kind of carried on as
10 usual?

11 A. Yeah, I had to.

12 Q. So you carried on with your
13 daily routine; is that right?

14 A. Yeah.

15 Q. Now, I want you to list for me
16 all the doctors that you went to see
17 for injuries you relate to this
18 accident, the September '99 accident?

19 A. I went to see Doctor Jesick.

20 Q. Is Doctor Jesick your family
21 doctor then?

22 A. Yes.

23 Q. Did you have any other doctor
24 you went to regularly at that time?

25 A. That's her. She's my doctor.

- 1 Q. How long has she been your
2 family doctor?
- 3 A. I can't say. She's been ---
4 ten years. It could be eight, but
5 ten years.
- 6 Q. So Doctor Jesick. Who else?
- 7 A. Doctor Bouma.
- 8 Q. That's the chiropractor;
9 right?
- 10 A. Yes. And Doctor Jesick sent
11 me to see a doctor in Pittsburgh, but
12 I don't remember his name.
- 13 Q. Is that Doctor Wecht or El
14 Kadi?
- 15 A. I don't know.
- 16 Q. A neurosurgeon?
- 17 A. Yes.
- 18 Q. How many times did you see
19 that doctor?
- 20 A. I only saw that doctor once.
- 21 Q. Any other doctors?
- 22 A. I don't think so. I think
23 that's it.
- 24 Q. And you went to the hospital,
25 too; right?

- 1 A. Yes, the day of the accident.
- 2 Q. Is that Clearfield County?
- 3 A. No.
- 4 Q. I'm sorry. Where did you go?
- 5 A. Indiana County.
- 6 Q. Indiana. I'm sorry.
- 7 A. Whatever that doctor's name
- 8 was, but I could not --- I don't
- 9 know.
- 10 Q. And you went and you were
- 11 treated and released that same day;
- 12 right?
- 13 A. Yes.
- 14 Q. Did they give you any
- 15 medicines, do you remember what they
- 16 did for you there?
- 17 A. They gave me Vicodin, Flexeril
- 18 and something else, but I forget the
- 19 name of it. It was for like the
- 20 headaches and the muscle spasms. I
- 21 don't remember. If there was a name,
- 22 I don't remember.
- 23 Q. How did you get to the
- 24 hospital? Did you drive yourself
- 25 there?

1 A. No, the tow truck driver
2 dropped me off.

3 Q. You didn't go by ambulance?

4 A. No.

5 Q. Did Jeff Williams go with you?

6 A. I don't remember if he did or
7 not.

8 Q. But when you went to the
9 hospital you didn't need any
10 stitches, you weren't cut; right? No
11 bleeding?

12 A. No.

13 Q. You were able to walk; right?

14 A. Yes.

15 Q. You didn't have any broken,
16 bones?

17 A. No.

18 Q. Did you have any visible
19 bruises or anything?

20 A. I had some on my side here.

21 Q. On your left side?

22 A. My left side and then up my
23 arm, but they weren't from --- they
24 were from hitting the side of the
25 door.

1 Q. And when is the last time you
2 went to see a medical person, and
3 that includes a chiropractor or
4 physical therapy or anything like
5 that, for these injuries?

6 A. The last person I seen for the
7 injuries was Doctor Bouma, but I
8 can't be sure of the exact date. It
9 was just ---. I would say it's been
10 a year.

11 Q. And I'm just going to
12 represent that I got records from
13 Doctor Bouma and it looked like to me
14 that you went to see him shortly
15 after the accident. You went for
16 about two months.

17 A. Uh-huh (yes).

18 Q. And then you stopped for a
19 year and a half?

20 A. Uh-huh (yes).

21 Q. And then you went back for a
22 little while. Does that sound right?

23 A. Yes.

24 Q. Why did you stop?

25 A. Because I didn't have the

1 money to pay for the visits and the
2 insurance company wasn't going to pay
3 for them.

4 Q. Who told the insurance company
5 wasn't going to pay for them?

6 A. I found out the second I
7 received the letter and it said or
8 Doctor Bouma's office received a
9 letter or something to that aspect
10 that it wasn't being covered anymore.
11 So I just didn't go anymore.

12 Q. If you received a letter like
13 that, is that something you would
14 still have?

15 A. I didn't receive that. I'm
16 saying --- I don't know if the doctor
17 received a letter or ---. I think if
18 I had received a letter I would have
19 given it to Myron, but I don't ---
20 because I was told by the doctor's
21 office that they were no longer going
22 to pay that and I wasn't going to,
23 you know, be able to go.

24 Q. And we're talking about in
25 1999; right? I just want to focus on

1 ---. You're sure though that that's
2 the reason you stopped having
3 treatment is that the doctor's office
4 told you the insurance company
5 wouldn't pay for it anymore?

6 A. Right.

7 Q. Did you make any follow up
8 calls, call the insurance company,
9 ask what was going on?

10 A. I called Myron's office and I
11 called Doctor Bouma's office back to
12 make sure of what was, you know,
13 going on. And that's the way, you
14 know, I interpreted it.

15 Q. Now, was that last year though
16 or was that ---? Remember we just
17 talked about kind of two different
18 periods of treatment, one in 1999 and
19 then one in 2001. And there's about
20 a year and a half between there with
21 no treatment. Which time are you
22 talking about right now when you're
23 saying I was told no more payment?

24 A. I think it was the first time.
25 But I don't know.

1 Q. During that year and a half or
2 so were you seeing anybody else?

3 A. I got the chicken pox, but I
4 didn't see anybody else other than my
5 gynecologist.

6 Q. But you weren't going to see
7 anybody for injuries you relate to
8 this accident; right?

9 A. No.

10 Q. You said you had one other
11 shower incident during that time
12 period. Did you have any other
13 accidents during that time period?

14 A. No, I didn't. I'm allergic to
15 latex and I had to go over to the
16 hospital because I was having an
17 allergic reaction to rubber gloves,
18 but no.

19 Q. And just so I understand you.
20 You claim that that period of
21 chiropractor treatment in 2001 that
22 second one. You claim that that's
23 because of this accident two; right?
24 The September '99 accident?

25 A. Yes.

1 Q. So if you thought the
2 insurance company wasn't paying for
3 it the first time, why did you go
4 back the second time? Did something
5 change?

6 A. No. Because I was talking to
7 Myron and he told me that if I had
8 felt that I needed to go, I needed to
9 go. And something wasn't right and I
10 went.

11 Q. And did the insurance company
12 pay for it?

13 A. Yes.

14 Q. When you say talking to Myron,
15 you mean your lawyer?

16 A. Yes, that's right.

17 Q. Did you have any trouble with
18 the insurance company paying for it
19 that second time?

20 A. No.

21 Q. And when I looked at Doctor
22 Bcuma's records there was a letter in
23 his file that looked like it might be
24 your handwriting. Do you remember
25 writing a letter about why you didn't

1 have any treatment during that
2 period?

3 A. I remember writing a letter
4 that stated that, due to the fact
5 that the insurance wasn't --- I can't
6 say exactly.

7 Q. But you do recall writing a
8 letter about it?

9 A. Because I had had a surgery in
10 the meantime.

11 Q. What surgery was that?

12 A. By a female doctor.

13 Q. And what kind of surgery was
14 that?

15 A. They took a cyst out or
16 something. Cyst or whatever you want
17 to call it.

18 Q. So you had a cyst removed?

19 A. Yeah.

20 Q. What year was that? That was
21 after the accident?

22 A. Yeah.

23 Q. I'm sorry. Go ahead. So you
24 wrote this letter to ---. Did you
25 write it to Doctor Bouma?

- 1 A. I don't remember.
- 2 Q. You remember writing a letter
3 of that nature though, about ---?
- 4 A. Yeah, something's telling me I
5 wrote a letter about something but I
6 don't remember.
- 7 Q. Do you know why you did that?
- 8 A. No, I don't.
- 9 Q. You don't know if somebody
10 asked you to do that?
- 11 A. I've totally forgotten all
12 about it. I did.
- 13 Q. So if Doctor Bouma's records
14 indicate that you haven't seen him
15 since October of 2001, does that
16 sound about right to you or do you
17 think you've seen him since then?
- 18 A. No, I haven't seen him since
19 then.
- 20 Q. Other than at the emergency
21 room did any other doctor prescribe
22 you medications for the pain
23 complaints you had?
- 24 A. Doctor Jesick might have
25 prescribed ---. I remember her

1 prescribing something for the --- I
2 think she just refilled my Flexeril.

3 I think that's what it was.

4 Q. How long do you think you were
5 taking medications after the
6 accident? Again, for injuries that
7 you relate to it.

8 A. About six months.

9 Q. And during that year and a
10 half that you weren't having
11 treatment, you know, that break in
12 treatment with Doctor Bouma. You
13 were still working; right?

14 A. Right.

15 Q. And at one point maybe even
16 two jobs because we're looking at
17 ---? No, I'm sorry. You would've
18 been working at Victorian Gardens
19 then. Okay. Why did you stop
20 treating with Doctor Bouma in October
21 of 2001? Why did you stop going?

22 A. Because I was ---. In 2001?

23 Q. Yes.

24 A. Because at that time he was
25 like adjusting me when I went and I

1 felt better and I didn't need to go
2 back.

3 Q. But you didn't just tell me a
4 little while ago that you had
5 continual problems and pains this
6 whole time?

7 A. Well, yeah, but I mean I had
8 to pay for it on my own and I didn't
9 have any insurance and I couldn't
10 afford it.

11 Q. Who told you you had to pay
12 for it on your own?

13 A. The doctor's office.

14 Q. How much money have you paid
15 out of your pocket for medical
16 expenses for these Doctor Bouma's
17 visits?

18 A. I couldn't --- I don't know.
19 Maybe \$100 bucks maybe. I would just
20 write a check, you know, or give him
21 cash. I don't remember.

22 Q. Can you prove to me how many
23 times you actually paid him out of
24 your own pocket?

25 A. I think I paid him twice out

1 of my own pocket.

2 Q. When was that?

3 A. The last couple of times I
4 went. But other than I didn't have
5 any out-of-pocket expenses.

6 Q. Do you have any documentation
7 to prove those payments?

8 A. I might if I didn't throw them
9 away.

10 Q. And was there some point when
11 the insurance company during that
12 second time denied you payments for
13 those visits?

14 A. Uh-huh (yes).

15 Q. There was?

16 A. Yes.

17 Q. And do you have documentation
18 to show that?

19 A. I just went by what the
20 doctor's office told me.

21 Q. So were you feeling better or
22 could you not pay for it? Why was it
23 that you stopped?

24 A. It was a little bit of
25 everything.

1 Q. Did you ever have any physical
2 therapy after this accident?

3 A. No.

4 Q. Do you recall it being
5 recommended by that neurosurgeon that
6 you went to that you have some more
7 testing?

8 A. I don't recall that.

9 Q. You don't recall that?

10 A. No.

11 Q. Do you recall ever being
12 recommended to have some tests that
13 you then didn't follow through and
14 have?

15 A. No.

16 Q. When this September '99
17 accident happened, were you taking
18 any prescription medications
19 regularly then?

20 A. No.

21 Q. Were you on anti-depressant
22 medications at that time?

23 A. No.

24 Q. Now, as far as any limitations
25 that you experienced because of the

1 injuries from this accident, I think
2 at one point you told me you pretty
3 much just carried on. Are there any
4 limitations that you had that you
5 haven't already described to me?

6 A. No.

7 Q. So is it fair to say you
8 really weren't prevented from doing
9 anything that you would normally do?

10 A. No. I could still do the
11 things that I normally do, but it
12 wasn't without pain or being
13 uncomfortable.

14 Q. Is it fair to say that it was
15 never recommended that you have
16 surgery or anything like that?

17 A. No, it wasn't recommended.

18 Q. Do you have any plans sitting
19 here today to have treatment in the
20 future for injuries you relate to the
21 September '99 accident?

22 A. I could go right now to the
23 chiropractor.

24 Q. Are you planning to do that?

25 A. I don't know.

1 Q. Is that any different than it
2 was in October of 2001? I mean are
3 you going to do that?

4 A. No, I don't plan on going
5 today, but I'm not saying I can't.
6 I'm not planning on it.

7 Q. Now, as far as your daily
8 activities, you know, you could do
9 the normal things you do at your
10 home; right?

11 A. Yes.

12 Q. Never prevented from doing
13 anything like that; is that right?

14 A. Sometimes it takes me longer
15 to do it because I have to sit down
16 because my leg hurts or my back is
17 killing me. But other than that, no,
18 I've tried to do everything that I
19 normally do.

20 Q. And it's your testimony that
21 the only other time you had any back
22 or neck problems was for about two
23 weeks after that incident in '95/'96;
24 right?

25 A. Yeah.

- 1 Q. Just a real short period then?
- 2 A. Yeah.
- 3 Q. Now, as far as the accident
- 4 itself, it was in Dubois; correct?
- 5 A. Yes.
- 6 Q. At the Sheetz there?
- 7 A. Yes.
- 8 Q. Is that the intersection of
- 9 322 and 119?
- 10 A. Yes.
- 11 Q. And where were you going when
- 12 that happened?
- 13 A. Jeff and I were just taking a
- 14 ride up to Elk County to visit, to
- 15 see elk for the day.
- 16 Q. Was that ---?
- 17 SHORT BREAK TAKEN
- 18 BY ATTORNEY OLIVER:
- 19 Q. So you're going for a drive,
- 20 it's September 6th, 1999. Your
- 21 fiancé, was he only person in your
- 22 vehicle other than you?
- 23 A. Yes.
- 24 Q. And did either of you have to
- 25 work that day?

- 1 A. No.
- 2 Q. What were you going into the
3 Sheetz for?
- 4 A. Just like a pee break, get a
5 cup of coffee.
- 6 Q. And how long had you been
7 driving that day?
- 8 A. I would say probably 45
9 minutes to an hour I would say.
- 10 Q. So you'd come right from home?
- 11 A. Yes.
- 12 Q. Sheetz Run Road, is that the
13 RD Two that you gave me?
- 14 A. Yeah, that's the one address
15 that they changed to.
- 16 Q. And what time of the day did
17 the accident happen? Do you recall?
- 18 A. It was like around lunchtime.
19 Between 11:00 and 1:00 I think. I
20 can't be for sure.
- 21 Q. And how would you describe the
22 traffic conditions as you came in to
23 Dubois?
- 24 A. It was busy because it was a
25 holiday.

1 Q. And were you familiar with
2 that ---? This happened at a Sheetz
3 parking lot; right?

4 A. Uh-huh (yes).

5 Q. And had you ever been to that
6 Sheetz before?

7 A. Yes.

8 Q. I'm sorry?

9 A. Yes, I had been.

10 Q. Fairly often?

11 A. Yeah, maybe once a month or
12 --- take a ride up north.

13 Q. So it'd be fair to say that
14 you're familiar with that
15 intersection and parking lot?

16 A. Yes.

17 Q. And as far as the ---. I
18 guess first let me ask you to, if you
19 could explain to me kind of what the
20 lay out of that lot is. Maybe the
21 best way if you can would be to have
22 you draw. Can you draw a diagram of
23 it?

24 A. Yeah.

25 Q. Obviously not the scale, just

1 so we're on the same page.

2 A. This is the red light.

3 Q. Could you label that 119

4 there, just so I know?

5 A. I don't know what this number

6 is.

7 Q. Okay.

8 A. This is the red light and then

9 here is the Sheetz, this is the

10 Sheetz. Well it's not over that far.

11 Q. Sure.

12 A. Then you come around and this

13 is all parking area. Here's the gas

14 pumps and here's where the cars would

15 be like getting gas. This is a

16 little thing, throughway and this is

17 the Sheetz here.

18 Q. Can you write the word cars,

19 just right along the side there?

20 A. Okay.

21 Q. And then gas pump.

22 A. Gas pump. Okay. And here's

23 cars here, too.

24 Q. How many gas islands if you

25 will are there?

1 A. I don't remember that.

2 Q. More than one?

3 A. Yeah, because there were cars
4 on each side. So it's probably one
5 with like three or four dual things.
6 And here's the parking lot where you
7 come in.

8 ATTORNEY TOMB:

9 Speak up.

10 A. You come in here and here's
11 like a ---.

12 BY ATTORNEY OLIVER:

13 Q. I'm just going to repeat so we
14 have this on the record. You're
15 coming off of 119?

16 A. 119, right.

17 Q. And you've drawn the one
18 entrance from 119. Is there more
19 than one or just that one?

20 A. There's one over here.

21 Q. Okay. But as far as if you're
22 coming from 119 is there only one
23 entrance to get in from there?

24 A. If you're going straight. To
25 my recollection, yes, because this is

1 all curb. I turned in here, like
2 this.

3 Q. You took a right?

4 A. Yes, took a right. And this
5 door.

6 Q. This is the door to Sheetz?

7 A. And then this is the front of
8 the store.

9 Q. Can you write that instead of
10 just ---.

11 A. Sorry, I'm making a mess of
12 this.

13 Q. That's okay. You're doing
14 fine.

15 A. And this is the parking. It's
16 kind of angled and then this is here.

17 Q. The parking kind of ---. The
18 store front jots out beyond the
19 parking area?

20 A. Yeah, right.

21 Q. Can you label that parking?
22 Thank you. Is there parking on the
23 other side as well?

24 A. I think. I never came in on
25 that side, so I really don't know. I

1 only know this side. And then
2 there's like a kerosene gas pump here
3 and I came in here. Now, meantime
4 there's cars like backing out of the
5 parking spots here and stuff. Okay?
6 So I come in here and here's a
7 parking spot and these are all
8 parking spots. And I come in here
9 and I was going in here. And just as
10 I was going in here.

11 Q. Where are we headed?

12 A. To that parking spot.

13 Q. To the very first parking
14 spot?

15 A. Yeah. I was going there.

16 Q. Okay.

17 A. Okay?

18 Q. The closest parking spot to
19 the store?

20 A. The one that was open, yeah.
21 Closest to the store.

22 Q. And the rest of them were full
23 of cars, is that what you're saying?

24 A. Uh-huh (yes). I was coming
25 here. Now, this is a throughway.

1 Q. In front of the store?

2 A. Yeah, were the handicapped
3 people get up on, like on both sides
4 of the ramp. There's no parking and
5 you're supposed to ---.

6 Q. Okay. Can you write
7 handicapped ramp just on one side.
8 We're not going to be able to tell
9 the scratching later, that's why.
10 Sorry, go ahead.

11 A. And this is like a no parking
12 zone, a no throughway. You're
13 supposed to keep it open so the
14 handicapped people can get on there.

15 Q. You called it a throughway.
16 Is it your testimony that it's a
17 throughway or it's not a throughway?

18 A. It's a throughway. If I'm
19 saying the right word. I can't
20 explain it. Like you're not allowed
21 to be going through there.

22 Q. You're not allowed to drive
23 there, in front of the store?

24 A. Right. No driving through or
25 parking there.

- 1 Q. Does it say no driving?
- 2 A. No throughway. I'm pretty
- 3 sure.
- 4 Q. Did it say that before
- 5 September of '99?
- 6 A. I'm not sure because there is
- 7 a sign and something on the road.
- 8 Q. What does it say?
- 9 A. I think it says no throughway,
- 10 no parking.
- 11 Q. So you told us that you don't
- 12 think people are allowed to drive
- 13 through there; right?
- 14 A. Yeah.
- 15 Q. And there is anything else you
- 16 need to add on there?
- 17 A. No.
- 18 Q. You've drawn the one entrance,
- 19 can you write the word entrance
- 20 there, please? If you didn't come in
- 21 that entrance that you've drawn and
- 22 you would proceed a little more down
- 23 119, is there another entrance to
- 24 enter into the Sheetz parking lot?
- 25 A. I don't know to be honest with

1 you. I don't know.

2 Q. So when you pulled in to
3 Sheetz that day you took a right into
4 the parking lot; right?

5 A. Uh-huh (yes).

6 Q. And how many cars were at the
7 gas pumps?

8 A. I don't remember that.

9 Q. Can you in general terms
10 describe whether they were full or
11 ---?

12 A. I would --- yeah, they were
13 full of cars.

14 Q. They appeared full?

15 A. Uh-huh (yes).

16 Q. You said the parking spaces
17 that you were coming near, all of
18 them were full except this one;
19 right?

20 A. Yeah, because the car had just
21 ---. When I was coming in here a car
22 backed out of here and was going so
23 that left that open.

24 Q. So you actually watched a car
25 back out of that space that you were

1 going to pull into?

2 A. Uh-huh (yes).

3 Q. And did that car back out
4 after you had already pulled into the
5 lot or as you were doing that?

6 A. I was coming in and as I'm
7 like coming in, you're already
8 scoping for a parking spot, when
9 you're pulling in you're already
10 looking for a parking spot. So I
11 noticed this car coming out, get in,
12 was leaving and I was just ---.

13 Q. Did you have to stop for that
14 car or anything?

15 A. It was already gone before I
16 even came.

17 Q. Out of the way. So as you
18 were pulling in you were looking
19 around up in that area to see if
20 there were any parking spots; right?

21 A. Right, just looking around
22 making sure everything was, you know,
23 all right. Because it was busy.

24 Q. And you were looking for a
25 parking spot; right?

1 A. Yeah, I'd seen I had a parking
2 spot when I was right here.

3 Q. When you were right here was
4 there a car in that parking spot or
5 not?

6 A. It was backing out of that
7 parking spot.

8 Q. So as you're pulling in you
9 notice that a car is pulling out of
10 the spot. That would leave one spot,
11 so you're looking to get in to that
12 spot where the car is leaving; right?

13 A. Yeah.

14 Q. Your car was a --- what kind
15 of car were you driving?

16 A. '97 Ford Escort.

17 Q. And that would be a --- that's
18 a five-speed vehicle?

19 A. Yes.

20 Q. When you pulled in what gear
21 were you in?

22 A. Going from second to first.

23 Q. As you made the turn?

24 A. Uh-huh (yes). Because the red
25 light is not that far from here to

1 here.

2 Q. Were you stopped at the red
3 light first?

4 A. Yeah.

5 Q. It was red?

6 A. It was red. And I didn't even
7 get to second. You know what I mean?
8 I went from first to second right as
9 I'm going in and then went into
10 first.

11 Q. So by the time you get into
12 the parking lot you're in first gear;
13 is that right?

14 A. Yeah, which is maybe five mile
15 an hour. Six something like that,
16 because you can't go really fast when
17 you're in first gear.

18 Q. When you pulled in did you
19 have any awareness of what was going
20 on? We're talking about the, you
21 know, the side of the store where you
22 were going to park. Do you have any
23 idea what was going on the other side
24 of the store?

25 A. No.

1 Q. A lot of traffic there; right?

2 A. Only thing I noticed that was
3 busy was the gas pumps. I don't know
4 nothing about this side.

5 Q. So you make the right, as
6 you're making the right you see this
7 car pulling out of that first spot,
8 you think I'm going to park in that
9 spot; right? And tell me what
10 happens then.

11 A. I go in to the thing and just
12 as my car is ---.

13 Q. To the thing, you mean the
14 parking stall?

15 A. Yeah. I'm sorry. Just as I
16 go --- head towards the parking
17 stall, the front end of my car is
18 just touching getting to go in and
19 just as I went in the car come
20 through there and smacked me. Right
21 there, just hit me.

22 Q. Where did it hit you?

23 A. Between the front end and
24 where the door and the front end meet
25 and that.

- 1 Q. Did you see the other car
2 coming before there was an actual
3 collision?
- 4 A. No.
- 5 Q. What about Jeff? Did he see
6 that other car coming?
- 7 A. I can't say what he saw.
- 8 Q. Did he ever talk to you about
9 it?
- 10 A. Yeah. He did.
- 11 Q. Did he ever tell you whether
12 he saw that other car coming?
- 13 A. Well, just as the --- I was
14 told by him, just as the collision
15 happened he seen that she was going
16 to hit me.
- 17 Q. And how long did before that
18 did he see it? Did he tell you?
- 19 A. No.
- 20 Q. I mean was it --- is your
21 impression from what he said, is that
22 it was right as it was happening?
- 23 A. Yeah.
- 24 Q. And did Jeff yell anything to
25 you?

- 1 A. No.
- 2 Q. Were you talking with Jeff
- 3 when this happened?
- 4 A. No.
- 5 Q. Do you know that or do you not
- 6 recall?
- 7 A. I don't recall if I was, but I
- 8 don't, you know, ---.
- 9 Q. Was your radio on?
- 10 A. No, it was broke. The fuse
- 11 was dead.
- 12 Q. How fast were you going as you
- 13 came toward that first spot next to
- 14 Sheetz there?
- 15 A. Not very fast at all,
- 16 practically just crawling.
- 17 Q. Can you tell me in miles per
- 18 hour what your speed was?
- 19 A. Six mile an hour maybe.
- 20 Because when you're in first gear you
- 21 can't really go much faster because
- 22 the engine is like going.
- 23 Q. So you're judging how fast you
- 24 were going by how fast you can go in
- 25 first gear?

1 A. No.

2 Q. Did you look at your
3 speedometer?

4 A. I can't say.

5 Q. From the time that you took
6 the right and pulled in until the
7 time that you come up to this spot, I
8 understand your nose is just getting
9 into the spot; right?

10 A. Well, it's not in my drawing,
11 but my nose is just ---. I was just
12 coming in and just as my front end
13 was just like getting to where the
14 lines end for your parking spot.
15 Okay? It was there and she'd come
16 through there and hit me.

17 Q. So the front end of your car
18 wasn't really into the spot yet but
19 you were about to kind of break that
20 threshold; right?

21 A. Yeah.

22 Q. So between the time that you
23 go to there and the collision happens
24 from when you pulled in, had you
25 stopped your car at all?

1 A. I don't think so, no. I was
2 not going very fast because it was
3 very busy..

4 Q. Now, when you were pulling in
5 and you said that there were cars and
6 the pumps looked pretty full. Were
7 there cars, you know, facing the
8 direction of that entrance at the
9 pumps? Do you know what I mean?

10 A. The cars were like this. This
11 is the front.

12 Q. Why don't you draw an arrow
13 pointing to where the front of the
14 cars were? Okay. So they would be
15 pulling --- if they were pulling away
16 from the pump, they'd be pulling in
17 the direction that you're coming
18 across; right?

19 A. Because there were cars ---.
20 Yeah. There was an Explorer, a big
21 one here.

22 Q. So when you take the right and
23 you come through and you're heading
24 towards your parking spot what's
25 happening to the right of you? What

1 are the cars over there doing when
2 you're pulling through the parking
3 lot?

4 A. Here?

5 Q. Yes, at the gas pumps. We'll
6 start there.

7 A. Nothing. They were just
8 pumping gas. They were sitting
9 there.

10 Q. You're sure that the people
11 were pumping gas at that point or
12 could they have been in their cars
13 waiting for awhile?

14 A. They could have been in the
15 store, but there was a gentleman
16 pumping his gas, I can remember that.
17 Because he has an Explorer and there
18 was a car here because it was full.
19 there was a car and a car.

20 Q. And I correct that you don't
21 know what all of those people were
22 doing along with those cars?

23 A. No, I don't.

24 Q. And it was daytime; right?

25 A. Yeah.

- 1 Q. Nobody had headlights on; is
2 that right?
- 3 A. No.
- 4 Q. Clear day?
- 5 A. Yes.
- 6 Q. And what did you as you passed
7 the pump? And then there were pumps
8 to your right; correct?
- 9 A. Yeah.
- 10 Q. And lots of cars?
- 11 A. Yeah.
- 12 Q. So would it be fair to say you
13 didn't have a clear view of the
14 parking lot over to your right on the
15 other side of those pumps as you
16 pulled past the pumps?
- 17 A. This parking area here?
- 18 Q. Yes.
- 19 A. And this here? No.
- 20 Q. No what?
- 21 A. No, I didn't have ---. I mean
22 I knew, I was watching when I was
23 going on around me in this section.
- 24 Q. In the section of the parking
25 spot you were pulling in to?

1 A. When I was coming in, but in
2 the meantime I'm watching to make
3 sure there's no car, you know, no
4 cars coming here. And you can
5 visibly see that these cars weren't
6 going anywhere because they were
7 doing something.

8 Q. But you don't know what they
9 were doing?

10 A. No, but I mean over here, no.

11 Q. You don't know what was going
12 on over on that other side of the
13 pumps?

14 A. No, I don't. No.

15 Q. And what did you do as you
16 passed these pumps, the last pumps,
17 you know that you have to clear
18 before you get up to where your spot
19 is. Did you look to your right and
20 see whether there were any cars
21 coming?

22 A. Yeah, I pulled through here.
23 I was going very slowly and I, you
24 know, knew it was busy and I was
25 being very cautious because I'm

1 afraid of getting in an accident. So
2 I went very slowly and one minute she
3 wasn't there and the next minute she
4 was.

5 Q. When you say she wasn't there,
6 are you testifying that you actually
7 looked over to your right?

8 A. Yeah.

9 Q. And you saw no cars coming as
10 you cleared that last gas pump?

11 A. Yeah, guaranteed.

12 Q. You looked over Jeff, was he
13 in your way?

14 A. No.

15 Q. Did you ask him to help you
16 look?

17 A. I don't remember asking him to
18 help me because I don't --- you know.

19 Q. Did you have to look around
20 him?

21 A. No.

22 Q. So you looked over there and
23 this whole you called it the --- you
24 said it's not a throughway. This
25 whole area was clear?

1 A. I can't say that it was clear.
2 You know what I mean? I can't say
3 that it was clear, but I remember
4 going very slow because of all the
5 cars moving around me. And there was
6 people moving in the parking lot and
7 I was being very cautious not to hit
8 any of them. And I was just being
9 very cautious. I can't say that
10 there was nobody here.

11 Q. Let me ask you again to be
12 clear. Did you look in that area, in
13 the area where you say people can't
14 park and drive? Did you look and see
15 if there was anybody coming?

16 A. No, I didn't look.

17 Q. You did not?

18 A. I mean I looked in this area
19 around me, but I didn't like lean
20 over around these cars and look down
21 that throughway.

22 Q. So you didn't look down to the
23 right to see if there was cars coming
24 as you cleared that last set of pumps
25 on your way to the parking spot?

1 A. No, because I was already, you
2 know, going in there.

3 Q. And when you were pulling in
4 you said you were in first gear. Was
5 your foot on the gas?

6 A. No, because I use --- I have a
7 clutch and a brake and I was using
8 the brake at the time.

9 Q. You were braking toward this
10 spot?

11 A. Uh-huh (yes).

12 Q. You didn't have your foot on
13 the gas at all?

14 A. No.

15 Q. When did you take your foot of
16 your gas? You come into the parking
17 lot ---.

18 A. Right here.

19 Q. And then you take your foot
20 off the gas?

21 A. Yeah, because if the car is
22 moving you can use --- control your
23 car by the brake. That's how I do
24 it.

25 Q. So you're saying you kind of

1 coasted in there; is that right?

2 A. Yeah.

3 Q. You had your foot on the
4 clutch?

5 A. Well, if you push the clutch
6 in and you put your foot on the brake
7 you can control moving without having
8 to ---.

9 Q. I'm just asking so we're
10 clear. You had your foot on the
11 clutch and you were using the brake;
12 right?

13 A. Yeah. That's how I always
14 drive it.

15 Q. After the collision did your
16 car move forward at all into the
17 spot?

18 A. It stayed right here because
19 when she hit me it debilitated it, it
20 did not move from that spot.

21 Q. So you think it just --- as
22 soon as you got hit you think it
23 stopped right away?

24 A. Oh, I know it stopped right
25 away.

1 Q. Did you apply your brake at
2 any point?

3 A. Where?

4 Q. During this whole incident?

5 A. Well, yeah. Yeah.

6 Q. When did you do that?

7 A. I just told you that I used
8 the clutch and the brake to coast to
9 where I was.

10 Q. So do you think you had your
11 foot on the brake at the time that
12 you got hit?

13 A. I don't know.

14 Q. But am I correct that you did
15 not brake because of seeing a car
16 coming at you; right? Because you
17 didn't see the car?

18 A. I didn't see the car coming at
19 me.

20 Q. Am I correct that you did not
21 apply your brake in reaction to that
22 other car?

23 A. No, because I didn't see the
24 car coming.

25 Q. What about right after she hit

1 you? Do you know if you slammed on
2 the brake or anything like that?

3 A. I don't remember. It stopped
4 the car.

5 Q. And can you describe for me
6 the impact when that collision
7 occurred?

8 A. It was just like my car
9 stopped dead when she hit me and it
10 just like threw me to the side.

11 Q. Did you have your seatbelt on?

12 A. Yeah.

13 Q. And you were thrown to the
14 left, is that what you're saying?

15 A. To the driver's --- yeah. It
16 was just like ---.

17 Q. Did you hit anything in the
18 vehicle?

19 A. I hit the door and the handle.
20 That's what bruised me, the handle.

21 Q. What part of your body hit
22 that?

23 A. This part.

24 Q. Your left arm?

25 A. Uh-huh (yes).

1 Q. What about Jeff? Did he hit
2 anything inside the vehicle?

3 A. If I'm not mistaken he hit his
4 --- because he like --- and then when
5 it hit he come over and then he
6 bounced back and hit his arm, his
7 right arm, on the door.

8 Q. Now, the impact didn't move
9 your whole car, did it?

10 A. It just like --- it moved it a
11 little bit because it broke the tie
12 rods. And it like pushed --- it
13 didn't push it, but it like moved it
14 over a little bit. Not much.

15 Q. Do you think your car went any
16 further into the parking spot after
17 you were hit?

18 A. No.

19 Q. In fact, if I recall correctly
20 you had made a statement about things
21 being thrown from your dashboard or
22 thrown in the car. Can you describe
23 that for me?

24 A. The stuff that was like in the
25 console was all over the front when

1 it hit threw it all over the floor.

2 Q. Did it go to the side, did it
3 go backward or what happened to those
4 items?

5 A. The stuff in the console?

6 Q. Yes.

7 A. It went on the floor to the
8 driver's side.

9 Q. Was there anything else that
10 was thrown around or displaced?

11 A. I don't know. There was --- I
12 had some stuff in the back that was
13 thrown on to --- like the back seat,
14 onto the floor, but it wasn't much.

15 Q. Are you able to tell me or to
16 estimate for me how fast the other
17 car that hit you was going?

18 A. No, I couldn't tell you.

19 Q. You couldn't do that?

20 A. No.

21 Q. Have you talked with Jeff
22 Williams about that?

23 A. No.

24 Q. Has he ever said to you
25 anything about how fast he thought

1 that car was going?

2 A. He's just made comments that
3 she had to be going fast enough to
4 break your tie rods. But, you know,
5 he'd never said anything.

6 Q. From what he said is it your
7 impression that he doesn't know how
8 fast she was going?

9 ATTORNEY TOMB:

10 I object to the
11 question.

12 A. I can't answer that. I don't
13 know.

14 BY ATTORNEY OLIVER:

15 Q. You don't know? All right.
16 So the collision occurs, then what
17 happens next?

18 A. I got out of the car and I
19 went to ---. By this time someone
20 had come over and said that they had
21 called, you know, 911. I don't know
22 how it was, don't remember. Someone
23 come over and said that they done
24 that. I sat down on the side of the
25 curb because I was like shaken up.

1 Somebody helped Jeff get out of the
2 car. I don't know who that was
3 because the door was --- he couldn't
4 get the door open so they pulled the
5 door to get him out. I don't
6 remember who, you know, because no
7 one ---. I went in to the Sheetz to
8 ask why it was taking so long for
9 someone to get there, you know, for
10 the police to get there. I asked Jus
11 ---. Is her name Justine, I think?

12 Q. Justine Toombs. The women you
13 sued?

14 A. Right. If everything was
15 okay, you know, if she was all right
16 and she said that she was fine. Her
17 boyfriend or the person who was with
18 her at the time made a phone call and
19 within a few minutes her parents ---
20 it might have been longer than a few
21 minutes. It just seemed like a few
22 minutes, everything was going so
23 hectic at that time. Her parents
24 came. In the meantime I called my
25 insurance company, State Farm, and

1 they told me what to do, what I
2 needed to do, you know, like what
3 information to get from her. And
4 let's see. After that they got all
5 the information. The cop that was
6 there I don't even know if he even
7 --- I don't think he even wrote a
8 report. But if I'm not mistaken he
9 knew her personally, Justine.

10 Q. Why do you think that?

11 A. Because he made a comment that
12 he knew --- he asked Jeff if he
13 should write a report and Jeff said
14 whatever you need to do. And he was
15 like well, you know, everything seems
16 to be okay. There's no need to write
17 a report. I can't remember the exact
18 words or the exact comment, but it
19 lead me to believe that he knew her
20 personally because he made a comment
21 about well they're good people I know
22 them from the area, we don't need to
23 write a report or something like
24 that. That's just hearsay. You know
25 what I'm saying?

1 Q. Sure.

2 A. And then I called the
3 insurance company back to make sure
4 that I could get my tow truck from
5 home. Because it was a holiday and I
6 would have to sit there forever
7 waiting for a tow truck company that
8 I didn't know. And they came and got
9 the car and I went back home with
10 them.

11 Q. You went back home or to the
12 hospital?

13 A. Well, I was heading home but
14 in the ride in the tow truck I had
15 them drop me off at the emergency
16 room because by then everything had
17 settled in.

18 Q. And by settling in you mean
19 ---?

20 A. I guess the shock wore off.

21 Q. And you had the kinds of
22 complaints that you told me about
23 already?

24 A. Yes.

25 Q. So there were no ambulances

1 called to the scene; right?

2 A. No.

3 Q. Now, did you hear Justine
4 Toombs say anything at the scene
5 other than you said you talked to her
6 and asked if she was all right. Did
7 you hear something else?

8 A. No. I heard Jeff say to her
9 boyfriend --- what the hell are you
10 doing going through there so fast?
11 And he said --- I don't remember what
12 he said. And he said something to
13 the fact that well --- I don't
14 remember, you know. I remember him
15 saying something to him and I was
16 just sitting there because I was like
17 starting to --- get real shaky
18 because I was scared. But other than
19 that I can't remember what they said.
20 They were speaking to each other but
21 I can't remember what they said.

22 Q. Do you remember did Justine
23 appear upset or anything like that?
24 Can you tell me?

25 A. I don't remember.

1 Q. I'm sorry?

2 A. I don't remember.

3 Q. Do you remember swearing at
4 either Justine or the passenger in
5 her car?

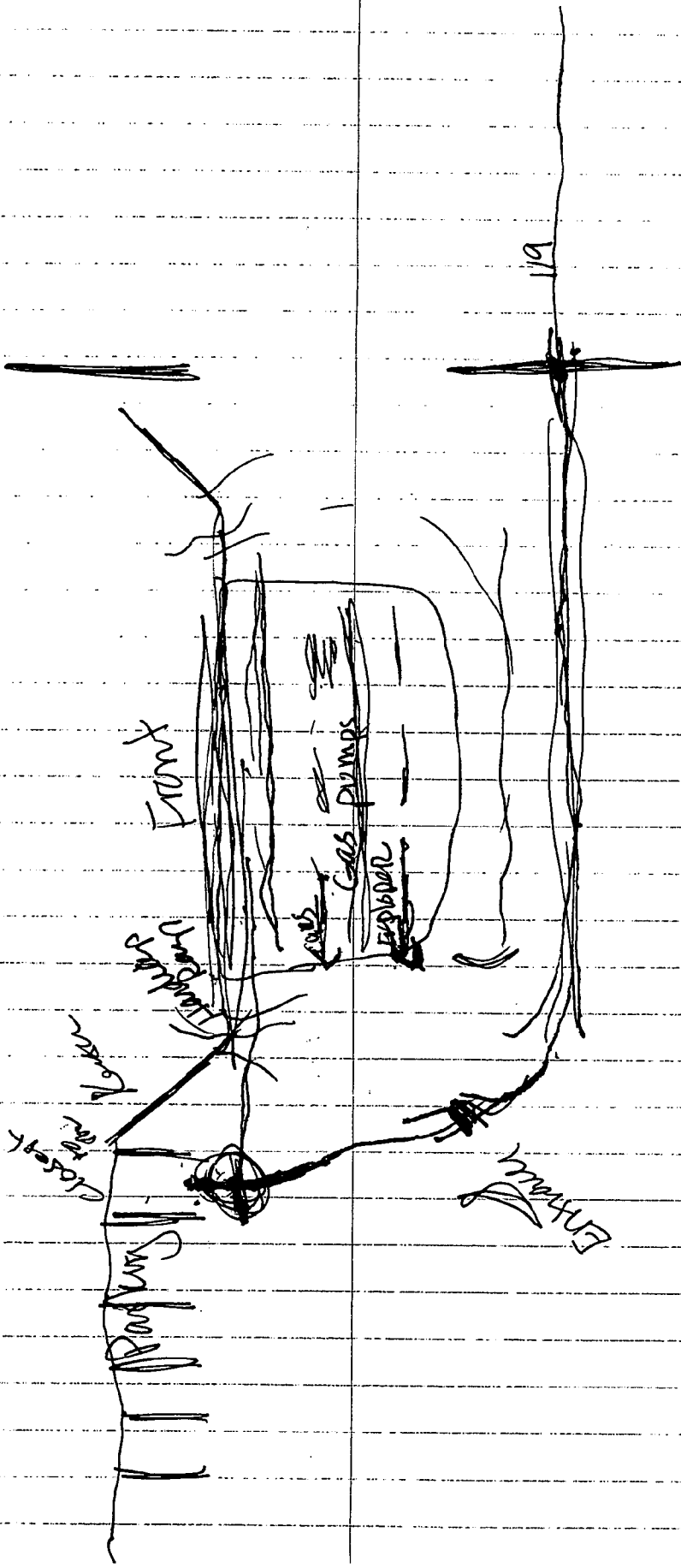


