PETITION FOR APPEAL
FROM SUSPENSION OF OPERATING PRIVILEGES

1. Appellant is DAVID DALE WARNER, an individual who resides at German Road, P. O. Box 191, Moshannon, Cooper Township, Clearfield County, Pennsylvania.

2. Appellee is Commonwealth of Pennsylvania, Department of Transportation, Bureau of Driver Licensing, Citation Processing Division, Room 302, Transportation and Safety Building, Harrisburg, Pennsylvania, 17120.

3. Appellant has been notified of the suspension of his driving privileges as a result of his conviction on February 27, 2001, of a violation of Title 35 Pa.C.S. §13 (a)16 of the Controlled Substance, Drug, Device, and Cosmetic Act, on or about December 31, 1999, said Notice being attached hereto and made a part hereof.

4. The mailing date of said Notice is August 10, 2001.

5. The effective date of the suspension is September 14, 2001.

6. This Court has venue of the instant proceeding as the County of residence of the Appellant.

7. Appellant's operating privileges have been suspended for a period of six (6) months.

8. Appellant has appealed the suspension of his operator's license and represents to the Court that:

a. The Defendant is a professional driver. At the time of his entry of a guilty plea to the charge of Possession of Drug Paraphernalia, the Defendant was not advised that his operating privilege would be suspended. Had Defendant known that a guilty plea to the charge would result in a suspension of his operator's license, Defendant would not have pled guilty to the charge.

b. The guilty plea colloquy form has a passage related to the suspension of operating privileges for certain offenses, but was not completed, leading Defendant to believe that no suspension of his operating privileges would occur.

c. The imposition of a suspension of the Defendant's operating privileges, causing a loss of Defendant's employment, would be unfair and oppressive.

WHEREFORE, the Appellant prays your Honorable Court for an Order sustaining the Appeal and Dismissing the Suspension of operating privileges.


