AND NOW COMES your plaintiffs, Dale and Donna Siegfried, who by and through their attorney, John R. Carfley, Esquire, sets forth the following statement and aver as follows:

1. Plaintiffs are Dale and Donna Siegfried, adult individuals, presently residing at R. D. 1, Box 134, Philipsburg, Pennsylvania.

2. Defendant Sky Haven Coal Company is a Pennsylvania Corporation with its principal place of business located at R. D. 1, Penfield, Clearfield County, Pennsylvania.

3. Plaintiffs entered into a contract with Sky Haven to remove the mineral estate from certain property wherein they retain an ownership interest which property is situate, lying and being in Decatur Township, Clearfield County, Pennsylvania, consisting of 100 acres more or less and being more particularly described in Deed Book Volume 901, Page 471.

4. Commencing as early as July of 1999 defendant began to remove minerals from the subject tract and to pay royalty to plaintiffs based upon an agreed royalty rate of \$1.75 per ton.

AND NOW COMES your plaintiffs, Dale and Donna Siegfried, who
by and through their attorney, John R. Carfley, Esquire, sets forth
the following statement and aver as follows:

1. Plaintiffs are Dale and Donna Siegfried, adult
individuals, presently residing at R. D. 1, Box 134, Philipsburg,
Pennsylvania.
2. Defendant Sky Haven Coal Company is a Pennsylvania
Corporation with its principal place of business located at
R. D. 1, Penfield, Clearfield County, Pennsylvania.
3. Plaintiffs entered into a contract with Sky Haven to
remove the mineral estate from certain property wherein they retain
an ownership interest which property is situate, lying and being in
Decatur Township, Clearfield County, Pennsylvania, consisting of
100 acres more or less and being more particularly described in
Deed Book Volume 901, Page 471.
4. Commencing as early as July of 1999 defendant began to
remove minerals from the subject tract and to pay royalty to
plaintiffs based upon an agreed royalty rate of \$1.75 per ton.

5. Beginning in January of 2000, production royalty was escrowed because of a controversy between the plaintiff and his brother, Terry Siegfried, which arrangement resulted in the withholding of payment of all royalties by the defendant. Said statement and the course of action undertaken by the defendant is verified in a letter dated June 27, 2000, a true and correct copy of which is attached hereto as Exhibit A.

6. It is believed that the defendant continued to mine this property and to provide for the escrow of royalties as per the agreement with these parties.

7. It is believed and therefore averred that these royalties are bearing interest at a specified rate in the account segregated for the use of these beneficiaries or in default thereof that the said defendant should be responsible for a reasonable rate of compensation based upon the acceptable interest rate in the trade during the applicable time period.

8. Demand has been made upon the defendant to deliver these sums of money to Plaintiffs and/or their duly authorized agents but to date the defendant refuses and continues to refuse to honor this request.

9. Defendant has realized substantial profits from the minerals sold, the exact amount of royalty being unknown to the plaintiffs since the information relating thereto is in the exclusive possession and control of the defendant.

10. Plaintiff has demanded that defendant account to him for the royalty generated on the sale of the mineral estate but except for the letter of June 27, 2000, defendant has refused and

continues to refuse to provide the plaintiff with an accounting of said activity.

11. Defendant has not only refused to account to the plaintiff for such royalty but has also refused to pay to him the amount due on the account of such mining activity despite repeated requests from Plaintiffs and their agents.


12. There is due and owing to the plaintiff from the defendant an amount believed to be in excess of \$40,000.00 from the mineral estate mined on the subject tract.

13. Defendant is required to account to the plaintiff in accordance with the parties agreement for this royalty. Plaintiff is unable to state the exact amount due him as no account has ever been rendered by the defendant.

14. It is believed and therefore averred that the sums involved at the present time exceed \$40,000.00 and that the defendant has continued to escrow these funds without an accounting to the plaintiff as is required by law.

WHEREFORE, Plaintiffs request this Honorable Court to enter and order directing the defendant to account fully to plaintiff, for the activity conducted on their property. Plaintiffs further demand that judgment be entered in favor of the plaintiffs and against the defendant, Sky Haven Coal Company, Inc. for those sums shown to be due to the plaintiff by such accounting and to further pay over to the plaintiff his pro-rata share of all royalty so

generated, and such other relief as this court may reasonably require and deem appropriate.

Dear Mr. Carfley:

This letter is to inform you of the status of the Siegfried Royalties on the Emigh job. The August 1999 production royalty thru the December 1999 production royalty, which was paid to Dale Siegfried, was paid to him at the full royalty rate of \$1.75/Ton. Starting with the January 2000 production royalty, because of the controversy in the split of royalties between Dale Siegfried and Terry Siegfried, all royalties from the Siegfried property are being held by Sky Haven Coal. The following is a break down. sheets enclosed, of the royalties paid and held as of August 1999 to May 2000 production.

\$30,068.89	Total paid to Dale Siegfried
\$15,034.45	one-half of the \$30,068.89 due Terry Siegfried
\$28,111.60	Total owed on Siegfried property from January to May 2000
\$13,077.15	Total owed to Dale Siegfried after Terry Siegfried's \$15,034.45 is recouped from \$28,111.60.






