COMES NOW, Petitioner, Jessica M. Hynd, mother of Alexis Marie Townsend, by her attorneys, Mazza, Schneider, Arbuckle & Bascom, who requests this Honorable Court to Order a change of her daughter's name pursuant to 54 Pa. C.S.A. Section 701, et sec., and in support thereof, represents:

1. That Petitioner is Jessica M. Hynd, an adult individual, currently residing at R.R. 1, Box 573, Osceola Mills, Clearfield County, Pennsylvania.

2. That Petitioner previously believed that the natural father of the minor child was Jared Curlin, but upon recent testing performed by the Indiana County Domestic Relations Section, it was ruled out that Mr. Curlin was the natural father of the child. At the present time, Petitioner is unaware of the identity of the child's natural father.

3. That Alexis Marie Townsend is two (2) years old (d.o.b. 06/21/99) born out-of-wedlock to Jessica M. Hynd, natural mother.

4. That upon birth, Alexis Marie Townsend was given the surname of Timothy Townsend who was believed to be the minor child's natural father at the time of birth. Mr. Townsend, however, was ruled out as a natural father by genetic testing performed by the Centre County Domestic Relations Section.

5. That during the course of the child's life she has resided with her mother and also with Donald and Kay Townsend of Philipsburg, Pennsylvania. A custody action initiated by Petitioner in Centre County at No. 2000-2948 re-established primary physical custody of the minor child with Petitioner. The minor child has lived at the aforementioned address in Clearfield County with the Petitioner for the last three months. The Petitioner has maintained custody of the minor child since February 23, 2001.

6. That there are no judgments or decrees of like nature against Alexis Marie Townsend.


7. That Petitioner requests her daughter's name be changed from Alexis Marie Townsend to **Alexis Marie Hynd**.

8. That Petitioner requests this change of name so that the child bears the Petitioner's last name.

WHEREFORE, your Petitioner respectfully requests this Honorable Court to enter an Order changing her name from Alexis Marie Townsend to **Alexis Marie Hynd**.
