MOTION

AND NOW, comes the C. A. and Flo B. White Trust, by their Trustee, Robin C. Holman, Esquire, and sets forth as follows:

1. Robin C. Holman, Trustee of the C.A. and Flo B. White Trust, was appointed by the Court on June 21, 2000.
2. Exceptions to the Final Account of Nancy White Vencil, former Trustee, were filed by seven of the 13 beneficiaries on April 12, 2001.
3. Hearings were conducted on said exceptions and various other matters which came before the Court on August 20th, August 21st, August 22nd and August 23rd, 2001.
4. Nancy White Vencil, the former Trustee, conveyed the following parcels of real estate to herself and her sister, Brenda White Vick, and her brother, George R. White on September 1, 1994:

- a. A property situate in Toboyne Township, Perry County, Pennsylvania, as more particularly described in a deed from Nancy White Vencil, Trustee, to Nancy White Vencil, et al, and recorded in Perry County Record Book 834, Page 174.
- b. A property situate in Covington Township, Clearfield County, Pennsylvania, as more particularly described in a deed from Nancy White Vencil, Trustee, to Nancy White Vencil, et al, and recorded in Clearfield County Deed Book Volume 1631, Page 392.
- c. A property situate in Dublin Township, Fulton County, Pennsylvania, as more particularly described in a deed from Nancy White Vencil, Trustee, to

Nancy White Vencil, et al, and recorded in Fulton County Deed Book
Volume 214, Page 424.

- d. A property situate in Fayette Township, Juniata County, Pennsylvania, as more particularly described in a deed from Nancy White Vencil, Trustee, to Nancy White Vencil, et al, and recorded in Juniata County Record Book Volume 190, Page 1099.
5. The Honorable Judge Keith B. Quigley directed the Trustee, Robin C. Holman, to file a Lis Pendens against the properties hereinbefore-described to preserve them in the event said properties need to be reconveyed to the Trust and distributed in accordance with a future directive of the Court.
