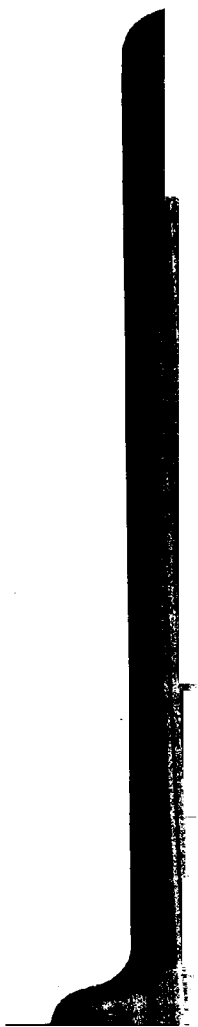

COMPLAINT IN CIVIL ACTION

AND NOW, comes Plaintiff, ROTARY DRILLING SERVICES, INC., by its attorneys, WITTLIN & IANNUCCI, P.C., and presents the within Complaint in Civil Action against the Defendant, DALE GREEN t/d/b/a GREEN ENTERPRISES, and, support thereof, avers as follows:

1. The Plaintiff, Rotary Drilling Services, Inc. (hereinafter referred to as "Rotary"), is a corporation duly organized and existing under the laws of the Commonwealth of Pennsylvania, with its principal place of business located at 312 South Centre Street, Philipsburg, Pennsylvania 16866.

2. The Defendant, Dale Green, is an individual, trading and doing business as Green Enterprises (hereafter referred to as "Green"), whose current principal place of business is located at R.D. 3, Box 80A, Franklin, Pennsylvania 16323.

3. On or about June 30, 2000, the parties hereto entered into a contract whereby the Plaintiff, Rotary, agreed to supply certain parts to the Defendant, Green, on an open account.

4. Subsequent to the delivery and acceptance of the goods provided by Plaintiff, as referenced hereinabove, Plaintiff then sent a series of invoices to the Defendant, Green. The agreed upon consideration for the purchase of the parts was \$6,000.00. A true and correct copy of the original invoice dated June 30, 2000 is hereby attached, and incorporated by reference as if set forth fully herein, as Exhibit "A".

5. Plaintiff believes, and therefore avers, that the Defendant, Green, did in fact make partial payments totaling \$2,000.00 towards the outstanding balance of \$6,000.00 as referenced hereinabove.

6. However, the Plaintiff believes, and therefore avers, that Defendant, Green, breached the express terms and conditions of the contract entered into by the parties by failing to remit the balance of \$4,000.00 due and owing to the Plaintiff.

7. By March 7, 2001, an additional invoice was sent to Defendant, Green, stating that a balance of \$4,000.00 was still due and owing to Plaintiff. A true and correct copy of the aforesaid invoice dated March 7, 2001 is hereby attached, and incorporated by reference as if set forth fully herein, as Exhibit "B".

8. Despite repeated demands for payment of the delinquent balance due and owing to the Plaintiff, the Defendant, Green, has failed, to date, to pay the \$4,000.00 owing to the Plaintiff, Rotary.

9. The Plaintiff believes, and therefore avers, that it has performed any and all necessary conditions precedent which would entitle it to receive payment in full of the balance owed under the contract entered into by the parties.

10. Plaintiff believes, and therefore avers, that it is entitled receive, in addition to the balance of \$4,000.00 due and owing, interest, cost and attorneys fees.

WHEREFORE, the Plaintiff, Rotary Drilling Services, Inc., respectfully requests this Honorable Court to enter judgment against the Defendant, Dale Green, t/d/b/a Green Enterprises, in the amount of \$4,000.00, plus interest, costs and fees incurred until the time of the entry of final judgment.
