The Plaintiff, MINERS HOSPITAL, by its attorneys, **KNUPP, KODAK & IMBLUM, P.C.**, brings this action of Assumpsit against the Defendant to recover the sum of THIRTEEN THOUSAND, ONE HUNDRED EIGHTY-NINE DOLLARS AND NINETY-FIVE CENTS (\$13,189.95), along with interest thereon from June 1, 2000, upon a cause of action of which the following is a statement:


1. The Plaintiff, MINERS HOSPITAL, is a corporation organized and existing under the laws of the Commonwealth of Pennsylvania, having its principal office and place of business at Spangler, Pennsylvania, with a mailing address of Post Office box 490, Spangler, Pennsylvania 15775-0490.
2. The Defendant, KATHRYN WICKER, is an adult individual residing at 610 Sue Street, Houtzdale, Clearfield County, Pennsylvania 16651.
3. Plaintiff did, over a period of time, provide medical and hospital services to Defendant, thereby creating a balance due in the amount of Thirteen Thousand, One Hundred Eighty-Nine Dollars and Ninety-Five Cents (\$13, 189.95). A true and correct copy of Plaintiff's Statement of Account showing said balance due and owing is attached hereto, marked as Exhibit "A" and made a part hereof.
4. The prices charged for said services provided were just and reasonable, were the legal and market prices therefor and were the prices which the Defendant orally promised and agreed to pay Plaintiff therefor.
5. The balance due and owing by Defendant to Plaintiff is the sum of Thirteen Thousand, One Hundred Eighty-Nine Dollars and Ninety-Five Cents (\$13,189.95), as appears by the Statement of Account hereto attached, made a part hereof and marked as Exhibit "A".

6. Plaintiff has frequently demanded payment from Defendant of said amount due and owing as aforesaid, but Defendant has refused and neglected and still refuses and neglects to pay said amount of any part thereof.






