Lingle; thence along lands now or formerly of Leroy Thompson and Benson H. Lingle North 11 degrees 34 minutes 40 seconds West a distance of 271.47 feet to an iron pin marking the southwest corner of lands of the aforementioned R. D. Goss; thence along lands of now or formerly of R. D. Goss North 60 degrees 01 minutes 00 seconds East a distance of 375.00 feet to an iron pin and place of beginning. **CONTAINING** 2.60 acres.
