



C O M P L A I N T

1. The Plaintiff, GENERAL HARDWARE & SUPPLY COMPANY, INC., is a corporation operating and doing business under the Laws of the Commonwealth of Pennsylvania, with its principal place of business at Philipsburg, Pennsylvania.

2. The Defendant, JOHN M. GREENAWALT, T/A GREENAWALT TRUCKING COMPANY, is an adult individual trading and doing business at Philipsburg, Pennsylvania.

3. The Plaintiff, at the special insistence and request of the Defendant, sold and delivered to the Defendant certain goods and materials at the times, in the amounts, of the kinds, and for the prices set forth in a true and correct copy of amounts taken from the Plaintiff's books of original entry hereto attached and marked Exhibit "A".

4. The total amount due was One Hundred Sixty Dollars and Eleven Cents (\$160.11), and there is still due and owing by the Defendant to the Plaintiff One Hundred Sixty Dollars and Eleven Cents (\$160.11).

5. The prices charged for said goods are just and reasonable and are the prices which the Defendant promised to pay the Plaintiff for the same.

6. The Plaintiff has demanded payment from the Defendant of the amount due, but the Defendant has refused and still refuses to pay the same, or any part thereof.

WHEREFORE, Plaintiff demands judgment against the Defendant for One Hundred Sixty Dollars and Eleven Cents (\$160.11) with interest, *from 3/31/1960*
