STIPULATION AGAINST LIENS

THIS AGREEMENT made this 7th day of November, 2001, by and between **DONALD S. BOUCH** and **DONALD E. SHORT**, partners t/d/b/a **HOME HANDI-MAN**, a partnership, of 208 North Third Street, DuBois, Clearfield County, Pennsylvania 15801, hereinafter referred to as "**CONTRACTOR**",

LINDA A. HUEY, formerly **LINDA A KEENER**, single, of R.D. #1, Box 168, Mahaffey, Clearfield County, Pennsylvania 15757, hereinafter referred to as "**OWNER**",

WHEREBY "**CONTRACTOR**" undertook and agreed to construct the porches, stairwell, and the electrical service for the modular home to be located on that certain lot of ground situate in Bell Township, Clearfield County, Pennsylvania, containing 112.78 acres, having Map No. 102-A12-000-00001, and more particularly described in a Deed dated April 27, 1978, from Calvin A. Keener and Linda A. Keener to Linda A. Keener, sole, Grantee, of record in the Office of the Recorder of Deeds of Clearfield County, Pennsylvania, in Record Book 761, at page 311. The said Linda A. Keener is presently known as Linda A. Huey.

NOW, THEREFORE, THIS AGREEMENT WITNESSETH: That the said "**CONTRACTOR**" for and in consideration of the sum of One (\$1.00) Dollar to "**CONTRACTOR**" in hand paid by "**OWNER**", the receipt whereof is hereby acknowledged, and the further consideration mentioned in the agreement aforesaid, for himself and his subcontractors, and all parties acting through or under him, covenants and agrees that no mechanic's liens or claims shall be filed or maintained by him or any of them against said buildings and the lot of ground appurtenant thereto for or on account of any work done or materials furnished by him or any of them under said contract or otherwise, for, towards, in, or about the construction pertaining to any and all buildings located on the lot above described, and said "**CONTRACTOR**", for himself, his subcontractors and others under him hereby expressly waives and relinquishes the right to have, file, and maintain and mechanic's liens or claims against the said buildings or any of them, and agree that this instrument, waiving the right of lien, shall be an independent covenant.
