4. On November 6, 2001, the Petitioners voted in the general election for the office of Clearfield Borough Councilor for the Third Ward.


5. The Petitioners allege that upon information they consider reliable, errors were committed in the computation of votes cast for the office of Clearfield Borough Councilor for the Third Ward.

6. The Petitioners further allege that a hand recount of the votes cast for the above office should be held immediately to correct errors in the prior computation.


