Dear Mr. Henning:

Please be advised that the Writ of Execution and related documentation served upon my client in the above matter has been forwarded to me for response and direction to you.

Please be advised that an involuntary proceeding under Chapter 7 of Title 11 was commenced against Reichdrill, Inc., in the United States Bankruptcy Court for the Western District of Pennsylvania at case #01-30627 BM on October 18, 2001. The case was converted to a proceeding under Chapter 11 by Order dated November 19, 2001, and is presently pending in said court.

As you are aware, the issuance of process to recover upon a pre-petition obligation during the pendency of a Chapter 11 case is precluded by 11 U.S.C. Section 362. Since the First Meeting of Creditors was only recently held, I shall assume for present purposes that your client did not advise you of its receipt of the Notice of Bankruptcy, and therefore, that the issuance of the Writ was an oversight rather than an intentional violation of stay. Please direct the Sheriff to dissolve the lien of levy on his records (the same being nullity as having been effected in violation of Section 362), and, further, confirm that no further action will be taken in violation of Section 362 in this matter. If this is not accomplished within the next seven (7) days, I have been instructed to commence an action for contempt in violation of the automatic stay against your client.
