COMPLAINT

1. Plaintiff is a corporation with offices in Kansas City, MO 64153.
2. Defendant is an adult individual residing at 508 Maple Avenue, Dubois, Clearfield County, Pennsylvania 15801.
3. Defendant applied for and received an AT &T Universal MASTERCARD credit card issued by Plaintiff bearing the account number 5491-1301-4378-0856.
4. Through the retention and use of the aforesaid MASTERCARD account , Defendant became bound by the terms and conditions of the cardholder Agreement.
5. Defendant made use of said MASTERCARD credit card and has currently a balance due and owing to Plaintiff, as of May 16, 2001, in the amount of \$9,347.74, as shown by Plaintiff's Statement of Account attached hereto, marked as Exhibit "1" and made a part hereof.
6. Defendant is in default of the terms of the cardholder Agreement having not made payment to Plaintiff as promised, thereby rendering the entire balance immediately due and payable.
7. Plaintiff avers that the written Agreement between the parties provides that Plaintiff is entitled to the addition of finance charges at the rate of 10.0% per annum on the unpaid balance.

8. Plaintiff avers that finance charges calculated at the aforesaid rate from May 16, 2001 to October 24, 2001 amount to \$414.89.

9. Although repeatedly requested to do so by Plaintiff, Defendant has willfully failed and/or refused to pay the principal balance, finance charges or any part thereof to Plaintiff.

WHEREFORE, Plaintiff demands Judgment in its favor and against Defendant, Robert F. Shaffer individually, in the amount of \$9,762.63 with continuing finance charges thereon at the rate of 10.0% per annum plus costs.
