





Plaintiff Abdollah Malekzadeh, by and through undersigned counsel, respectfully requests that the Office of the Prothonotary for the State of Delaware Superior Court, in and for New Castle County, (the "Prothonotary") enter judgment by default pursuant to Rule 55(b)(1) of the Superior Court Civil Rules against Defendants David Dorazio and Holly I. Toy, in the principal sum of \$6,924.03, together with interest accrued thereon from August 31, 2001 in the amount of \$132.22, and thereafter at the rate of 8.5% per annum [*per diem* of \$1.61], on the amount of unpaid principal until this judgment is fully satisfied, attorneys fees in an amount of \$740.00, and the costs of this action of \$280.30.

In support of this request, Plaintiff represents as follows:

1. Plaintiff filed its Complaint in this case on September 28, 2001. (See Exhibit A)

hereto).

2. Defendants are non-residents of the State of Delaware.
3. Service was made on Defendants pursuant to 10 *Del. C.* § 3104.
4. On October 26, 2001, Plaintiff mailed a copy of the Complaint and Summons to Defendants by registered mail. (*See Exhibit B* hereto).
5. Defendants have not filed an answer or otherwise responded to the Complaint.
6. The twenty (20) day period within which Defendants have to respond to the Complaint has expired pursuant to 10 *Del. C.* § 3104.
7. Defendants have therefore failed to make an appearance or otherwise responded to the Complaint in conformity with the Superior Court Civil Rules.
8. Attached to this Direction is a Statement showing the principal amount due and the computation of interest, attorneys fees and costs to the date of this Direction (Exhibit C hereto), and the affidavit of Plaintiff as required by Superior Court Civil Rule 55(b)(1) (Exhibit D hereto).

WHEREFORE, Plaintiff prays that the Prothonotary enter judgment against Defendants in accordance herewith.




